- 1. Inserting the following provisions within Part II—Planning Approval of the Scheme Text as outlined below—
 - 2.10 Delegation
 - (a) The Council may, either generally or in a particular case or cases, by resolution passed by an absolute majority of the Council, delegate to the following eligible persons the authority to deal with an application for planning approval made under this Scheme—
 - (i) a member of the Council being the Chairman of the committee required at the direction of Council to consider and report upon all applications for planning

- approval within its municipal district, and being qualified by experience with the work of any such committee; and/or
- (ii) that officer of the Council, suitably qualified and appointed to the position of Town Planner for the purpose of the Local Government Act with overall responsibility for the planning functions of the Council or appointed by the Council to supervise the development control functions of the Council.
 - (iii) or those persons who from time to time occupy the positions referred to in (i) and (ii) above.
- (b) Any delegation made under subclause 2.10(a) shall have effect for the period of twelve (12) months following the resolution unless the Council stipulates a lesser or greater period in the resolution.
 - (c) A delegation of authority pursuant to the provisions of this clause has effect and may be exercised according to its tenor, but is revocable at the will of the Council and does not preclude the Council from exercising the power.
 - (d) The performance of the function by a delegate under subclause 2.10(a) shall be deemed to be the performance of the function by the Council in all circumstances where the Council is able to delegate its powers.
 - (e) Without affecting the generality of the provisions of this clause, where in the exercise of any power under this Scheme the Council is required to form any opinion or view or have any state of mind or to consider to have due regard to any matter, then that requirement shall be satisfied if a person exercising delegated authority in respect of that power performs the function.
 - (f) A resolution to revoke or amend a delegation under this clause may be passed by an absolute majority.
 - (g) An officer or member exercising the power delegated pursuant to the provisions of this clause shall comply with the provisions of the Scheme governing the exercise of the power by the Council, insofar as such provisions are reasonably applicable.
 - (h) A persons who is or has been a delegate of the Council is not personally liable for anything done or omitted in good faith in, or in connection with, the exercise or purported exercise of any powers conferred, or the carrying out of any duty imposed on the Council by this Scheme.

By amending subclause 2.1.1 to read as follows—

2.1.1 Regional Reservations

Any land shown as "Regional Reservations" on the Scheme Maps is land reserved by the Commission pursuant to the Metropolitan Region Scheme and is shown on the Scheme Maps in order to comply with the Metropolitan Region Town Planning Scheme Act 1959. The said land is not reserved by this Scheme and compensation for injurious affection shall not be payable by the Council in respect of a Regional Reservation. GAMING COMMISSION AMENDMENT REGULATIONS 1997

Made by His Excellency the Governor in Executive Council.

Citation

1. These regulations may be cited as the *Gaming Commission Amendment Regulations 1997*.

Principal regulations

2. In these regulations the *Gaming Commission Regulations 1988** are referred to as the principal regulations.

Regulation 12 amended

3. Regulation 12 of the principal regulations is amended —

(a) by inserting after the regulation designation “12.” the subregulation designation “(1)”;

(b) by inserting the following subregulation —

“
 (2) Unless it is otherwise provided in the directions of the Commission specified in, or which relate to, the form that is annexed to the permit, a permit to which subregulation (1) applies is issued subject to the condition that the financial statement referred to in that subregulation is required to be prepared and furnished to the Commission —

(a) if the permit authorizes a permitted lottery to which subregulation (1) (c) applies —

(i) that is a standard lottery, within 14 days after the drawing of the lottery is completed; or

(ii) that is a continuing lottery, within 14 days after the date of the expiry of the permit;

or

(b) if the permit authorizes any other kind of gaming, within 7 days after the date of the expiry of the permit.

”

Regulation 16 amended

4. Regulation 16 (2) of the principal regulations is amended by deleting “28 days” and substituting the following —

“ 7 days ”.

Regulation 31 amended

5. Regulation 31 (b) of the principal regulations is amended by deleting “\$500.” and substituting the following —

“ \$1 000. ”.

Regulation 35 repealed and a regulation substituted

6. Regulation 35 of the principal regulations is repealed and the following regulation is substituted —

“

Accounts, etc.

35. With respect to a continuing lottery, all accounts, tickets, vouchers and things relating to the lottery shall at all times be kept readily accessible by the permit holder for inspection or audit as provided by the Act.

”

Schedule 4 amended

7. (1) Part 1 of Schedule 4 to the principal regulations is amended in rule 6 —

- (a) in paragraph (a) (i), by deleting “20 cents;” and substituting the following —
“ 50 cents; ”;
- (b) in paragraph (a) (ii), by deleting “10 cents;” and substituting the following —
“ 30 cents; ”; and
- (c) in paragraph (d) —
 - (i) by inserting after subparagraph (i) the following —
“ and ”;
 - (ii) by deleting the semicolon at the end of subparagraph (ii) and “and” after that subparagraph and substituting a full stop; and
 - (iii) by deleting subparagraph (iii).

(2) Part 1 of Schedule 4 to the principal regulations is amended in rule 7 —

- (a) by inserting after the rule designation “7.” the subrule designation “(1);” and
- (b) by inserting the following subrules —

“
 (2) If the prizes for a game consist of, or include, something else having a value other than money (“**prize goods**”), the aggregate value of the prize goods for the game shall not exceed \$1 000.

(3) A player who is awarded prize goods will be offered money to the value of the prize goods as an alternative prize in place of the prize goods and may choose to receive either the prize goods or the money.
 ”.

(3) Part 1 of Schedule 4 to the principal regulations is amended in rule 8 —

- (a) by inserting after the rule designation “8.” the subrule designation “(1);”
- (b) by deleting “between” and substituting the following —
“ among ”; and
- (c) by inserting the following subrule —

“
 (2) Where —
 (a) there is more than one winning card in relation to a prize that consists of, or includes, something else having a value other than money (“**prize goods**”); and
 (b) it is not possible or practicable to share the prize goods equally among all the winners,
 money to the value of the prize goods will be shared equally among all the winners in place of the prize goods.
 ”.

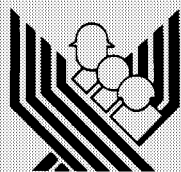
