#### FISH RESOURCES MANAGEMENT ACT 1994

PROHIBITION ON COMMERCIAL FISHING FOR ROCK LOBSTER (DAMPIER) ORDER 1997

Order No. 5 of 1997

FD 703/97 [158]

Made by the Minister under section 43.

#### Citation

1. This order may be cited as the Prohibition on Commercial Fishing For Rock Lobster (Dampier) Order 1997.

#### Interpretation

2. In this order—

"rock lobster" means the crustacean of that common name described by the scientific classification opposite that name in column 2 of Schedule 7 of the regulations;

"regulations" means the Fish Resources Management Regulations 1995.

#### Prohibition on fishing for rock lobster

3. The holder of a commercial fishing licence must not fish for rock lobster at any time in the waters of the Indian Ocean bounded by a line commencing at the high water mark at the northern most point of Cape Preston; thence north to the intersection of the 200 metre isobath; thence generally north easterly along the 200 metre isobath to the intersection of 117° 10' east longitude; thence south to the intersection of the high water mark on the mainland (Cape Lambert); thence in a generally south westerly direction along the high water mark on the mainland back to the commencement point.

#### FISH RESOURCES MANAGEMENT ACT 1994

WEST COAST PURSE SEINE MANAGEMENT PLAN AMENDMENT 1997

#### FD 255/88 [151]

Made by the Minister under section 54(2).

#### Citation

1. This amendment may be cited as the West Coast Purse Seine Management Plan Amendment 1997.

#### **Principal Plan**

2. In this amendment the West Coast Purse Seine Management Plan 1989\* is referred to as the principal Plan.

#### Clause 3 amended

3. Clause 3 of the principal Plan is amended by-

- (a) deleting the item commencing "approved form" and substituting the following-
  - " "Catch and Disposal Record Book" means a book of triplicate consignment notes in a form approved for the purpose of clause 13 by the Executive Director;";
- (b) deleting the item commencing "licence";
- (c) inserting after the item commencing "length" the following-
- "" "licence" means a managed fishery licence that authorises a person to fish in the fishery;"; (d) inserting after the item commencing "licence" the following-
- "ilicensed fishing boat number" has the meaning provided for in the Regulations;"; and (e) inserting after the item commencing "purse seine net" the following-
- ""Regulations" means the Fish Resources Management Regulations 1995;".

#### **Clause 4 amended**

4. Clause 4 of the principal Plan is amended by inserting after "Fishery" the following— ", and the fishery is a managed fishery".

#### Clause 5 amended

5. Clause 5 of the principal Plan is amended by inserting after subclause (3) the following— "(4) A person shall not fish at any time in the waters described in Schedule 2.".

#### Clause 8 deleted and substituted

6. Clause 8 of the principal Plan is deleted and the following clause substituted-

#### **"Duration of licence**

8. A licence which is in force on 1 July 1997 shall, subject to the Act, remain in force until 31 March 1998.".

#### Clause 10 deleted and substituted

7. Clause 10 of the principal Plan is deleted and the following clause substituted—

#### "Fishing may be prohibited

10. (1) The Executive Director may, by notice published in the Gazette, prohibit fishing in a Zone of the fishery for the period specified in the notice if in the opinion of the Executive Director the prohibition is required in the better interests of the fishery.

(2) A person must not fish in a Zone of the fishery at a time when fishing in the Zone has been prohibited by a notice made under subclause (1)."

#### Clause 11 deleted and substituted

8. Clause 11 of the principal Plan is deleted and the following clause substituted-

#### "Regulation of fishing

11. (1) A person must not fish in the fishery other than by means of lampara nets or purse seine nets which—

- (a) are of a length not greater than 350 metres; and
- (b) are of a mesh size of not less than 18 millimetres.

(2) A person must not fish in the fishery under the authority of a licence at any time on or before 31 March 1998 when the total amount of small pelagic fish taken under the authority of the licence after 1 July 1997 is equal to or greater than—

- (a) where the licence was first granted pursuant to clause 7, 271,000 kilograms; or
- (b) where the licence was first granted pursuant to clause 12, 37,500 kilograms in the case of licence number 1058 and 7,500 kilograms in any other case.".

#### Clause 13 deleted and substituted

9. Clause 13 of the principal Plan is deleted and the following clause substituted-

#### "Catch and Disposal Records

13. Where a boat has been used in connection with the taking and landing ashore of small pelagic fish, the master of the boat shall—

- (a) complete in triplicate, in Part A of a consignment note in a Catch and Disposal Record Book, details of any small pelagic fish landed ashore;
- (b) complete the consignment note within 30 minutes of landing ashore the small pelagic fish and shall not allow any of those fish to be removed from that place of landing unless the consignment note is completed;
- (c) cause the original copy of the completed consignment note to accompany any small pelagic fish taken under the authority of the licence from the place of landing to the place of the processor specified on that consignment note;
- (d) forward, within 24 hours of landing ashore the small pelagic fish, the duplicate copy of the completed consignment note to the Metropolitan Office of the Fisheries Department at 147 South Street, Fremantle in the State;
- (e) retain the triplicate copy of the completed consignment note in the Catch and Disposal Record Book and produce the Catch and Disposal Record Book to a Fisheries Officer on demand;
- (f) retain all three copies of any cancelled, spoiled or unused consignment notes in the Catch and Disposal Record Book; and
- (g) not deliver or allow to be delivered any small pelagic fish for the purpose of sale to any processor or place other than the processor and place specified on a completed consignment note.".

#### **Clauses 15 deleted and substituted**

10. Clause 15 of the principal Plan is deleted and the following clause substituted—

"Procedure before this Plan is amended or revoked

15. For the purposes of section 65(1) of the Act the Purse Seine Fishery Management Advisory Committee is the advisory committee that is to be consulted before this Plan is amended or revoked.".

#### Clause 16 deleted and substituted

11. Clause 16 of the principal Plan is deleted and the following clause substituted—

#### "Rolling of fish

16. A person must not use a purse seine net from a licensed fishing boat to fish for an amount of small pelagic fish that is greater than the amount of small pelagic fish that can be—

- (a) brought aboard the boat; and
- (b) landed ashore and consigned to a person who has authority to process the fish.".

#### **Clause 17 inserted**

12. The principal Plan is amended by inserting after clause 16 the following-

#### "Offences and major provisions

17. A person who contravenes a provision of ---

- (a) clause 13 or 16; or
- (b) clause 5, 6, 10 or 11,

commits an offence and for the purposes of section 75 of the Act the provisions specified in paragraph (a) are major provisions.".

#### Schedule 2 deleted and substituted

13. The principal Plan is amended by deleting Schedule 2 and substituting the following-

"Schedule 2 (Clause 5)

All WA waters within the boundaries of the Marmion Marine Park Reserve No. 1 bordered red on the Department of Land Administration Miscellaneous Plan numbered 1597;

All WA Waters within 1000 metres of the high water mark between  $31^{\circ}$  south latitude (near Lancelin) and  $31^{\circ}$  54' south latitude (near Observation City);

All WA waters within 1000 metres of the high water mark between  $32^{\circ}$  16' south latitude (near Cape Peron) and  $33^{\circ}$  south latitude; and

All waters of Warnbro Sound, the Indian Ocean and Shoalwater Bay bounded by a line commencing at a point on the high water mark at Becher Point and extending seawards to a point 2,400 metres west; thence northerly to a point 1,600 metres from the high water mark of the southern most point of Penguin Island; thence generally north westerly and northerly to a point 1,600 metres due west from the high water mark of the western most point of Penguin Island; thence due north to a point of intersection with a line drawn due west from the northern most point of Point Peron; thence easterly along that line to the high water mark at Point Peron and then easterly along that line to the high water mark at Point Peron and then along the high water mark to the commencing point.".

#### Schedule 3 deleted

14. The principal Plan is amended by deleting Schedule 3.

#### REAL ESTATE AND BUSINESS AGENTS (GENERAL) AMENDMENT REGULATIONS 1997

Made by the Governor in Executive Council.

#### Citation

1. These regulations may be cited as the Real Estate and Business Agents (General) Amendment Regulations 1997.

#### Commencement

2. These regulations come into operation on 1 July 1997.

#### Schedule 2 amended

**3.** Schedule 2 to the Real Estate and Business Agents (General) Regulations 1979\* is amended by deleting Form 1 and substituting the following form —

"

Form 1

#### Western Australia

#### TOBACCO CONTROL ACT 1990

TOBACCO CONTROL (EXEMPTION) NOTICE 1997

Made by the Minister for Health under section 14 after consultation with the Minister for Sport and Recreation.

#### Citation

1. This notice may be cited as the Tobacco Control (Exemption) Notice 1997.

#### Interpretation

2. In this notice—

"associated statement" means the statement "Government Health Warning";

"health warning" means the health warning referred to in clause 4 (b).

#### Exemption

3. (1) Subject to the conditions set out in clause 4, competitors, and persons officially supporting or directly assisting competitors, in the motor racing event to be held between 19 October 1997 and 7 November 1997 in Western Australia and known as the 1997 Rally Australia event ("**the Event**") are exempted from the operation of sections 5 and 8 of the *Tobacco Control Act 1990* in respect of the Event.

#### Conditions

4. The conditions subject to which the exemption referred to in clause 3 is granted are that—

- (a) any tobacco advertisement is displayed only-
  - (i) on the uniforms of the competitors, and of the persons officially supporting or directly assisting the competitors, in the Event;
  - (ii) on the sides, front and back of the motor vehicles participating in the Event;

- (iii) on the official vehicles used exclusively for the transport of the competitors and other persons referred to in subparagraph (i); and
- (iv) when incidentally or accidentally present in photographs used to publicize the Event;
- (b) when displayed, any tobacco advertisement is accompanied by the health warning "SMOK-ING KILLS" and the associated statement.
- (c) except in the circumstances referred to in paragraph (d), the area exclusively devoted to the display of the health warning and associated statement is not less than 30% of the total area of the tobacco advertisement that the health warning accompanies;
- (d) the health warning that accompanies a tobacco advertisement displayed on a uniform referred to in paragraph (a) (i) appears in capitals not less than 8 millimetres in height and the associated statement appears in letters not greater than 4 millimetres in height;
- (e) the health warning—
  - (i) appears, in the case of a tobacco advertisement displayed in accordance with paragraph (a) (i), (ii) or (iii), immediately before, after, above or below the first word, number or symbol of the tobacco advertisement, and adjacent to the associated statement;
  - (ii) appears in white Helvetica Bold capitals on a black background; and
  - (iii) except in the circumstances referred to in paragraph (d), occupies, together with the associated statement, not less than 80% of the area devoted to the display of the health warning and associated statement; and
- (f) the letters of the associated statement—
  - (i) appear in Helvetica Medium capitals and Helvetica Medium lower case type; and
  - (ii) are not greater than half the height of the letters used in the health warning that appears adjacent to the associated statement.

#### BUSH FIRE NOTICE AND REQUIREMENTS

#### Notice to All Owners and/or Occupiers of Land in the Shire of Bridgetown-Greenbushes

In accordance with section 33 of the Bush Fires Act 1954, you are required to carry out fire prevention work on land owned or occupied by you in accordance with the provisions of this Order.

The penalty for non-compliance with this notice is a maximum fine of \$1 000 and notwithstanding prosecution, Council may enter upon the land and carry out required works at the owner/occupier's expense.

If it is considered for any reason to be impractical or environmentally unsound to carry out the provisions of this Order, application must be made before the 1st day of November for permission to provide alternative firebreaks or other fire abatement measures. In the absence of written permission for alternative measures the requirements of this Order must be adhered to.

Guidelines for alternative breaks are contained in paragraph 7 of this Order.

An inspection of firebreaks and hazard removal will be carried out in all areas of the Shire by an authorised Officer.

#### FIREBREAK REQUIREMENTS

Period—Fire prevention work must be carried out by 30th November and kept maintained throughout the summer months until the 14th March.

1. Landowners/Occupiers Responsibility

The Council forwards a copy of this Firebreak Order with rate assessments each year. The Order is published in the *Government Gazette*, Manjimup-Bridgetown Times and additional copies are available at the Shire Offices and Library.

It is the responsibility of the landowner/occupier to understand and comply with the requirements of this Order.

If further clarification is required contact your Fire Control Officer or Shire Offices.

2. Managed Farmland

(a) Farmland—A 2.5 metre firebreak shall be constructed in such positions as agreed at a properly constituted meeting of a Bush Fire Brigade and incorporated in the Brigade Strategic Firebreak Plan, a copy of which is lodged at the Council Offices and the Brigade Fire Control Officer.

If agreement between landowner/occupier and Brigade for Strategic Firebreak requirements is not achieved, Council may make a specific Order as to firebreaks required.

- (b) Crops to be Harvested—A firebreak not less than 2.5 metres wide shall be provided around the perimeter of land on which a crop is planted.
- (c) Buildings and Haystacks—A firebreak not less than 4 metres in width shall be provided immediately or as near as practicable surrounding all buildings and haystacks.

3. Managed Land—over 2 000 m<sup>2</sup> not included in the Strategic Firebreak Plan for Farmland

This land will not require firebreaks except around buildings, haystacks and crops if at the time of inspection it is clearly evident that measures are in place which will prevent the existence of a high level of fuel accumulation over the period specified in this Firebreak Order.

4. Unmanaged Land over 2 000 m<sup>2</sup>

A firebreak not less than 4 metres in width inside and along the boundary of cleared or part cleared land on each lot or location. A firebreak not less than 4 metres in width shall be provided immediately or as near as practicable surrounding all buildings and haystacks.

5. Residential, Commercial and Industrial Land under 2 000 m<sup>2</sup>

Fire Prevention work must be carried out by 30th October and maintained through the summer months until 14th March.

Remove all flammable materials likely to create a fire hazard except standing live green trees and shrubbery and maintain throughout the required period.

- 6. Plantations
  - (a) All Plantations planted after 1st May 1990
    - 1. The first row of trees must be a minimum of 15 metres from the outer edge of the firebreak adjoining all formed public roads.
    - 2. A 10 metre firebreak to be constructed on the boundaries of the plantation in separate ownership, and all formed public roads.
    - 3. A firebreak 6 metres wide shall be provided in such position that no compartment of a plantation should exceed 30 hectares.
    - 4. No planting will be allowed within a distance of 20 metres on either side of all power lines, and a 6 metre firebreak shall be provided as near as practical underneath the power lines.
    - 5. All firebreaks must be maintained in a condition trafficable to tractors and four wheel drive vehicles, and adjoining trees progressively pruned to a minimum height of 4 metres to allow unrestricted access and to maintain an effective width of firebreak.
  - (b) Pine Plantations planted prior to 1st May 1990
    - 1. All of the provisions of items 6(a), 2-5 inclusive apply.
  - (c) Eucalypt Plantations planted prior to 1st May 1990
    - 1. A 5 metre firebreak to be constructed on the boundaries of the plantation, including the boundaries of each separate location and all formed public roads.
    - 2. All of the provisions of items 6(a), 4-5 inclusive apply.

Alternatives: In the interest of environmental protection, alternatives to the above conditions may be allowed by specific written agreement with Council in accordance with the Guidelines for Alternative Breaks in this Order. Application must be made when submitting the development plan of the plantation for Planning Approval before planting commences.

- 7. Definitions—For the purpose of this Order the following definitions apply:
  - "Firebreak" means ground from which all inflammable material has been removed and on which no flammable material is permitted to accumulate during the period earlier referred to.
  - "Haystack" means a collection of hay including fodder rolls placed or stacked together.
  - "Managed Farmland" means land used for primary production located in an area covered by the Strategic Firebreak Plan.
  - "Unmanaged Land" land will be classified as unmanaged if at the time of inspection it is not clearly evident that measures are in place which will prevent the existence of a high level of fuel accumulation during its period of notice.
  - "Plantation" means an area of planted pine, eucalypt or other commercial value trees exceeding 5 hectares but not including windbreaks or groups of shelter belts or woodlots.
  - "Residential, Commercial and Industrial Land" means all land used for those purposes and includes any ungrazed lot under 2 000 m<sup>2</sup>.
  - "Shelter Belt" or "Woodlot" means an area of planted trees not exceeding 5 hectares, but which may be part of a group of similar plantings separated by grazed pasture of not less than 10 metres in width.
  - "Windbreak" means an area of planted trees not exceeding 15 metres in depth with an unrestricted length.
- 8. Guidelines for Alternative Breaks
  - (a) An alternative break shall be cleared as near as practicable to the position required by this Notice, and such position shall be approved by either the Bush Fire Control Officer or Captain of the Bush Fire Brigade in the area concerned and forwarded in writing by the 1st November by the owner or occupier to the Shire Council for confirmation, enclosing a map of the alternative positions endorsed.

- (b) The Strategic Firebreak scheme submitted by a Bush Fire Brigade must be agreed to at a properly constituted Brigade meeting. Alterations to the Brigade plan will need to be submitted to Council by 1st November each year and application for alteration shall be endorsed by the Brigade Captain or Fire Control Officer.
- (c) Any alternative submitted has no effect until approved by the Council after which notification in writing will be given.
- (d) All alternative breaks approved may be reviewed by the Council at any time after the expiry of one year.
- (e) Cultivation of roadsides will be allowed on road reserves only with the written permission of the Council, and for the purpose of protection of fencing only, and not as an alternative to a firebreak.
- (f) Where an application supported in writing by the Land Conservation District Committee there is a recognisable potential or existing erosion problem on a property subject to firebreak provisions, the Council may, in writing, approve in lieu of the absence of inflammable material, an alternative strip of mown grass maintained not exceeding 30mm in height for the duration of the requirements of this Notice.

9. Special Orders

The requirements of this Order are considered to be the minimum standard of fire prevention work to protect not only individual properties but the district generally. In addition to the requirements of this Order, Council may issue Special Orders on owners or occupiers if hazard removal is considered necessary in some specific areas.

VOCATIONAL EDUCATION AND TRAINING (TAFE INTERNATIONAL WA) ORDER 1997 Made by the Minister for Employment and Training under section 57 of the *Vocational Education and Training Act 1996.* 

#### Citation

1. This order may be cited as the Vocational Education and Training (TAFE International WA) Order 1997.

#### Commencement

2. This order takes effect on and from the day that this order is published in the Government Gazette.

#### Interpretation

3. In this order unless the contrary intention appears—

"chief executive" means the chief executive of the department;

"department" means the department principally assisting the Minister in the administration of the Act;

"overseas student" means student who is not—

- (a) a Australian citizen;
- (b) a New Zealand citizen;
- (c) a permanent resident in Australia; or
- (d) a dependent of a person referred to in paragraph (a), (b) or (c),

and in relation to whom a full fee is payable for vocational education and training or related services;

"the Act" means the Vocational Education and Training Act 1996; and

"the Institution" means TAFE International WA established under clause 4.

#### Establishment and corporate name

4. (1) An institution known as TAFE International WA is established under section 57 of the Act.

(2) The Institution is a body corporate with-

- (a) perpetual succession and a common seal; and
- (b) power to take and defend proceedings in its corporate name.

#### **Functions of Institution**

5. The functions of the Institution are-

- (a) to make arrangements for and facilitate the provision of vocational education and training and related services either directly or through any agency to overseas students in or outside the State and to persons or organisations outside the State in conjunction with a college or otherwise;
- (b) to participate in initiatives involving the whole of the State training system and to collaborate with colleges and educational institutions to ensure the greatest effectiveness and economy in expenditure and the most beneficial relationship between the Institution and colleges and educational institutions throughout the State;
- (c) to co-ordinate or arrange for the provision of vocational education and training by the use of any technology that may be available for that purpose;
- (d) to enter into arrangements for the development of curriculum and related materials and services for the purposes of vocational education and training under the Act; and
- (e) to publish or arrange for the publication of works for or on behalf of the State training system.

#### Management and control

6. The management and control of the Institution are vested in the chief executive but subject to the exercise of the Minister's powers under section 14 of the Act.

#### Powers of chief executive

7.(1) The chief executive may do all things necessary or convenient to be done for or in connection with the performance of the functions of the Institution.

(2) without limiting subsection (1) the chief executive may, on behalf of the Institution-

- (a) make arrangements for the provision of housing for staff, and residential accommodation for students;
- (b) make arrangements for the conferring of awards and qualifications; and
- (c) provide, for a fee or otherwise, or enter into contracts to provide, products, consultancy or other services in the course of, or incidental to, the provision by the Institution of vocational education and training and related services.

(3) The chief executive may exercise the powers of the chief executive outside the State if that is necessary or convenient for the performance of the functions of the Institution.

#### Advisory committee

8. The Chief Executive may appoint a committee for the purposes of advising the Chief Executive in carrying out the functions of the Institution.

#### Staff

9. For the purposes of assisting the Institution in carrying out its functions-

- (a) there may be appointed under and subject to the *Public Sector Management Act 1994* such public service officers and other employees as are necessary; and
- (b) despite paragraph (a), the Chief Executive may employ or engage persons otherwise than under the *Public Sector Management Act 1994*.

#### Application of Financial Administration and Audit Act 1985

10. For the purposes of the Financial Administration and Audit Act 1985 the Institution is to be regarded as a service of the department.
