POISONS (AUTHORIZED POSSESSION OF SUBSTANCES)
ORDER 1997

Made by the Governor in Executive Council under section 41 of the Act.

Citation

1. This order may be cited as the *Poisons (Authorized Possession of Substances) Order 1997*.

Commencement

2. This order comes into operation on the day on which it is published in the *Gazette*.

Interpretation

3. In this order —

“**Ag WA officers**” means the people listed in Schedule 1 to the *Poisons (Authorization to Possess Cannabis) Order 1996*;

“**Mrs Dove**” means Gladys Marian Dove of 37 Denny Way, Alfred Cove;

“**studio**” means the studio situated at 37 Denny Way, Alfred Cove and used by Mrs Dove for paper making.

Possession of certain substance authorized

4. (1) Subject to clause 5 Mrs Dove is authorized to possess, for the purpose of researching the fibrous properties of hemp for use in paper making, not more than 20 kg of the leaves and stems of the cannabis plants grown as part of the experimentation and research referred to in the *Poisons (Authorization to Possess Cannabis) Order 1996*.

(2) The Ag WA officers are authorized to deliver to Mrs Dove not more than 20 kg of the leaves and stems of the cannabis plants which the Ag WA officers are authorized to possess under the *Poisons (Authorization to Possess Cannabis) Order 1996*.

(3) The authorizations in subclauses (1) and (2) applies in respect of —

- (a) the studio;
- (b) the offices of Agriculture WA at 3 Baron-Hay Court, South Perth;
and
- (c) the direct route between those places.

Conditions of authorized possession

5. The possession authorized under clause 4 (1) is subject to the conditions that —

- (a) the cannabis is obtained from an Ag WA officer;
- (b) on the day on which this order expires Mrs Dove is to return any unused leaves or stems to an Ag WA officer;
- (c) when the cannabis is not being used for the purposes referred to in clause 4 (1), Mrs Dove is to keep it at the studio in a secure manner as directed by the Commissioner of Health; and
- (d) Mrs Dove provide to the Commissioner of Health any information relating to the cannabis which is requested by the Commissioner.

Expiry

6. This order expires 12 months after it comes into operation.

Citation

1. This order may be cited as the *Poisons (Authorized Possession of Substances) Order (No.2) 1997*.

Commencement

2. This order comes into operation on the day on which it is published in the *Gazette*.

Interpretation

3. In this order —

“Ag WA officers” means the people listed in Schedule 1 to the *Poisons (Authorization to Possess Cannabis) Order 1996*;

“Mrs Chivers” means Dawn Janette Chivers of 8 Fourth Avenue, Burns;

“premises” means the premises at 8 Fourth Avenue, Burns and used by Mrs Chivers for spinning yarn for weaving into fabric.

Possession of certain substance authorized

4. (1) Subject to clause 5 Mrs Chivers is authorized to possess, for the purpose of researching the fibrous properties of hemp for use for spinning yarn for weaving into fabric, not more than 20 kg of the leaves and stems of the cannabis plants grown as part of the experimentation and research referred to in the *Poisons (Authorization to Possess Cannabis) Order 1996*.

(2) The Ag WA officers are authorized to deliver to Mrs Chivers not more than 20 kg of the leaves and stems of the cannabis plants which the Ag WA officers are authorized to possess under the *Poisons (Authorization to Possess Cannabis) Order 1996*.

(3) The authorizations in subclauses (1) and (2) applies in respect of –

- (a) the premises;
- (b) the offices of Agriculture WA at 3 Baron-Hay Court, South Perth; and
- (c) the direct route between those places.

Conditions of authorized possession

5. The possession authorized under clause 4 (1) is subject to the conditions that –

- (a) the cannabis is obtained from an Ag WA officer;
- (b) on the day on which the order expires Mrs Chivers is to return any unused leaves or stems to an Ag WA officer;
- (c) when the cannabis is not being used for the purposes referred to in clause 4 (1), Mrs Chivers is to keep it at the premises in a secure manner as directed by the Commissioner of Health; and
- (d) Mrs Chivers provide to the Commissioner of Health any information relating to the cannabis which is requested by the Commissioner.

Expiry

6. This order expires 12 months after it comes into operation.

Schedule of Rates and Charges

General Rates—

- (a) 2.2813 cents in the dollar on Unimproved Values.
- (b) 11.0389 cents in the dollar on Gross Rental Values.

Minimum Rates—

\$225 per lot on all land within the Shire of Quairading.

Discount—

A discount of 10% on all current rates issued and received in full at the Shire Office up to 4.30 p.m. on the 10th October 1997.

A discount of 10% on all interim rates issued and received in full at the Shire Office by the 35th day after the date of service of the rate notice.

Options for payment of Rates—

Option 1—Prompt Payment. Due no later than 4.30 p.m. 10th October 1997.

Option 2—Four Equal instalments—

1. First instalment due no later than 4.30 p.m. 10th October 1997.
2. Second instalment due no later than 4.30 p.m. 12th December 1997.
3. Third instalment due no later than 4.30 p.m. 13th February 1998.
4. Fourth instalment due no later than 4.30 p.m. 17th April 1998.

Note: No discount applicable on payment option 2. Instalment options are not applicable if arrears and any interest that has accrued up to the date of issue of the notice are not paid by the due date.

Administration Charge—

A charge of \$2.00 per reminder notice will apply on option 2.

Instalment Plan Interest Rate—

A charge of 6.5% per annum, calculated daily by simple interest from 11th October 1997.

Late Payment Interest Charge—

A charge of 10% per annum, calculation daily by simple interest as from 5th December 1997.

Rubbish Charge—

\$106 per annum for weekly removal of one 240 litre Mobile Garbage Bin.

\$53 per annum Refuse Site Maintenance Charge for Commercial properties not serviced with a Mobile Garbage Bin.
