HOSPITALS AND HEALTH SERVICES ACT 1927

**HOSPITALS AND HEALTH SERVICES (WESTERN HEALTH SERVICE)
BY-LAWS 1998**

Made by the Western Health Service under section 22 of the Act.

Citation

1. These by-laws may be cited as the *Hospitals and Health Services (Western Health Service) By-laws 1998*.

Interpretation

2. In these by-laws —

“**Board**” means the hospital board assigned the corporate name “Western Health Service” under clause 4 of the *Hospitals and Health Services (Re-organization of Hospital Boards) Notice (No. 2) 1997*.

Local management committees to be established

3. The Board is to establish a local management committee for each public hospital under the control of the Board.

Constitution of local management committees

4. (1) A local management committee is to consist of not less than 3 persons or more than 9 persons appointed under sub-by-law (2).

(2) At least —

(a) 2 persons are to be appointed by the Board from its members; and

(b) one person is to be appointed by the Board from persons nominated to the Board in accordance with procedures determined by the Board and approved by the Minister.

Chairperson

5. The members of a local management committee are to elect one of them who was appointed under by-law 4 (2) (a) to be the chairperson of the committee.

Constitutional provisions

6. (1) Subject to sub-by-law (2), Schedule 1 to the Act has effect in relation to the constitutional provisions that apply to a local management committee.

(2) For the purposes of sub-by-law (1) —

- (a) a reference in Schedule 1 to the Act —
 - (i) to the Governor or the Minister is to be taken to be a reference to the Board; or
 - (ii) to the Chairman is to be taken to be a reference to the chairperson;
- (b) clauses 3 and 12 of that Schedule do not apply; and
- (c) the reference in clause 14 of that Schedule to “this Act” is to be taken to be a reference to “any directions given by the Board”.

Functions of local management committees

7. The functions of a local management committee established for a public hospital are —

- (a) to supervise, and provide advice and recommendations to the Board in relation to, the management of the public hospital;
- (b) in association with the Board, to select the person to be employed by the public hospital as its senior employee;
- (c) to manage, and provide advice and recommendations to the Board in relation to the management of, the funds available to the Board for distribution to the public hospital;
- (d) to participate in business and strategic planning processes in relation to the public hospital;
- (e) to supervise, and provide advice and recommendations to the Board in relation to, contracts or arrangements entered into for the purposes of services provided by the public hospital; and
- (f) to perform any other functions as directed by the Board.

Board may give directions to local management committees

8. The Board may give directions to a local management committee in relation to the performance of the committee's functions, and the committee is to comply with any direction so given.

FIREBREAK NOTICE

Notice to all Owners and/or Occupiers of land in the Shire of Broome.

Pursuant to the powers contained in Section 33 of the above Act, you are hereby required on or before 15 May 1998 and thereafter up to and including 31 December 1998 to have firebreaks clear of all inflammable material in accordance with the following—

NOTICE OF PROPOSAL TO CONSTRUCT GROUNDWATER BORE MAINS

To augment Perth's Water Supply System, the Water Corporation proposes to construct the following works—

- Various below ground collector pipelines with associated fittings, valves and manholes—
 - 300mm nominal diameter, approximately 520 metres long,
 - 500mm nominal diameter, approximately 2970 metres long,
 - 600mm nominal diameter, approximately 1570 metres long;
 - 700mm nominal diameter, approximately 3100 metres long; and
- Pipeline connecting groundwater production bores to the collector pipelines with associated valves, pipework and pumps.

The location of the proposed works is as shown on the plan. The collector pipelines will traverse the following land other than road reserves—

Reserve 27575 of Swan Loc 3323
(via a pipe easement and pipe corridor),
Lots 17, 2 and 137 Connolly Dr,
Land allocated for future Mitchell Freeway,
Lot 472 Christchurch Tce and abutting Lot 629,
Lot 96 Shenton Ave, and
Lot 748 Hodges Dr.

QX10—Reserve 43413 Swan Loc 11971,
WT10 & WT15—Lots 629 and 472,

WT40 & WT45—Lot 303.

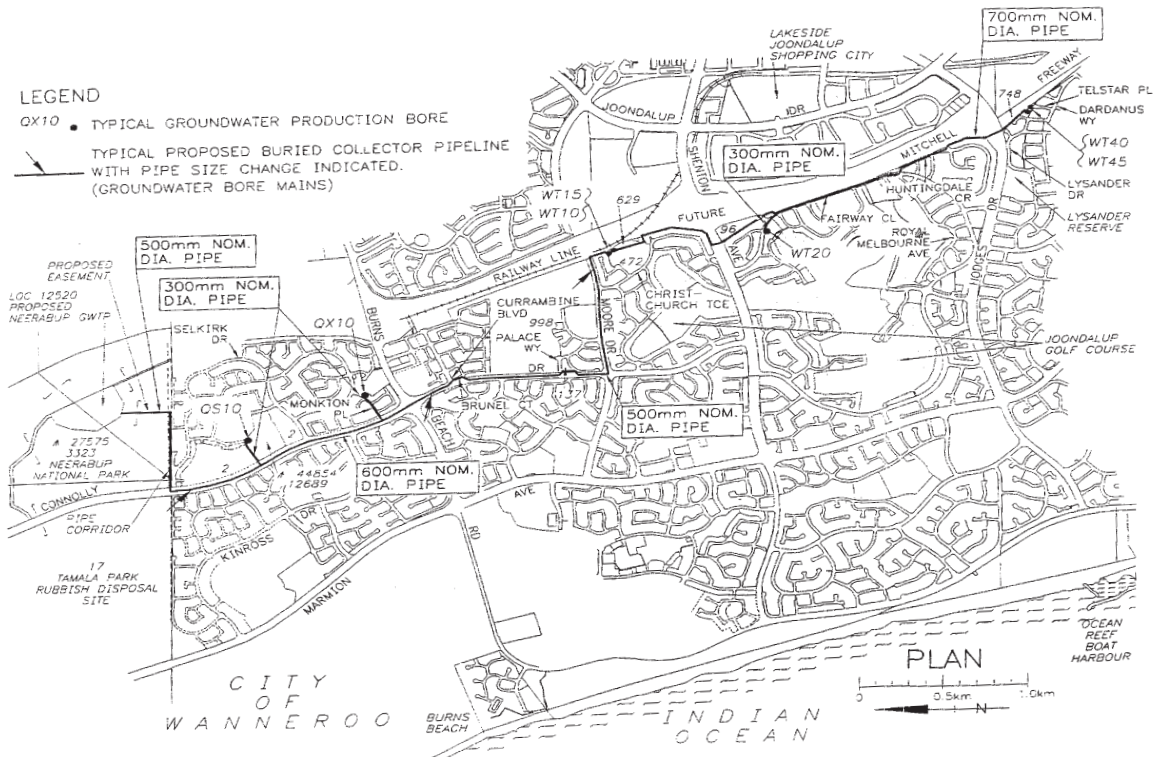
The proposed works are scheduled to commence in December, 1998 and shall continue for a duration of approximately 12 months.

Construction of the proposed works will require some clearing of vegetation and open trench excavation which will be backfilled and restored.
