- (g) Relating to the continuance of the lawful use of land and buildings.
- (h) Relating to appeals against refusal of approval for development or against conditions subject to which approval to carry out development is granted.

## **Gaming Commission Amendment Regulations 1998**

Made by the Governor in Executive Council.

**1. Citation**

These regulations may be cited as the *Gaming Commission Amendment Regulations 1998*.

**2. Commencement**

### **SWAN RIVER TRUST ACT 1988**

#### NOTICE OF DELEGATION

Notice is hereby given that the Swan River Trust at its meeting held on 16 June 1998, and acting pursuant to the provisions of Section 26 of the Swan River Trust Act has resolved to delegate its powers and functions with respect to the Swan River Trust Act as set out in this notice.

**Notice of Delegation**

The Trust has resolved, subject to the conditions set out below, to delegate to the officer of the Water and Rivers Commission for the time being appointed as manager of the Swan River Trust (the Manager) the power to make decisions in relation to the following of its functions—

- (i) Make recommendations to the Western Australian Planning Commission and local government concerning the determination of applications made under CL30A(1)b of the Metropolitan Region Scheme provided that—
  - the development complies with Trust policies and adopted draft policies;
  - the recommendation is for approval;
  - there is no filling of the floodway required;
  - the development is not proposed within a System Six area;
  - the proposal is not part of a development of land subject to Part V of the Swan River Trust Act or a CL30A(1)a MRS application;
  - the proposal is not considered by the Manager to be of a controversial nature or significant public interest and the Trust has not requested that the matter be brought before it.
- (ii) Give advice and assistance to planning authorities in relation to planning scheme amendments provided that—
  - the statement of planning policy and scheme provisions are not in conflict with Trust policy or the Swan River Management Strategy.
- (iii) Give advice to the Western Australian Planning Commission in relation to subdivision applications provided that—
  - proper provision is made for the reservation of land along the river foreshore;
  - the proposed subdivision is in accordance with Trust policies and the Swan River Management Strategy.
- (iv) Issue clearance of diagrams of survey, subdivision conditions, and minor amendments to approved subdivisions on behalf of the Western Australian Planning Commission provided that—
  - the subdivision/amalgamation accords with conditions advised by the Trust.
- (v) Power to direct cessation or removal of development contrary to SRT Act Section 68(1) provided that—
  - the Swan River Trust Manager is satisfied that the direction will not leave the Trust open to a claim for damages.
- (vi) Power to remove abandoned property under Section 69 of the SRT Act provided that—
  - the power is exercised in accordance with the procedures set out under Section 69 of the SRT Act.
- (vii) Power to approve spectator events as set out in the SRT Regulations 1989 provided that—
  - appropriate conditions are imposed indemnifying the Trust against claims for liability and ensuring after event cleanup of the site by the event organisers.
- (viii) Clearance of conditions set by the Trust in relation to SRT Act Part V approvals provided that—
  - the development complies in all respects with the approval and conditions issued by the Minister for Water Resources.
- (ix) Authorisation to deal with day to day correspondence, advice and information concerning the functions and roles of the Trust provided that—
  - the Manager is satisfied that the matter to be dealt with is of a minor or non-statutory nature.

**Interpretations**

For the purposes of this notice, terms used shall have the same meanings as those assigned to them in the Swan River Trust Act 1988.

**TR401\*****NAVIGABLE WATERS REGULATIONS****WATER SKI AREA****GERALDTON INNER HARBOUR**

Department of Transport,  
Fremantle WA, 4 August 1998.

Acting pursuant to the powers conferred by Regulation 48A of the Navigable Waters Regulations, the Department of Transport by this notice defines and sets aside the following area of navigable water for the purpose of water skiing between the hours of sunrise and sunset—

**GERALDTON INNER HARBOUR**

All of the harbour waters west of a line drawn from the eastern end of No.1 berth north to the eastern end of the west breakwater spur. So however that no boat or skier shall approach within 60 metres of the breakwater, wharf or ships berthed thereon. Skiing is prohibited when any commercial vessel is manoeuvring within the area south of a line drawn between the east and west breakwater light beacons. A signal of three prolonged blasts on the ship's whistle or siren will be sounded by a vessel entering prior to crossing this line and by a vessel departing prior to casting off from a berth. With the absence of beach take off areas skiers are advised that take off and landings must be confined to deep water.
