Agriculture Protection Board,

Acting pursuant to the powers granted by Section 35 and 36 of the Agriculture and Related Resources Protection Act 1976, the Agriculture Protection Board hereby:

(a) declares those plants listed below to be declared plants and assigns them to the categories specified, in those regions shown.

- Apple of Sodom (*Solanum linnaeanum*), P1;P4, Those portions of the State constituted as the Busselton, Manjimup, Albany and Harvey regions under Section 13 of the Act.
- Arum lily (*Zantedeschia aethiopica*), P1;P4, Those portions of the State constituted as the Busselton, Manjimup, Albany and Harvey regions under Section 13 of the Act.
- Blackberry (*Rubus fruticosus agg.*), P1;P2, The Municipal district of Boddington.  
P1;P4, Those portions of the State constituted as the Busselton, Manjimup, Albany and Harvey regions under Section 13 of the Act.
- Cape tulip (*Homeria flaccida*)(one leaf),(*Homeria miniata*) (two leaf),  
P1, Whole of the State.  
P3, That portion of the State constituted as the Esperance region under Section 13 of the Act.

On all land where fuel drum ramps are located and where fuel dumps, whether containing fuel or not are stored, clear and maintain a firebreak at least four metres wide around any drum, ramp or stack of drums.

**5. GENERAL PROVISIONS**

If for any reason it is considered by the owner or occupier of land, that it is impractical to comply with the requirements of this notice a request may be made to the Council not later than 17th October 1998. Where approval of a proposed variation is not granted by Council you shall comply with the requirements of this notice.

The penalty for non-compliance with this notice is a maximum of \$1 000 and notwithstanding prosecution, Council may direct its Bush Fire Control Officer to enter on the land and carry out the requisite works at the owner/occupiers expense. Council will assist owners/occupiers of townsites by carrying out a bulk rubbish collection where rubbish is placed on the verge on or before the 1st November 1998.
