## **Casino Control (Burswood Island) (Licensing of Employees) Amendment Regulations 1999**

Made by the Governor in Executive Council.

### **1. Citation**

These regulations may be cited as the *Casino Control (Burswood Island) (Licensing of Employees) Amendment Regulations 1999*.

### **2. The regulations amended**

The amendments in these regulations are to the *Casino Control (Burswood Island) (Licensing of Employees) Regulations 1985\**.

### **3. Regulation 2 amended**

Regulation 2(1) is amended in the definition of “current holder” by inserting after “granted” —

“ or renewed ”.

**4. Regulation 6 amended**

After regulation 6(1) the following subregulation is inserted —

“

- (1a) The fee payable in respect of an application —
- (a) for the renewal of a casino key employee licence, is \$75; and
  - (b) for the renewal of a casino employee licence, is \$75.

”.

**5. Regulation 7 amended**

After regulation 7(2) the following subregulation is inserted —

“

- (3) Upon receipt of an application for the renewal of a casino key employee licence or a casino employee licence, and compliance by the applicant with any requirement made under these regulations together with any further or other information or matter required from the applicant, the Chief Casino Officer shall —
- (a) consider the application and any information or other matters relevant to or accompanying it and make an assessment of the suitability of the applicant to be employed or work in the Casino; and
  - (b) recommend to the Commission that the application be granted, or be granted only in respect of a specified type or specified types of work or subject to specified terms, conditions or restrictions, or that it be refused.

”.

**6. Regulation 8 amended**

- (1) Regulation 8(1)(a) is amended by inserting after “application for” —

“ or for the renewal of ”.

- (2) Regulation 8(2) is amended by inserting after “licence” where first occurring —

“ or renewal of a licence ”.

**7. Regulation 9 amended**

Regulation 9(1) is amended by inserting after “application for” —

“ or renewal of ”.

**8. Regulation 14 amended**

Regulation 14(1) is amended as follows:

- (a) after paragraph (c) by deleting “or”;

- (b) after paragraph (d) by deleting the full stop and inserting a semicolon;
- (c) after paragraph (d) the following paragraphs are inserted —

“

- (e) in the case of a licence issued before 1 January 1996, 1 January 2001; or
- (f) in the case of a licence issued on or after 1 January 1996, 5 years from the day specified in the licence as the day on which the licence was issued.

”.

**9. Regulation 14A inserted**

After regulation 14 the following regulation is inserted —

“

**14A. Renewal of licence**

- (1) A person who wishes to renew a casino key employee licence or a casino employee licence shall apply for the renewal before the expiration of the licence.
- (2) A licence that is renewed has effect for 5 years from the expiration of the previous licence.
- (3) A person who wishes to renew a casino key employee licence or a casino employee licence shall forward to or lodge with the Chief Casino Officer an application for renewal in writing that substantially —
  - (a) is in such form as the Commission may approve; and
  - (b) complies with the requirements of that form and any other requirements made known to the applicant by the Chief Casino Officer.
- (4) The application for renewal shall be accompanied by the appropriate licence fee prescribed in regulation 6.

”.

**HE401****ANATOMY ACT 1930**

## ANATOMY ACT (SECTION 4) NOTICE 1999

Made by the Minister under section 4 of the Act.

**Citation**

1. This notice may be cited as the *Anatomy Act (Section 4) Notice 1999*.

**Commencement**

2. This notice comes into operation on 14 June 1999.

**Authorized school of anatomy**

3. Subject to clause 4, the place specified in the table to this clause is authorized to be established and conducted as a school of anatomy.

**Table**

The School of Human Anatomy within the Division of Veterinary Biomedical Science at the Murdoch University, South Street, Murdoch.

**Conditions of authorization**

4. The authorization under clause 3 to establish and conduct the school of anatomy specified in the table to that clause is subject to the conditions that—

- (a) the school obtains human body parts only from the authorized school of anatomy at the University of Western Australia, Stirling Highway, Nedlands;
- (b) no dissection on human body parts is undertaken at the school;
- (c) human body parts are, at all times, other than when specifically prepared for museum or demonstration room display purposes only, kept completely separate from any animal tissue;
- (d) the part of the school where human body parts are stored is kept secure at all times; and
- (e) any human body part held at the school that requires disposal be returned to the authorized school of anatomy at the University of Western Australia for that purpose.

The appropriate agronomic requirements such as fertiliser, lime application etc must be met when establishing Kikuyu pasture and also when managing the existing annual sub clover based pasture to maintain production as required. Land holders who run stock infrequently may request an exemption from this requirement;
  - (c) land holders ensuring Kikuyu does not escape into surrounding vegetation, bushland, and road verges. Kikuyu growth shall be controlled by mechanical methods rather than pesticides;

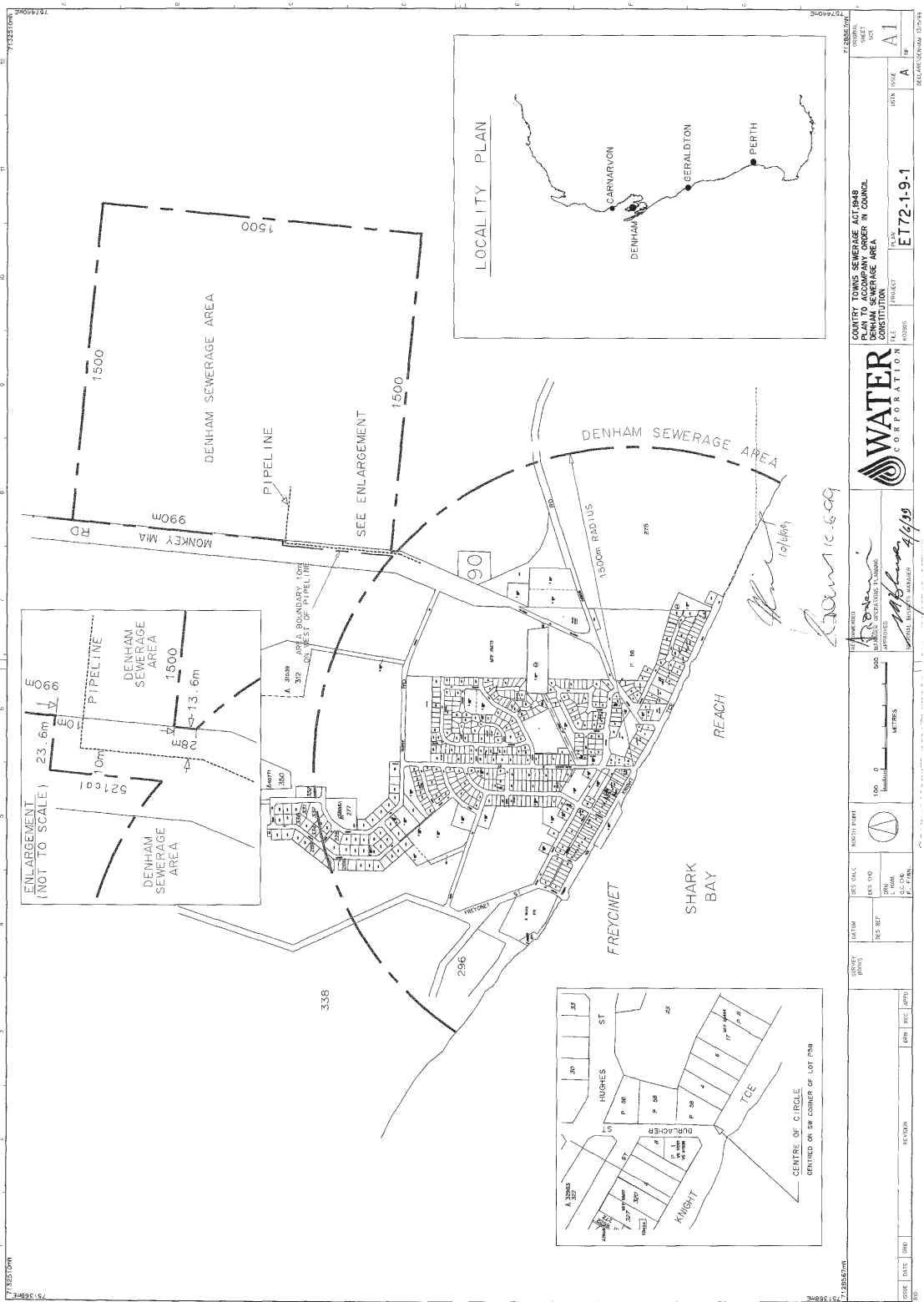
