NOTICE OF AMENDMENT

Notice is hereby given that at a meeting of the Committee of the Western Australian Trotting Association held at Gloucester Park, East Perth, on the 9th day of November 1999, it was resolved by an absolute majority of the Committee of the Association that the By-laws of the Western Australian Trotting Association made under the Western Australian Trotting Association Act 1946 ("the Act") be amended as follows:

Amend By-law 13.5:

Subclause (3)

Present wording:

13.5 (3) No person may:

- (a) make application for:
 - (i) registration as a driver, trainer, owner, stable hand, bookmaker or bookmaker's clerk;
 - (ii) registration of a horse or foal (or for a certificate of service) or of any transfer, lease or cancellation of lease of a horse;
 - (iii) registration of a syndicate;
 - (iv) registration of a harness racing stud;
 - (v) registration of colours; or
 - (vi) full time employment with the Association, or any other licence or registration under the Rules;
- (b) lodge a nomination of a horse for any race or trial; or
- (c) lodge a stable return,

and, subject to subclause (6), the Controlling Body may not accept or deal with such an application, nomination or return, unless the person is a participating member and, unless all persons referred to in the application, nomination or, return are participating members.

Amended wording:

13.5 (3) No person may:

(a) make application for:

(i) registration as a driver, trainer, owner, stable hand, bookmaker or bookmaker's clerk;

(ii) registration of a horse or foal (or for a certificate of service) or of any transfer, lease or cancellation of lease of a horse;

(iii) registration of a syndicate;

(iv) registration of a harness racing stud;

(v) registration of colours; or

(vi) full time employment with the Association,

or any other licence or registration under the Rules;

(b) lodge a nomination of a horse for any race or trial; or

(c) lodge a stable return,

and, subject to subclause (6), the Controlling Body may not accept or deal with such an application, nomination or return, unless:

(d) the person is a participating member; and

(e) all persons referred to in the application, nomination or, return are participating members.

And by adding the following new subclause immediately after subclause (4):

13.5 (4A) paragraph (e) of subclause (3) shall not apply in the case of an application required to be signed by more than one person and where the manager or person first mentioned in the application is a participating member.



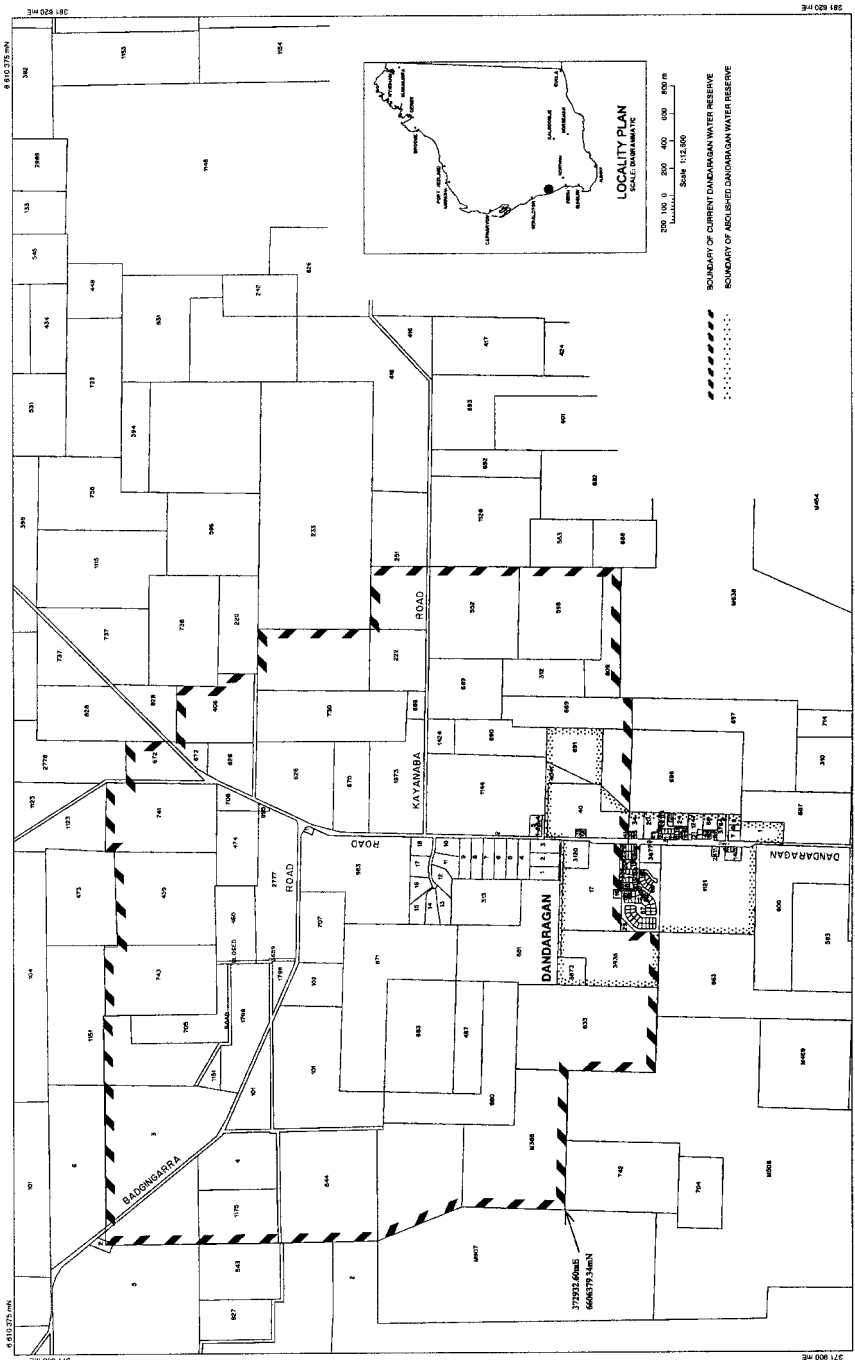

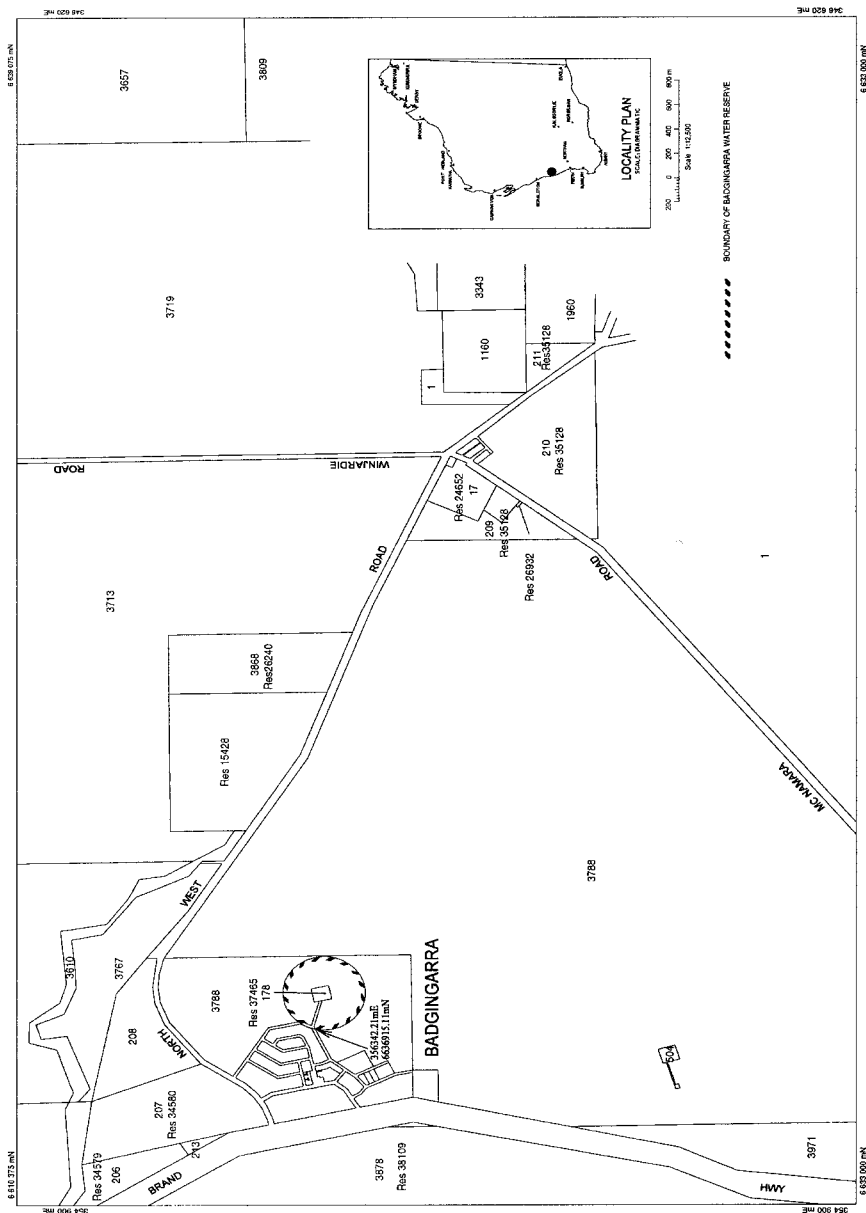

BUSH FIRES ACT 1954

NOTICE TO ALL OWNERS/OCCUPIERS OF LAND WITHIN THE
CITY OF SUBIACO

FIRE BREAK OR REMOVAL OF FLAMMABLE MATTER ORDER

1999/2000

Pursuant to the powers contained in Section 33 of the Bush Fires Act 1954, as amended, owners and/or occupiers of property's within the City of Subiaco are hereby required on or before 30 November 1999, and thereafter to the 31 March 2000, or within fourteen (14) days of the date of becoming owner or occupier, should this be after the 30 November 1999 to maintain a fire break or remove flammable matter as follows—

- (a) Where the land is 2 024m² (approximately 1/2 an acre) or less, remove all flammable matter from the whole of the land, (for the purposes of this Notice, flammable matter does not include low standing trees, cultivated plants or shrubs in gardens).
- (b) Where the land exceeds 2 024m² (approximately 1/2 an acre) you shall have a fire break not less than three (3) metres wide and clear of all external boundaries of the land and immediately surrounding all buildings and improvements on the land.

If it is considered impractical for any reason to clear fire breaks, or remove flammable matter as required by this Notice, you may apply to the Council or its duly authorised officers not later than the 15 November 1999, for permission to provide a fire break in alternative positions, or to take alternative measures to abate fire hazards on the land. If permission is not granted by the Council or its duly authorised officer, you shall comply with the requirements of this Notice.

The penalty for failing to comply with this Notice is an infringement penalty of \$80.00 or a fine of not more than \$1,000.00 and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed in this Notice, if it is not carried out by the owner/occupier by the date required by this Notice.

PETROLEUM (SUBMERGED LANDS) ACT 1967

(SECTION 119)

PROHIBITION OF ENTRY INTO A SAFETY ZONE

I, William Lee Tinapple, the Director Petroleum Division of the Department of Minerals and Energy of the State of Western Australia, by instrument of delegation dated 4 June 1998, and pursuant to Section 119 of the above Act, hereby prohibit all vessels other than vessels under control of the registered holders of Exploration Permit WA-260-P from entering or remaining in the area of the safety zone without the consent in writing of the Director, Petroleum Division. This safety zone extends to a distance of five hundred metres, measured from each point of the outer edge of the floating Production Storage and Offloading facility "Buffalo Venture" (281m in length) and the Buffalo Venture mooring riser (latitude 10° 39'44.91" South, longitude 126° 05'04.71" East.)

Where an unauthorised vessel enters or remains in the safety zone specified in contravention of this instrument, the owner and the person in command or in charge of the vessel are each guilty of an offence against Section 119 of the Act and are punishable, upon conviction, by a fine not exceeding \$100,000 or imprisonment for a term not exceeding 10 years, or both, pursuant to Section 119(3) of the Act.
