Building and Construction Industry Training Fund and Levy Collection
Act 1990

Building and Construction Industry Training Fund and Levy Collection Amendment Regulations 2000

Made by the Governor in Executive Council.

1. Citation

These regulations may be cited as the *Building and Construction Industry Training Fund and Levy Collection Amendment Regulations 2000*.

2. New regulation 3B inserted

The *Building and Construction Industry Training Fund and Levy Collection Regulations 1991** are amended by inserting after regulation 3A the following regulation —

“

3B. Exemption for foreign missions and consulates

Construction work carried out for the government of a foreign country in the course of, or in connection with, constructing, extending or altering a building that is used or is to be used for the purposes of a diplomatic mission or consulate of the foreign country is excluded from the definition of “construction work” in section 3(1) of the Act.

”.

ENVIRONMENTAL PROTECTION

EP301*

Environmental Protection Act 1986

Environmental Protection (Claremont Speedway) Exemption Order 1999

Made by the Minister with the approval of the Governor in Executive Council under section 6 of the Act.

1. Citation

This order may be cited as the *Environmental Protection (Claremont Speedway) Exemption Order 1999*.

2. Commencement and expiry

This order comes into operation on the day on which it is published in the *Gazette* and, subject to section 6 of the Act, expires on 31 March 2000.

3. Definitions

In this order —

“**Director**” means the Director of the Pollution Prevention Division of the Department of Environmental Protection, 141 St George’s Terrace, Perth, Western Australia;

“**meeting**” means a series of races held at the speedway;

“**operator**” means Placide Pty Ltd (ACN 009 409 572) as trustee for the Metro Speedway Unit Trust and trading as “Claremont Speedway”;

“**racing**” includes exhibition runs, trials, testing, practice and promotional presentations using racing vehicles;

“**racing vehicle**” means a vehicle used for racing at a meeting;

“**speedway**” means the Claremont Speedway operated at the Royal Showgrounds, Claremont, by the operator;

“**sprint car**” means a racing vehicle having 4 open wheels, a V8 engine with a capacity greater than 300 cubic inches, wings to provide down force assistance and which is registered to race under the requirements of the Sprintcar Control Council of Australia Inc or the National Association of Speedway Racing Inc;

“**the period of exemption**” means the period during which this order is in operation.

4. Application

- (1) This order applies only while the operator remains the sole operator of the speedway.
- (2) This order applies only to noise emitted at the speedway from —
 - (a) racing vehicles;
 - (b) the public address system; and
 - (c) firework displays.

5. Declaration of exemption and requirement to comply

- (1) Part V of the Act (except for sections 71, 74, 76, 77 and 78) and, subject to clause 12(a) of Schedule 1, the *Environmental Protection (Noise) Regulations 1997* are declared not to apply to noise emitted at the speedway from —
 - (a) racing vehicles;
 - (b) the public address system; and
 - (c) firework displays.
- (2) The declaration under subclause (1) is subject to the conditions specified in Schedule 1.
- (3) The operator is required to comply with the conditions specified in Schedule 1.

Schedule 1 — Conditions of exemption

[cl. 5]

1. Racing at speedway to comply with Schedule

The operator is to allow the speedway to be used for racing only at a meeting held in accordance with this Schedule.

2. Number of meetings

- (1) The operator is not to hold more than 60 meetings during the period of exemption.
- (2) Each day on which a meeting is held under clause 5(1) is a separate meeting for the purpose of subclause (1).

3. Duration of meetings

- (1) Except as otherwise stated in this Schedule, the operator is to ensure that —
 - (a) a meeting is held only on a Friday, Boxing Day or New Year's Day; and
 - (b) racing at a meeting does not begin before 5 p.m. and ends not later than 10.30 p.m.
- (2) If racing at a meeting is substantially delayed —
 - (a) the operator is to make appropriate arrangements to minimize the need for racing to continue after 10.30 p.m.; and
 - (b) subject to paragraph (a), racing may continue at the meeting until it is completed, but it is to end not later than 10.45 p.m.
- (3) If racing continues under subclause (2), the operator is to notify the Director by 5 p.m. on the next working day of —
 - (a) the reason why racing was substantially delayed; and
 - (b) the arrangements made to minimize the need for racing to continue after 10.30 p.m.
- (4) If a meeting does not take place on a day referred to in subclause (1)(a) because of bad weather, the meeting may be held on any other day, except a Sunday.
- (5) Subclauses (1)(b), (2) and (3) apply to a meeting that is held under subclause (4).

4. Meetings for training, practice and measuring noise emissions

- (1) The operator may hold a meeting on a Thursday for the purpose of training, practice or measuring noise emissions.
- (2) The operator is to ensure that a meeting held under subclause (1) does not begin before 12 p.m. or end after 2 p.m.

5. State, national and international meetings

- (1) If the operator is hosting a State, national or international event at the speedway, the operator may hold a meeting that continues on consecutive Thursday, Friday and Saturday nights.

- (2) The operator is to ensure that the Director is given 7 days written notice that a meeting is going to be held under subclause (1).
- (3) The operator is to ensure that no more than 2 meetings are held under subclause (1) during the period of exemption.
- (4) Clause 3(1)(b), (2) and (3) apply to each day on which a meeting is held under subclause (1).

6. Noise emissions of racing vehicles

- (1) The operator is to ensure that the level of noise emitted by a racing vehicle at a meeting does not exceed —
 - (a) 95 dB $L_{A\ slow}$; or
 - (b) where the operator is of the opinion that it is appropriate and the racing vehicle is used only for exhibition runs, 105 dB $L_{A\ slow}$.
- (2) The operator is to ensure that the level of noise emitted by a sprint car that is to be raced at a meeting is measured in accordance with clause 8 and calculated in accordance with clause 9 prior to the meeting and, when so measured and calculated, does not exceed 95 dB $L_{A\ slow}$.
- (3) If the exhaust system or engine of a sprint car is modified or replaced after the level of noise emitted by the car has been measured, the operator is to ensure that the level of noise emitted by the car is measured again in accordance with clause 8 and calculated in accordance with clause 9 before the car is raced at a meeting.
- (4) Subclause (1) does not apply in respect of noise emitted by a racing vehicle for the purpose of measuring the level of that noise.

7. Certificate regarding testing of noise emissions of racing vehicle

- (1) Unless subclause (2) applies, the operator is to be taken to have complied with clause 6 in respect of a racing vehicle if the operator ensures that a certificate has been given by a person approved by the Director in respect of the vehicle to the effect that the level of noise emitted by the vehicle has been measured in accordance with clause 8 and, where relevant, calculated in accordance with clause 9 prior to the meeting and does not exceed the relevant level of noise specified in clause 6(1).
- (2) Subclause (1) does not apply if the exhaust system or engine of a racing vehicle in respect of which the certificate is given is modified or replaced after the certificate has been given.

8. Method of measurement of noise levels of racing vehicles

- (1) The operator is to ensure that the level of noise emitted by a racing vehicle, other than a racing vehicle referred to in clause 6(1)(b), is measured while the vehicle completes 3 consecutive laps of the speedway within a period that is not greater than 3.5 times the average lap time recorded for races at the speedway for the class of racing vehicle to which the vehicle belongs during the 1998 to 1999 racing season.

- (2) The operator is to ensure that the measurements referred to in subclause (1) are made at a point that is —
- (a) inside the inner boundary of the speedway track;
 - (b) not less than 29 m and not more than 31 m from the inner boundary; and
 - (c) on, or as close as practicable to, the shorter axis of the speedway track,

and with the measuring microphone not less than 1.2 m or more than 1.4 m above the ground plane.

- (3) The operator is to ensure that the level of noise emitted by a racing vehicle referred to in clause 6(1)(b) is measured —
- (a) taking less than 15 minutes, while the vehicle —
 - (i) is stationary and its engine is operating at its maximum speed; or
 - (ii) is moving under power with the engine operating at not less than 80% of its maximum speed;
 - (b) at a point that is not less than 29 m and not more than 31 m from the nearest point of the vehicle; and
 - (c) with the measuring microphone not less than 1.2 m or more than 1.4 m above the ground plane.

9. Calculation of average noise level where measured over 3 laps

The level of noise emitted by a racing vehicle under clause 8(1) and (2) is taken to be the level obtained by —

- (a) adding together the maximum level of noise measured for the vehicle on each of the laps referred to in clause 8(1); and
- (b) dividing the total resulting from that addition by 3.

10. Noise from public address system

The operator is to ensure that the level of noise emitted from the public address system at the speedway —

- (a) is kept to as low a level as is possible to minimize the impact of that noise at nearby residential properties while providing an adequate commentary for speedway patrons; and
- (b) at no time exceeds 80 dB $L_{A\ slow}$ when measured at or near any nearby residence.

11. Firework displays

The operator is to ensure that firework displays during meetings at the speedway end not later than 9 p.m.

12. Operator to ensure compliance of instruments

The operator is to ensure that —

- (a) an instrument used to measure levels of noise emissions for the purposes of this order is calibrated in accordance with, and otherwise complies with, Schedule 4 to the *Environmental Protection (Noise) Regulations 1997*; and
- (b) a person who operates the instrument is approved by the Director.

13. Operator to ensure assistance is given to inspectors

The operator is to ensure that an inspector performing functions in relation to this order is given any assistance the officer reasonably requires.

14. Reports

- (1) The operator is to prepare a written report in a form and of a standard approved by the Director each time that measurements are made under clause 8 of the level of noise emitted by a racing vehicle.
- (2) The operator is to ensure that a copy of each report is given, within 14 days after the measurements referred to in the report are made, to the Director and to the chief executive officer of the Town of Claremont.

**Chiropractors Registration Board Amendment
Rules 1999**

Made by the Board with the approval of the Governor in Executive Council.

1. Citation

These rules may be cited as the *Chiropractors Registration Board Amendment Rules 1999*.

2. The rules amended

The amendments in these rules are to the *Chiropractors Registration Board Rules 1966**.

- (1) Rule 6(2) is amended after paragraph (a) by deleting “or” and inserting —

“

- (aa) fails to pay the annual licence fee referred to in rule 10(2); or

- (2) Rule 6(5) is amended by deleting “, upon payment of the fee prescribed in Appendix A to these rules,”.

- (3) After rule 6(5) the following subrule is inserted —

“

- (6) A person may, on payment of the fee prescribed in Appendix A, obtain a copy of the register.

and any person who takes part in a meeting so held or approves a resolution so circulated is, for the purposes of that subclause, deemed to have been present at the meeting.

”.

6. Rule 10C amended

- (1) Rule 10C(1)(a) is amended by inserting after “that title” —

“

unless it is used in conjunction with the word “chiropractor” or “chiropractic”

”.

- (2) Rule 10C(4) is repealed.

7. Rule 14 amended

Rule 14(1) is amended as follows:

- (a) after paragraph (b) by deleting “or”;
 - (b) after paragraph (c) by deleting the comma and inserting —

- (d) order the chiropractor to pay a penalty not exceeding \$5 000,

LOCAL GOVERNMENT ACT 1995
SHIRE OF SERPENTINE-JARRAHDAL
 EXTRACTIVE INDUSTRIES LOCAL LAW

Under the power conferred by the *Local Government Act 1995* and under all other powers, the Council of the Shire of Serpentine-Jarrahdale resolved on 20th December 1999 to make the following local law.

The Shire of Donnybrook/Balingup Extractive Industries Local Law published in the *Government Gazette* on 9 June 1998 is adopted as a local law of the Shire of Serpentine-Jarrahdale, with the alterations which follow—

1. Clause 1.1—Definitions

1.1 In clause 1.1—

- (a) in the definition of 'local government', delete '[1]' and substitute 'Shire of Serpentine-Jarrahdale';
- (b) insert in the appropriate alphabetical position—
 "person" does not include the local government.

2. Clause 1.2—Application

2.1 After the clause designation "1.2" the subclause designation "(1)" is inserted.

2.2 In clause 1.2(1)—

- (a) In paragraph (a) delete "and (d)" and substitute ", (d) and (e)";
- (b) in paragraph (c) delete "and";
- (c) renumber paragraph (d) to paragraph (e);
- (d) insert the following paragraph—
 '(d) do not apply to the carrying on of an extractive industry on land by the owner or occupier of that land for use on that land; and'

2.3 After clause 1.2(1) insert the following subclause—

- '(2) In subclause (1)(d) land includes adjoining lots or locations in the same occupation or ownership of the owner or occupier referred to in subclause (1)(d).'

3. Clause 1.3—Repeal

3.1 Delete clause 1.3 and substitute—

The Shire of Serpentine-Jarrahdale By-laws (Extractive Industries) published in the *Government Gazettes* of 30 July 1970, 10 January 1986, 18 December 1987, 25 November 1988, 29 December 1989, 7 December 1990, and 28 October 1994, are repealed.

4. Clause 2.3(1)—Application for licence

4.1 After the clause designation "2.3(1)" delete "A" and substitute "Subject to subclause (3), a".

4.2 In clause 2.3(1)(a)(v), delete 'roads' and substitute 'thoroughfares' in both places where it appears.

4.3 In clause 2.3(1)(b), in subparagraphs (vii) and (xv), delete 'roads' and substitute 'thoroughfares'.

4.4 In clause 2.3(1)(c)—

- (a) renumber subparagraphs (iii), (iv), (v) and (vi) to (iv), (v), (vi) and (vii) respectively;
- (b) insert the following subparagraph –
 '(iii) how each face is to be made safe and batters sloped;'; and
- (c) in renumbered subparagraph (vi) delete 'and irrigated'.

4.5 In clause 2.3(1)(d), delete 'road' and substitute 'thoroughfare'.

4.6 In clause 2.3(1)—

- (a) renumber paragraphs (i) and (j) to (j) and (k) respectively;
- (b) insert the following as paragraph (i)—
 'evidence that a notice of clearing has been given to the Commissioner of Soil and Land Conservation if that is required under regulation 4 of the *Soil and Land Conservation Regulations 1992*'; and
- (c) in renumbered paragraph (j), insert 'reasonably' after 'may'.

4.7 After clause 2.3(2) insert the following subclause—

'(3) The local government may exempt a person making application for a licence under subclause (1) from providing any of the data otherwise required under subclause (1), if, in the opinion of the local government, the location and size of the proposed excavation are such that no significant adverse environmental affects will result therefrom.'

5. Clause 3.1(5)—Determination of application

5.1 In clause 3.1(5)(b), delete 'roads' and substitute 'thoroughfares'.

5.2 In clause 3.1(5)—

(a) renumber paragraphs (q) and (r) to (r) and (s) respectively; and

(b) insert the following as paragraph (q)—

'requiring the licensee to enter into an agreement with the local government by which it agrees to pay any extraordinary expenses incurred by the local government in repairing damage caused to thoroughfares in the district by heavy or extraordinary traffic conducted by or on behalf of the licensee under the licence.'

6. Clause 5.2—Use by the Local Government of secured sum

6.1 In clause 5.2, delete 'Local Government' in the heading and substitute 'local government'.

 - (ii) the subject of a management order issued pursuant to section 46 of the *Land Administration Act 1997* to the Minister for Health or a Hospital Board or an Agency or Trust, or the subject of a vesting order issued under section 33(2) of the *Land Act 1933* to the Minister for Health or a Hospital Board or an Agency or Trust;
 - (iii) to the extent of the statutory powers of the Minister for Health or a Hospital Board or an Agency or Trust under the said Acts to grant or deal in interests in such land;
 - (iv) in accordance with any terms and conditions of a management order issued under section 46 of the *Land Administration Act 1997* or a vesting order issued under section 33(2) of the *Land Act 1933*, and associated policies and law.

- This delegation does not extend to transfers in fee simple; assignments of vesting or management to other parties; or to leases for terms exceeding any limits specified in the said Acts or in any management order or vesting order issued in relation to the subject land.

B. Limited Term of Delegation

This delegation will only endure until—

- Legislation is enacted to exclude or modify the application of section 18 of the *Land Administration Act 1997* in relation to Crown land dedicated to or set apart for the purposes of the said Acts, or vested pursuant to the provisions of the said Acts, or the subject of any management order issued under s.46 of the *Land Administration Act 1997* or vesting order issued under s.33(2) of the *Land Act 1933*; or

SPECIAL PROVISIONS

(1) Outline Development Plan

- (a) Subdivision of Special Residential Zone No.8 is to be in accordance with "Outline Development Plan—Special Residential Zone Area No. 8 (Plan No. 89/38/12) dated August 1999 and appended hereto.
- (b) Notwithstanding (a) above, the Western Australian Planning Commission may approve a minor variation to the subdivisional design, but further breakdown of the lots so created shall be deemed contrary to the provisions of the Scheme.

(2) Purpose of Zone

The purpose of Special Residential Zone No. 8 is to create a special-residential living environment which preserves the landscape quality and visual amenity of the locality, with particular attention given to—

- the minimisation of erosion, soil and vegetation disturbance;
- ensuring that buildings do not conflict with, or detract from, the landscape in terms of their design, location, scale, height or otherwise;
- minimising the impact of the development on the physical environment, particularly in terms of foreshore management, bushfire control, on-site effluent disposal and other servicing requirements.

(3) Lot Sizes

The minimum lot size shall be 2,000m².

(4) Land Use

Within the Special Residential Zone No. 8—

- (a) The following uses are permitted
"Residential Dwelling House"
- (b) The following uses are not permitted unless specific approval is granted by Council—
"Home Occupation"
- (c) All other uses not mentioned under (a) or (b) above are not permitted, and with the intention of preventing land degradation and practices detrimental to the environmental amenity of the zone, this includes the keeping of horses, goats, sheep, cattle, cats and any other animals considered detrimental by Council. The keeping of not more than two dogs may be permitted provided they are kept in manner that is sensitive to the objective of the zone relating to the protection of fauna.

(5) Building Envelopes

- (a) Any building and effluent disposal system on a lot shall be located within the Building Envelope delineated on the Outline Development Plan (Plan No. 89/38/12).
- (b) The location and extent of the building envelopes are as defined on Plan No. 89/38/12 and shall not exceed 900m² in area.
- (c) The clearing of indigenous vegetation within the building envelope shall require Planning Scheme Consent as required by special provision (7a).

(6) Fire Control

- (a) Council may request the Commission to impose a condition at the subdivision stage that strategic fire breaks, as nominated on the Outline Development Plan and defined by survey pre-cal, shall be constructed by the applicant in accordance with the requirements and specifications of Council.
- (b) Council shall require that individual landowners are responsible for the maintenance of a strategic fire break where it crosses the landowner's lot.
- (c) The clearing of fire breaks other than for strategic fire break purposes will not be permitted unless for safety reasons to comply with Council and Bush Fires Board requirements.
- (d) Within the approved building envelope, limited parkland clearing around all building structures may be required by Council to establish low fuel areas. The low fuel zones shall be kept free of debris and maintained to a standard approved by Council.
- (e) The subdivider shall make arrangements to the satisfaction of Council to ensure prospective purchasers, in the transfer of lots, are aware of the fire management guidelines of the Homeowners Bushfire Survival Manual and the Australian Standard 3559-1991—'Construction of Buildings in Bushfire Prone Areas'.

(7) Clearing of Indigenous Vegetation

- (a) All clearing of indigenous vegetation shall require Planning Scheme Consent including that required for approved driveway access, approved building and fenceline construction, and parkland clearing.
- (b) Council may approve parkland clearing within the Building Envelope however, significant vegetation shall be retained to the satisfaction of Council.
- (c) No clearing of indigenous vegetation will be approved outside the Building Envelope except that required to maintain an approved strategic firebreak, construct an approved driveway or fenceline, or remove dead, diseased or dangerous trees, or species exotic to the area.

(8) Planting of Vegetation

- (a) The planting of vegetation outside the Building Envelope shall only be permitted with Council approval.
- (b) The planting of species exotic to the area, outside the Building Envelope shall not be permitted.

(9) Reinstatement of Vegetation

- (a) Where land is devoid of vegetation or it is determined that erosion has occurred as a result of the development of private property, Council shall require the landowner to implement erosion control measures in accordance with the requirements and satisfaction of Council in the interests of preventing further land degradation.
- (b) In the event that provision (a) above is not complied with, Council may carry out, or cause to carry out, appropriate action to reinstate vegetation. Any expenses incurred by Council in carrying out such action shall be borne by the landowner.

(10) Dieback Control

To safeguard against the introduction of dieback within the zone, the following measures will be adopted—

- (a) Utilisation of in-situ basic raw materials in construction of building improvements, where feasible;
- (b) Where the importation of basic raw materials is unavoidable, such materials shall be obtained from classified die-back free sources;
- (c) Preparation of appropriate die-back hygiene strategies in consultation with CALM and Council in advance of construction work.

(11) Erosion Prevention

- (a) The position of access roads and driveways, pedestrian pathways, fire access tracks and building envelopes are as shown on the Outline Development Plan.
- (b) The extent of all areas disturbed by earthworks shall be minimised. Any disturbed areas shall be stabilised with vegetation, mulch, brush matting or other means approved by Council following the practical completion of construction phase.
- (c) The applicant shall maintain the stabilised soil surface over a period of two summers from the date of practical completion of the construction phase.
- (d) Commencement of construction of a building within a building envelope shall take place within one month of the building site being cleared, or such other period agreed to by Council.
- (e) Where construction of a building does not take place within the agreed time period, Council may enforce special provision (9) in the interests of preventing erosion and land degradation.

(12) Fencing

- (a) To assist in the retention of existing vegetation cover and to preserve and enhance the visual character of the zone, the erection of fencing on a lot shall not be permitted.
- (b) Notwithstanding (a) above and subject to the approval of Council, as a means of limiting access, fencing may be constructed—
 - (i) where a lot boundary abuts the Lake Vancouver Public Open Space Reserve;
 - (ii) where a lot boundary abuts the Vancouver Beach Foreshore Reserve;
- (c) Where fencing is approved, an area limited to one metre in width for the purpose of erecting and maintaining the fenceline will be required, and the method of clearing shall be by way of slashing to reduce erosion risk and excessive removal of vegetation.

(13) Building Design, Material, Colour and Height

- (a) All buildings constructed within the zone shall be sympathetic to existing landscape elements (namely landform and vegetation) in terms of their location, scale, height, building materials and colour.
- (b) Roof and external wall materials of buildings constructed within the zone shall be non-reflective and coloured to meld with the natural vegetation. Zincalume or other similar cladding will not be permitted. Other roof and external wall materials which would, in the opinion of Council, adversely affect the landscape amenity will not be permitted.
- (c) The maximum height of buildings constructed within the zone shall be in accordance with Figure 1—Measurement of Building Heights.

(14) Foreshore Management

The Council may request the Commission to impose a condition at the subdivision stage to require the applicant to implement the relevant part of the approved Foreshore Management Plan prepared in accordance with the requirements and specification of Council and Western Australian Planning Commission for the southern portion of the Vancouver Beach Foreshore abutting the Special Residential Zone No. 8.

(15) Servicing

- (a) On-site effluent disposal shall be the responsibility of the individual landowner and shall involve the use of alternative on-site effluent disposal systems approved by Council and the Public Health Department. The disposal systems shall be located within the building envelope identified on Plan No. 89/38/12 and installed and managed in accordance with the specifications of Council. Septic and leach drain systems will not be permitted.
- (b) The disposal of stormwater from within the site shall be managed in accordance with the approved Drainage Management Plan prepared in accordance with the requirements and specification of Council and the DEP.
- (c) To protect the groundwater resources of the locality, the supply of water using private bores shall not be permitted.
- (d) The Council may request the Commission to impose a condition at the subdivision stage requiring that power supply to land within Special Residential Zone No. 8 shall be located underground both within the road reserve and where connection is made to individual lots.
- (e) Roads within the zone shall;
 - (i) be located as in the Outline Development Plan and be in a manner which is sympathetic to the topography and minimises visual impact,
 - (ii) shall adopt a 16 metre wide road reserve and a 5 metre pavement designed to minimise cut and fill,
 - (iii) be drained underground and kerbed to meet the requirements and specification of Council.
- (f) Battleaxe legs as on the Outline Development Plan shall be constructed to the requirements and specification of Council.
- (g) The Council may request the Commission impose a condition at the subdivision stage which requires that the applicant shall construct the private driveways on each lot to a limestone base standard, between the road reserve and the external boundary of the approved building envelope.

(16) Pedestrian Access

Any application for subdivision of the land shall include as part of the proposal, provision for pedestrian access to the public open space adjoining the Foreshore Reserve.

(17) Unexploded Ordnance Survey

- (a) The Council may request the Commission impose a condition at the subdivision stage which requires the applicant to carry out any Unexploded Ordnance Survey as may be required by the UXO Branch of the Policy Emergency Services Unit.

(18) Anthropological and Archeological Survey

- (a) The applicant shall carry out an Anthropological and/or Archeological Survey of Lot 401 and obtain the necessary clearance from the Minister for Aboriginal Affairs in accordance with the Aboriginal Heritage Act 1972-1980.
- (b) Where the Anthropological and/or Archeological Survey identifies the need to modify the Outline Development Plan (Plan No 89/38/12), the Western Australian Planning Commission may approve minor variations to the design, but where variations are considered to be major, a further Scheme Amendment will be required.

(19) Applications for Development Approval

- (a) The construction of buildings including associated site works such as filling, excavation, construction of retaining walls and fencing, and the removal of vegetation in accordance with special provision (7), shall require Planning Scheme Consent.
