Beekeepers Act 1963

**Beekeepers Amendment Regulations
(No. 2) 2000**

Made by the Governor in Executive Council.

1. Citation

These regulations may be cited as the *Beekeepers Amendment Regulations (No. 2) 2000*.

2. Regulation 27A and heading inserted

After regulation 27 of the *Beekeepers Regulations 1963** the following heading and regulation are inserted —

“

Approved Devices**27A. Devices approved for pollination purposes**

- (1) A beekeeper who owns bees, or has the charge, care or possession of bees, that are kept in a device approved for the purposes of section 8(1a) of the Act shall clearly and indelibly mark on the device the date when the bees are first placed in it.
- (2) The prescribed manner of disposing of the bees and the device for the purposes of section 8(1a) of the Act is —
 - (a) by destroying the bees immediately after flying has ended at night by pouring petrol into the device and immediately closing it;
 - (b) by burning the device and the dead bees in a pit in the ground; and
 - (c) by burying the burnt remains under at least 0.3 metres of earth.

”.

PROHIBITION ON LINE FISHING FROM TRAWLERS
(SHARK BAY) ORDER 2000
Order No. 8 of 2000

FD 1620/98 [383]

Made by the Minister under section 43.

Citation1. This order may be cited as the *Prohibition on Line Fishing from Trawlers (Shark Bay) Order 2000*.**Interpretation**

2. In this order—

“trawler” means a licensed fishing boat which may be used for trawling in the waters of the Shark Bay western gulf under the authority of any fishing boat licence or managed fishery licence; and

“waters of the Shark Bay western gulf” has the meaning provided for in regulation 30D of the *Fish Resources Management Regulations 1995*.**Prohibition on fishing by line or hook**

3. A person must not fish by means of a fishing line or hook from a trawler in the waters of the Shark Bay western gulf.

Sentencing Act 1995

**Sentencing Amendment Regulations
(No. 3) 2000**

Made by the Governor in Executive Council.

1. CitationThese regulations may be cited as the *Sentencing Amendment Regulations (No. 3) 2000*.

2. Commencement

These regulations come into operation on the day on which the *Acts Amendment (Fines Enforcement) Act 2000* comes into operation.

3. Part 3A inserted

After Part 3 of the *Sentencing Regulations 1996** the following Part is inserted —

“

Part 3A — Cancellation of fine enforcement (WDO) orders**6A. Application for cancellation of order (s 57B)**

- (1) An application under section 57B(2) of the Act is to be made in an approved form.
- (2) On receiving an application a court officer is to issue a summons (in an approved form) to the offender to a hearing on a date and at a place fixed by the officer.
- (3) The summons must be served by a court officer on the offender.
- (4) If satisfied that the offender has been served with a summons, the court may deal with the application.

”.

**Fines, Penalties and Infringement Notices
Enforcement Amendment Regulations
2000**

Made by the Administrator in Executive Council.

1. Citation

These regulations may be cited as the *Fines, Penalties and Infringement Notices Enforcement Amendment Regulations 2000*.

2. Commencement

These regulations come into operation on the day on which the *Acts Amendment (Fines Enforcement) Act 2000* comes into operation.

3. Regulation 6C inserted

After regulation 6B of the *Fines, Penalties and Infringement Notices Enforcement Regulations 1994** the following regulation is inserted —

“

6C. Reduction of liability to pay fine where WDO taken to be cancelled (s. 57B(7) Sentencing Act 1995)

- (1) This regulation applies if a WDO has been wholly or partially completed at the time it is to be taken to be cancelled under section 57B(5) of the *Sentencing Act 1995*.
- (2) If the WDO has been wholly completed, the offender's liability to pay the fine is discharged.
- (3) If the WDO has been partially completed, the fine payable by the offender is to be reduced by \$150 for every 6 hours worked.

LOCAL GOVERNMENT

LG301***HEALTH ACT 1911**

City of Nedlands

HEALTH (EATING HOUSES) LOCAL LAW 2000

Made by the Council of the City of Nedlands under section 342 of the *Health Act 1911* in accordance with subdivision 2 of Division 2 of Part 3 of the *Local Government Act 1995*.

PART 1—PRELIMINARY**1. Citation**

This Local Law may be cited as the City of Nedlands Health Eating-Houses) Local Law 2000.

2. Repeal

(1) The Health Local Laws of the City of Nedlands, described as “*Health Local Law—Eating Houses*” made by the City of Nedlands on 9 April 1959 and published in the *Government Gazette* on the 30 June 1959 and amended from time to time, are repealed; and

(2) The Health Local Laws of the City of Nedlands, described as "*Local Law Relating to Eating Houses*" made by the City of Nedlands on 1 September 1988 and published in the *Government Gazette* on the 21 April 1989 and amended from time to time, are repealed.

3. Interpretation

In this Local Law, unless the context otherwise requires—

“Act” means the *Health Act 1911* as amended.

“approved fee” means the fee as fixed from time to time by the Local Government under Section 344C of the Act;

“approved form” means a form approved by the Local Government;

“eating house” shall have the same meaning as defined in Section 160 of the *Health Act 1911*;

“licence” means a licence to conduct an eating house issued by the Local Government under this Local Law;

“local government” means the City of Nedlands,

“registration” means the registration of an eating house issued by the Local Government under this Local Law.

PART 2—REGISTRATION AND LICENSING

4. Prescribed Date

For the purpose of Section 163 of the Act 30 June in each year is hereby prescribed as the date on or before which the registration of an eating house and a licence for the proprietor of an eating house shall be applied for annually.

5. Requirement for registration and licensing

A person shall not occupy or use or cause, suffer, or permit to be occupied or used any premise as an eating house unless and until—

(a) the premises are registered; and

(b) each of the proprietors of the premises is licensed,

in accordance with the provisions of this Local Law.

6. Registration of an Eating House

(1) Any person seeking the registration of an eating house shall make application on the approved form and shall forward the application to the Local Government together with—

(a) subject to subclause (3), the approved fee;

(b) a floor plan and specification of the eating house which plan and specifications shall include the following details—

(i) the use of every room;

(ii) the internal finishes of every wall, floor and ceiling;

(iii) the position and type of every fitting and fixture;

(iv) all sanitary conveniences, change rooms, ventilating systems, drains, grease traps and provisions for waste disposal;

(c) the proposed menu; and

(d) the estimated number and sex of every person, including the proprietor or proprietors, engaged in the preparation, manufacture, processing, cooking or serving of meals.

(2) Where a person makes application for the registration of an eating house in respect of which a certificate of registration is current at the date of the application, the person shall not be required to forward the plan and specification referred to in paragraph (b) of sub-clause (1).

(3) Where the registration for any year commences between 1 January and 30 June inclusive in that year, then the applicant shall be required to pay only one half of the approved fee.

(4) Upon approval of an application for registration of an eating house, for any premises it considers suitable for the purpose, the Local Government shall provide the applicant with a certificate of registration.

7. Licence to conduct an eating house

(1) The proprietor of an eating house seeking the issue of a licence shall make application on the approved form and shall forward the application to the Local Government together with the approved fee.

(2) Where there are two or more proprietors of an eating house—

(a) all proprietors names shall be included on the application; and

(b) the licence shall be issued in joint names.

(3) If the application is approved, a licence shall be issued by the Local Government.

(4) Any person seeking the transfer of a licence shall make application on the approved form and shall forward the application to the Local Government together with the approved fee. The application shall be signed by the proposed transferee of the licence and the holder of the licence.

8. Licence conditions

A licence shall be issued upon and subject to the condition that the holder of the licence shall—

- (a) display the licence and certification of registration of the eating house in a conspicuous place in the eating house;
- (b) notify the Local Government in writing of any alteration, addition or other work relating to the construction, drainage or ventilation of the eating house prior to the commencement of such alteration, addition or other work;
- (c) notify the Local Government in writing of any proposed changes to the menu that shall affect the classification under the *Health (Food Hygiene) Regulations 1993*;
- (d) notify the Local Government in writing of any proposed increase in staff numbers;
- (e) notify the Local Government of anything which may or has caused contamination of food; and
- (f) prevent public access to the food preparation and storage areas at all times.
- (g) not permit the reuse of any table napkin or serviette unless such table napkin has been thoroughly washed and cleansed since it was used.
- (h) not allow, animals or bird to be slaughtered and dressed or any poultry, pigeons or game to be plucked in any part of the premises.

9. Eating areas

The proprietor of any eating house shall maintain the public's dining area in a clean and hygienic condition, including any outdoor eating area and shall, when directed by an Environmental Health Officer, thoroughly clean and disinfect any such area.

PART 3—MISCELLANEOUS

10. Inspection

Pursuant to section 349 of the *Health Act 1911*, an environmental health officer is permitted to conduct inspections of properties from time to time and to investigate any contravention of this local law.

11. Delegation

The City may delegate any of the powers, functions and duties in this Local Law to the CEO or to an environmental health officer.

PART 4—PENALTIES

12. Penalties

A person who commits a breach or fails to comply with any of the requirements of this local law commits an offence and is liable to the penalties as follows—

- (a) a penalty which is not more than \$2,500 and not less than—
 - (i) in the case of a first offence \$250;
 - (ii) in the case of a second offence \$500; and
 - (iii) in the case of a third offence or subsequent offence \$1,250; and
- (b) if that offence is a continuing offence, a daily penalty which is not more than \$250 and not less than \$125.

This Local Law was made by the City of Nedlands at an Ordinary Meeting held on 25 of July 2000.

Caravan Parks and Camping Grounds Amendment Regulations 2000

Made by the Governor in Executive Council.

1. Citation

These regulations may be cited as the *Caravan Parks and Camping Grounds Amendment Regulations 2000*.

“**road side rest area**” means an area designated by a traffic sign erected in accordance with a written law, as an area which may be used for 24 hours for —

- (a) resting;
- (b) stopping; or
- (c) camping,
in a vehicle;

”.

- (a) on 1 July 1997; and
- (b) immediately after the commencement of the *Caravan Parks and Camping Grounds Amendment Regulations 2000*,

regulations 16(b) and 22(b) do not apply in respect of that caravan for as long as the caravan remains at the facility it was located at on 1 July 1997.

- (ii) that the park home will be constructed in accordance with the requirements of the Building Code applicable with respect to a particular class or classes, specified in the certificate; and
- (iii) the year in which the park home will be constructed and the name of the person who constructed the park home;

and

(b) with the plans for the park home attached.

Penalty: \$4 000.

”.

- (3) Regulation 32(2) is amended by deleting “on or after 1 January 1998”.
- (4) Regulation 32(3) is amended by deleting “on or after 1 January 1998”.
- (5) After regulation 32(6) the following subregulation is inserted —

“

- (7) A builder who provides a certificate under subregulation (1a) in respect of the construction of a park home must ensure the park home is constructed in accordance with that certificate and the plans attached, unless —

(a) the local government; and

(b) the licence holder of the facility on to which the park home is to be brought,

have approved otherwise in writing.

Penalty: \$4 000.

”.

- (3) Despite any requirement of the Building Code to the contrary, a park home is not required to contain ablution, toilet or laundry facilities.
