Land Administration Amendment Regulations 2001

Made by the Governor in Executive Council.

1. Citation

These regulations may be cited as the *Land Administration Amendment Regulations 2001*.

2. Commencement

These regulations come into operation on the day after the day on which they are published in the *Gazette*.

4. Regulation 4 amended

Regulation 4(a) is amended by inserting before "the advice of the Valuer-General" —

" subject to regulation 12, ".

5. Regulation 17 amended

Regulation 17(1) is amended by inserting after "by the Department" —

" for and on behalf of the Minister".

6. Regulations 17B and 17C inserted

After regulation 17A in Part 2 the following regulations are inserted —

17B. Acts prescribed for the purposes of section 18(8)(b)(ii) of the Act

For the purposes of section 18(8)(b)(ii) of the Act, the *Local Government Act 1995* is prescribed.

17C. Stock prescribed for the purposes of the definition of authorised stock in section 93 of the Act

City of Fremantle

PARKING LOCAL LAWS AMENDMENT

Pursuant to its powers under the Local Government Act 1995 the City of Fremantle resolved on the 19 March 2001 to make the following amendments to the City of Fremantle Parking Local Law—

Part 3 Definitions

In the correct alphabetical order, insert new definition as follows-

"City" means the City of Fremantle.

Delete definition "parking facility" and substitute the new definition as follows—

"parking facility" includes land, buildings, reserve, road, parking area, metered zone, ticket machine zone, parking bay, parking station, attended parking station and any other facility available to the public generally with or without signs and/or for a specified class of persons for the parking of a vehicle, whether or not a fee is charged.

Delete definition "public reserve" and substitute the new definition as follows—
"reserve" includes any land;

- (a) Owned by the City;
- (b) Of which the City is the management body under the Land Administration Act 1997; or
- (c) Which is an 'otherwise unvested facility' in terms of section 3.53 of the Act.

Insert-New Clause as follows-

Part 10—Other Areas

Reserves

- 88(1) A person, other than an employee of the City in the course of his or her duties or a person authorised by the City, must not stand or park a vehicle on or over any portion of a reserve other than an area specifically set aside for that purpose.
- 88(2) Unless authorised by the City, a person—
 - (a) Must not, for the purposes of conducting a business, stand or park a vehicle on any part of a reserve; or
 - (b) Must not stand or park a vehicle in front of or over any footpath constructed across a reserve.

Modified Penalties

Insert the following-

88(1)	Stand or park a vehicle on a reserve	\$50.00
88(2)(a)	Stand or park a vehicle on a reserve, for conducting a business.	\$50.00

Applications for the award of a permit over areas W01-1 to W01-26 are required to be made in the approved manner, submitted in duplicate and should be accompanied by—

1.1 Details of-

1.1.1 Technical Assessment

The applicant's technical assessment of the petroleum potential of the area, including the concepts underlying its proposed exploration work program, with sufficient detail to support that program

1.1.2 Minimum Guaranteed Work Program

The applicant's minimum guaranteed proposal (including indicative minimum expenditure) for exploration wells to be drilled, 3D and 2D seismic and other surveying activities, data evaluation and other work, for each year of the first three years of the permit term. This proposal, to be known as the minimum guaranteed work program, should comprise work expected to involve a substantial exploration component - normally, appraisal work should not be included

1.1.3 Secondary Work program

The applicant's proposal (including indicative minimum expenditure) for exploration wells to be drilled, 3D and 2D seismic and other surveying activities, data evaluation and other work, for each of the three remaining years of the permit term. This proposal, to be known as the secondary work program, should comprise work expected to involve a substantial exploration component—normally, appraisal work should not be included.

NOTE: Applicants should note it is mandatory that the minimum work program proposed in each year of the exploration permit is stated precisely to avoid any ambiguity. Proposals for work programs that cannot be guaranteed to be undertaken within the first 3 years of the permit must not be included.

- 1.2 Particulars of the applicant—
 - 1.2.1 the technical qualifications of the applicant and of its key employees
 - 1.2.2 the technical advice available to the applicant
 - 1.2.3 the financial resources available to the applicant, including evidence of the applicant's ability to fund the work program proposed, a statement of other exploration commitments over the next 6 years, and a copy of the latest annual and quarterly reports for each applicant company

1.3 Other Information

Such other information as the applicant wishes to be taken into account in consideration of the application. Where an applicant has previously had an exploration permit cancelled such information might include why the applicant believes the prior failure is irrelevant to the current application.

1.4 Fee

Each application must be accompanied by a fee of \$A3,000, payable to the Commonwealth of Australia through an Australian bank or bank cheque.

An information package on the release areas detailing the work program bidding system outlined above and including the criteria for assessment of applications and the conditions to apply following the award of a permit, is available on the Department of Industry, Science and Resources Website at www.isr.gov.au/resources/petroleum.html, or on CD-ROM. Copies of the CD-ROM can be obtained through the Department of Industry, Science and Resources by e-mailing petroleum.exploration@isr.gov.au.

Obtaining and observing the release package is essential to making an informed application for any of the areas.

It should be noted that any income derived in the future from the recovery of petroleum from these areas will be subject to the Commonwealth Government's Resources Rent Tax.
