## Road Traffic Act 1974

## Road Traffic (Fees for Vehicle Licences) Regulations 2001

Made by the Governor in Executive Council.

### 1. Citation

These regulations may be cited as the *Road Traffic (Fees for Vehicle Licences) Regulations 2001*.

### 2. Commencement

These regulations come into operation on the day of their publication in the *Government Gazette*.

### 3. Specified day: section 28A

For the purposes of section 28A(3) of the Act, the specified day in relation to these regulations is 1 August 2001.

### 4. The *Road Traffic Act 1975* amended

Part III Division 2 of the Second Schedule to the *Road Traffic Act 1975*\* is amended as follows:

- (a) in clause 2(1) by deleting “\$12.51” and inserting instead —
