Agricultural Products Act 1929

## **Agricultural Products (Table Grapes) Order 2001**

Made by the Minister under section 3D(1) of the *Agricultural Products Act 1929*.

**1. Citation**

This order may be cited as the *Agricultural Products (Table Grapes) Order 2001*.

**2. Prohibition on sale of certain table grapes**

The sale, except for the purpose of export from the State, of table grapes that are below market grade (undergrade) as specified under the *Table Grape Grading Code 2001* is prohibited.

Electricity Corporation Act 1994

### Electricity Distribution Access Order 2001

Made by the Minister under section 93(1)(b) of the Act.

**1. Citation**

This order may be cited as the *Electricity Distribution Access Order 2001*.

**2. Commencement**

This order comes into operation on 1 January 2002.

**3. Definitions**

In this order, unless the contrary intention appears —

“**access**” means access to spare capacity and new capacity;

“**distribution employee**” has the same meaning as it has in the *Electricity Distribution Regulations 1997*;

“**distribution exit point**”, in relation to an existing or prospective user, means a distribution exit point within the meaning of the *Electricity Distribution Regulations 1997* to which the user wants electricity to be transported;

“**network access**” means access to spare capacity and new capacity of the interconnected network as defined in the *Electricity Distribution Regulations 1997*;

“**proposed access day**”, in relation to an existing or prospective user, means the day on and from which the user wants access, network access, or regional system access, as the case requires, to be made available;

**“regional system”** means any part of the electricity distribution system identified as a regional power isolated system on the depiction prepared and maintained under regulation 5(2) of the *Electricity Distribution Regulations 1997*;

**“regional system access”** means access to spare capacity and new capacity of a regional system;

**“relevant period”** means the period of 12 months beginning on the proposed access day;

**“renewable source”** means a source of energy that is not derived from a fossil fuel or a man-made nuclear fission process.

#### **4. Network access**

Under clause 2(1) of Schedule 6 to the Act, the corporation is to make available network access to an existing or prospective user for the transport of electricity if that user is able to demonstrate, to the reasonable satisfaction of a distribution employee, that the amount of electricity transported to each distribution exit point in the relevant period —

- (a) will be at least 2 000 megawatt hours, if the proposed access day is on or after 1 January 2002 but before 1 January 2003; or
- (b) will be at least 300 megawatt hours, if the proposed access day is on or after 1 January 2003.

#### **5. Regional system access**

Under clause 2(1) of Schedule 6 to the Act, the corporation is to make available regional system access to an existing or prospective user for the transport of electricity if that user is able to demonstrate, to the reasonable satisfaction of a distribution employee, that the amount of electricity transported to each distribution exit point in the relevant period will be at least 300 megawatt hours.

#### **6. Renewable energy access**

Despite anything in clause 4 or 5, under clause 2(1) of Schedule 6 to the Act, the corporation is to make available access to an existing or prospective user for the transport of electricity generated from a renewable source if that user is able to demonstrate, to the reasonable satisfaction of a distribution employee, that the amount of electricity to be transported to each distribution exit point in the relevant period will be at least 50 megawatt hours.

#### **7. Revocation of certain orders**

- (1) The *Electricity Distribution Access (Regional Systems) Order 1998* is revoked.
- (2) The *Electricity Distribution Access (Renewable Energy) Order 2000* is revoked.



- (3) The *Electricity Distribution Access (Interconnected Network) Order 2000* is revoked.

  - (b) a copy of any advice given by the Minister under section 8(1) of the Compensation Act;
  - (c) a copy of the authorization held by the affected person, as defined in the Compensation Act, in respect of which the claim for compensation was made;
  - (d) a copy of any order, amendment to a management plan or substituted management plan or notice which caused the entitlement to compensation under the Compensation Act to arise;
  - (e) a copy of any certificate by the Executive Director issued under section 5 of the Compensation Act;
  - (f) any other information that the applicant considers relevant to the determination of whether or not the affected person, as defined in the Compensation Act, is entitled to compensation or to the amount of compensation payable to the affected person; and
  - (g) if the applicant is the affected person, a fee of \$300.

”.

Rottnest Island Authority Act 1987

### Rottnest Island Notice 2001

Made by the Rottnest Island Authority under regulation 72A(1) of the *Rottnest Island Regulations 1988*.

**1. Citation**

This notice may be cited as the *Rottnest Island Notice 2001*.

**2. Commencement**

This notice comes into operation on the day on which it is published in the *Gazette*.

**3. Interpretation**

In this notice —

“**length**” has the same meaning as in the *Rottnest Island Regulations 1988*.

**4. Adequate insurance cover**

For the purposes of the *Rottnest Island Regulations 1988* —

- (a) a vessel that is 6.4 metres in length or longer has adequate insurance cover if there is in force in relation to the vessel —
  - (i) third party legal liability insurance providing indemnity of not less than \$5 million; and

- (ii) salvage insurance providing indemnity of not less than \$5 million;
- and
- (b) a vessel that is less than 6.4 metres in length has adequate insurance cover if there is in force in relation to the vessel third party legal liability insurance providing indemnity of not less than \$2 million.

### 1. Citation

These regulations may be cited as the *Rottnest Island Amendment Regulations 2001*.

### 2. The regulations amended

- (2) A mooring inspection report that is rejected by the Authority is to be taken not to have been provided to the Authority for the purposes of these regulations.

”.

**7. Regulation 48 amended**

- (1) Regulation 48(2) is amended by deleting the definition of “give way”.
- (2) After regulation 48(2) the following subregulation is inserted —

“

- (3) The requirement to give way takes effect in the circumstances described in regulation 7 of the *Road Traffic Code 2000* and is to be complied with as described in that regulation.

”.

**8. Regulation 59 amended**

- (1) Regulation 59(2) is amended by inserting after “possession” the following —  
“ , or discharge an explosive device, ”.
- (2) After regulation 59(3) the following subregulation is inserted —

“

- (3a) In subregulation (2) —  
“**explosive device**” includes a marine flare.

## Special Provisions

**1.0 PLAN OF SUBDIVISION**

1.1 Subdivision of Special Rural Zone Area No. 19 shall be generally in accordance with the Subdivision Guide Plan endorsed by the Chief Executive Officer.

1.2 Council may recommend that the Western Australian Planning Commission approve minor variations to the Subdivision Guide Plan.

**2.0 OBJECTIVES OF THE ZONE**

The objectives for Special Rural Area 19 are to—

- Provide for rural-residential living;
- Conserve remnant vegetation; and
- Manage all development so as to minimise any nutrient export from the land.

**3.0 LAND USE**

3.1 Within Special Rural Area No 19 the following uses are permitted—

- Residential Dwelling House
- Livestock Grazing

3.2 The following uses may be permitted subject to the special approval of Council—

- Home Occupation
- Public Utility
- Cottage Industry
- Other incidental or non defined activities considered appropriate by Council which are consistent with the objective of the zone.

#### 4.0 KEEPING OF LIVESTOCK/ANIMALS

4.1 Intensive agricultural pursuits such as piggeries and horticultural operations are not permitted. The keeping of livestock shall be restricted to fenced areas of existing pasture. The lot owner shall be responsible for the erection and maintenance of stock proof fencing sufficient to protect remnant vegetation and tree/shrub planting areas. Animal numbers shall not exceed the stocking rates recommended by Agriculture W.A. The keeping of animals shall not result in the removal or damage of vegetation and trees or result in soil degradation and dust nuisance.

4.2 Where in the opinion of Council the continued presence of animals on any portion of land is likely to contribute, or is contributing to dust nuisance or soil degradation, notice may be served on the owner of the land, requiring immediate removal of those animals specified in the notice.

4.3 Where notice has been served on a landowner in accordance with this Clause the Council may also require the land to be rehabilitated to its satisfaction within three (3) months of serving the notice.

4.4 In the event that such action is not undertaken, Council may carry out such works as are deemed necessary, with all costs being borne by the landowner.

#### 5.0 LOCATION OF BUILDINGS AND STRUCTURES

5.1 Buildings, and all other structures are not permitted within the Development Exclusion Area designated on the Subdivision Guide Plan.

5.2 Buildings and structures shall be setback a minimum of 30 metres from the lot boundary abutting Rocky Crossing Road and 15 metres from all other lot boundaries.

5.3 Buildings shall be sited to allow a low fuel area not less than 20 metres wide.

5.4 All dams require the approval of Council prior to construction. Dams shall be sited to avoid visual impact from Rocky Crossing Road to the satisfaction of Council.

#### 6.0 BUILDING DESIGN, MATERIALS & COLOUR

6.1 Dwellings and outbuildings shall be designed and constructed of materials which allow them to blend into the landscape of the site. Council will be supportive of walls and roofs with natural tonings in keeping with the amenity of the area. Council shall refuse to approve walls and roofs constructed of reflective materials such as unpainted zincalume and off-white colours.

6.2 Dwelling houses shall not exceed 7.5 metres in height which is measured vertically from the natural ground level. The maximum height of all outbuildings will be at the discretion of Council in order to minimise the visual impacts of such buildings when viewed from Rocky Crossing Road.

6.3 No boundary fencing shall be constructed of fibre cement, metal sheeting or wooden picket. If boundary fencing is utilised, it shall be of rural construction such as post and strand to the satisfaction of Council.

6.4 Water tanks shall be painted or coloured an appropriate shade of brown or green or shall be suitably screened with vegetation to the satisfaction of Council.

#### 7.0 VEGETATION PROTECTION & TREE/SHRUB PLANTING

7.1 No clearing of vegetation shall occur except for—

- (i) clearing to comply with the requirements of the Bush Fires Act 1954 (as amended);
- (ii) clearing as may reasonably be required to construct an approved building and curtilage;
- (iii) trees which are dead, diseased or dangerous;
- (iv) clearing required to establish a low fuel area;
- (v) clearing to gain vehicular access to an approved dwelling or any other clearing which may be approved by the Council.

7.2 Additional tree/shrub planting may be required as a condition of development approval.

7.3 Clearing of remnant vegetation for internal boundary fencing is not permitted. Internal boundary fencing is to be of a type that does not require clearing of remnant vegetation.

#### 8.0 WATER SUPPLY

Each dwelling shall be provided with a potable water supply with a minimum capacity of 92 000 litres. This may be supplied from underground supplies or a rainwater storage system to the satisfaction of Council and the Health Department of WA.

#### 9.0 EFFLUENT DISPOSAL

9.1 On-site effluent disposal shall be the responsibility of the individual landowners.

9.2 The disposal of liquid and/or solid wastes shall be carried out with an effluent disposal system approved by Council and the Health Department of WA. Systems shall be designed and located to minimise nutrient export and/or release into any waterway or ground water. Conventional effluent disposal areas for new dwellings shall be situated 2 metres above the highest known ground water level.

9.3 Council shall require the use of amended soil type effluent disposal systems, such as Ecomax/ATU Systems in the following situations—

- where a 2 metre vertical separation to the highest known groundwater level cannot be achieved;
- where a 100 metre horizontal separation from a creek line or water course cannot be achieved;
- where soil conditions are not conducive to the retention of nutrients; and
- in low lying areas.

Separations from waterways and ground water shall be determined by Council in accordance with the Health Department of WA and Department of Environmental Protection guidelines.

9.4 No more than one effluent disposal system will be permitted per lot.

#### 10.0 BUSHFIRE SAFETY

10.1 Low fuel areas, at least 20 metres wide shall be established and maintained around all buildings.

10.2 The subdivider shall make arrangements to the satisfaction of Council to ensure prospective purchasers are aware of the fire management guidelines of the Homeowners Bushfire Survival Manual and the Australian Standard 3959 "Construction of Buildings in Bushfire Prone Areas."

10.3 Any internal firebreaks are to use existing tracks around remnant vegetation.

#### 11.0 NOTIFICATION OF PROSPECTIVE PURCHASERS

11.1 Provision shall be made to Council's satisfaction to ensure prospective purchasers of land with Special Rural Zone Area No. 19 are given a copy of these Special Provisions prior to entering into an agreement to acquire any property.

11.2 Application for Planning Scheme Consent shall require the submission of—

- (i) a completed "Application for Grant of Planning Scheme Consent" form;
- (ii) three copies of a Plan showing the precise location and size of all the buildings proposed and the parkland clearing and fire protection measures to be adopted;
