Conservation and Land Management Act 1984

Public Firewood Areas Order 2002

Made by the Executive Director under regulation 98 of the *Forest Management Regulations 1993*.

1. Citation

This order may be cited as the *Public Firewood Areas Order 2002*.

2. Interpretation

- (1) References in this order to CALMAPS are to maps produced by the Department of Conservation and Land Management.
- (2) Copies of the maps are available for inspection by the public during normal office hours at the places referred to in clause 4.

3. Public firewood areas

- (1) The areas of State forest named in column 1 and described in column 3 of Schedule 1 are set aside for the purposes of the collection of firewood by members of the public.
- (2) The areas set aside under subclause (1) are delineated on the relevant CALMAPS referred to in column 2 of Schedule 1.
- (3) Regulation 100 of the *Forest Management Regulations 1993* applies to the areas described in Schedule 1.

4. Inspection of CALMAPS

A CALMAP referred to in Schedule 1 may be inspected at the following Department of Conservation and Land Management offices —

2. **The *Settlement Agents' Code of Conduct 1982* amended**

Rule 8(3) of the *Settlement Agents' Code of Conduct 1982** is deleted and the following subrule is inserted instead —

“

(3) In this rule —

“**substantial shareholder**” means a person who has a substantial holding, as defined in section 9 of the *Corporations Act 2001* of the Commonwealth, in a body corporate, as if the percentage in paragraph (a) of that definition were 20% rather than 5%.

”

(ABOLITION OF STATE FOREST) ORDER (No. 1) 2002**

Made by the Governor in Executive Council under section 9(2) of the *Conservation and Land Management Act 1984*.

1. Citation

This order may be cited as the *Conservation and Land Management (Abolition of State Forest) Order (No. 1) 2002*.

2. Background to this order

- (i) Under section 9(2) of the Act, a proposal that an area of about 12.3 hectares situated approximately 3 kilometres west of Wanneroo be revoked from State forest No. 69 was laid before the Legislative Assembly on 6 May 1999 and before the Legislative Council on 27 May 1999.
- (ii) Resolutions that the proposal referred to in subclause (i) be carried out were passed by the Legislative Assembly on 13 May 1999 and by the Legislative Council on 1 July 1999.
- (iii) Portions of the area referred to in subclause (i) were excised from State forest No. 69 by orders published in the Government Gazettes of 26 October 1999 and 28 April 2000.
- (iv) It is now proposed to revoke the dedication of the balance of the area involved.

3. Remnant of State forest No. 69 abolished

The land described in Schedule 1 is declared to be no longer State forest No. 69.

DETERMINATION OF STANDARD RATES OF INTEREST

Department of Housing and Works
(The State Housing Commission),
Perth May 2002.

Pursuant to Sections 33 and 42 being loans under Section 36 of the Housing Act 1980, The State Housing Commission by this determination which was approved by the Honourable Minister for Housing and Works fixes the following maximum standard rates of interest to apply in respect of the various classes of loan granted by it—

1. Keystart Loans, Income Based Loans, Shared Equity (Real Start), pre 1985 Variable Interest Schemes and Wisechoice under Sections 33 and 36 to 6.24% per annum.
2. In respect of Shared Equity 1994 (Aboriginal—Subsidised Rate) Loans the initial rate of interest shall be 6.5% per annum for the first year. After this period the rate will be increased by 0.5% per annum on every June 30 subsequent to the date from which interest is to be calculated until the rate of interest is 6.24% per annum.
3. In respect of Shared Equity 1994 (Access—Subsidised Rate) Loans the initial rate of interest shall be 6.5% per annum for the first year. After this period the rate will be increased by 0.5% per annum on every June 30 subsequent to the date from which interest is to be calculated until the rate of interest is 6.24% per annum.
4. In respect of Shared Equity 1997 (Goodstart—Subsidised Rate) Loans the standard rate of interest shall be 6.5% fixed per annum, until the borrower's income exceeds Homeswest maximum rental income eligibility limits. The rate will then move to the Commonwealth Bank standard home loan variable interest rate subject a minimum interest rate of 6.5% per annum.

This determination shall take effect from 1 June 2002.
