### LOCAL GOVERNMENT ACT 1995

*Shire of Irwin*

#### LOCAL LAWS RELATING TO FENCING

Under the powers conferred by the Local Government Act 1995 and under all other powers enabling it, the Council of the Shire of Irwin resolved on 13 August 2002 to make the following local law.

#### Citation

1. These Local Laws may be cited as the “Shire of Irwin Local Laws Relating to Fencing.”

#### Incorporation by Reference

2. (i) In these Local Laws, “The Shire of Capel Local Laws Relating to Fencing”—
- (a) means the Shire of Capel Local Laws Relating to Fencing published in the *Government Gazette*, special edition number 130, on 4th July 2001, and
  - (b) does not include any amendments that might be made to those Local laws.
- (ii) Subject to modifications set out in the Schedule, the Shire of Capel Local Laws Relating to Fencing are incorporated with and form part of these Local Laws.

#### Repeal

3. The Local Laws Relating to Fencing adopted by the Shire of Irwin on 21st December 1993 and published in the *Government Gazette* on 9th December 1994 are repealed.

The mesh fencing is to be a minimum of 700mm high.

**Rail Freight System (Corridor Land)

**1. Citation**

This order may be cited as the *Rail Freight System (Corridor Land) Rectification Order 2002*.

**2. Commencement**

This order has effect from the time when the *Rail Freight System (Corridor Land) Order 2000* had effect but, to the extent that it has effect before the day of its publication in the *Gazette*, its operation is limited by section 39(4) of the Act.

**3. Definition**

In this order —

“**Railway Identification Plans**” has the same meaning as it has in the *Rail Freight System (Corridor Land) Order 2000*.

**4. Errors corrected**

- (1) For the purposes of identifying, by clause 4 of the *Rail Freight System (Corridor Land) Order 2000*, the land that is designated as corridor land (in Schedule 1 called “**the corridor**”), the Railway Identification Plans are to be regarded as having been corrected as described in Schedule 1.

- (2) A reference in Schedule 1 to a particular distance at which the corridor is amended refers to that distance, approximately, from the start of the section of line concerned, unless in the context it is clear that something else is intended.

#### SALARIES AND ALLOWANCES TRIBUNAL

##### Determination Variation

The Tribunal has today issued a Report under section 7 of the *Salaries and Allowances Act 1975* to the Minister recommending an increase of 3.3 per cent in the remuneration to be paid effective from 1 January 2003 to Judges of the Supreme Court, Masters of the Supreme Court, Judges of the District Court, Stipendiary Magistrates and members of the Anti-Corruption Commission.

Consistent with past determinations, it is appropriate to determine the remuneration of other office-holders under the Tribunal's jurisdiction, which has generally been adjusted at the time of a recommendation made under section 7.

This determination makes no reference to the Commissioners of the Western Australian Industrial Relations Commission, whose offices have recently been placed for remuneration purposes under the jurisdiction of the Tribunal. It is understood that until the Tribunal makes its first determination with respect to these offices, remuneration will be adjusted in accordance with the previous statutory provisions dealing with the matter. Accordingly, the 3.3 per cent increase recommended in the Report made under section 7 will flow through to the Commissioners. The Tribunal intends to make specific recommendations with respect to the Commissioners following further consideration, particularly in the light of possible changes made to judicial remuneration at the Federal level.

The determination of the Salaries and Allowances Tribunal made on 19 April 2002 under section 6(1)(c), (d) and (e) of the Salaries and Allowances Act 1975 is hereby varied by a further determination, to make the amendments set out below—

**ROAD TRAFFIC ACT 1974****ROAD TRAFFIC (VEHICLE STANDARDS) REGULATIONS 2002****NOTICE OF EXEMPTION FROM THE REQUIREMENT TO FIT AN IMMOBILISER**

Pursuant to regulation 41 of the *Road Traffic (Vehicle Standards) Regulations 2002* ("the Regulations") I, Greg Martin, Chief Executive Officer of the Department for Planning and Infrastructure and the Director General for the purposes of the Regulations, do hereby exempt the following vehicles from Rule 176 of the *Road Traffic (Vehicle Standards) Rules 2002*—

- any motor wagon, other than a vehicle that is, or has been previously licensed or registered under the *Road Traffic Act 1974* or any corresponding law of any State or Territory of the Commonwealth of Australia, and not being a demonstration vehicle as defined in section 5 of the *Motor Vehicle Dealers Act 1973*.
- a vehicle owned by the Western Australian Police Service when being used by a police officer in the course of his duties, including when that vehicle is stationary;
- a vehicle of a fire brigade on official duty in consequence of a fire or an alarm of fire, or of an emergency or rescue operation where human life is reasonably considered to be in danger;
- an ambulance, when being used as such;

- a vehicle being used to obtain or convey blood or other supplies, drugs or equipment for a person urgently requiring treatment and duly authorised to carry a siren or bell for use as a warning instrument; and
- a vehicle duly authorised as an emergency vehicle by the Director General.

NOTICE OF EXEMPTION—TRAILER BRAKING SYSTEMS

This exemption applies only whilst the trailer is used in conformity with any restrictions or conditions specified in the licence or authorisation.
