**Real Estate and Business Agents (General)
Amendment Regulations 2003**

Made by the Governor in Executive Council.

1. Citation

These regulations may be cited as the *Real Estate and Business Agents (General) Amendment Regulations 2003*.

2. The regulations amended

The amendments in these regulations are to the *Real Estate and Business Agents (General) Regulations 1979**.

[* Reprinted as at 8 March 2002.]

3. Regulation 2 amended

Regulation 2 is amended as follows:

- (a) by deleting the definition of “Ministry”;
- (b) by inserting in the appropriate alphabetical position the following definition —

“

“**registered training provider**” has the same meaning as in section 5(1) of the *Vocational Education and Training Act 1996*;

”.

4. Regulation 6 replaced and savings provision

- (1) Regulation 6 is repealed and the following regulation is inserted instead —

“

6. Prescribed examinations

The prescribed examinations for the purposes of clause 1(a) of the Schedule to the Act are —

- (a) the examinations which are required by a registered training provider to be passed for a Diploma of Property (Real Estate), together with the examinations conducted by a registered training provider in the following courses —

- (i) Unit 15826 — Rural Sales;
- (ii) Unit 15825 — Selling Businesses; and
- (iii) Unit 15892 — Real Estate Law;

or

- (b) the examinations required to be passed for the conferring of a Bachelor of Commerce (Property and Marketing) or a Bachelor of Commerce (Property) by the Curtin University of Technology.

”.

- (2) Despite the amendments effected by subregulation (1), examinations referred to in a provision of the *Real Estate and Business Agents (General) Regulations 1979* referred to in column 1 of the Table to this subregulation, as in force immediately before the commencement of these regulations, continue to be prescribed examinations for the purposes of

clause 1(a) of the Schedule to the Act until the date specified in column 2 of that Table opposite the reference to the provision.

5. Regulation 6A replaced and savings provision

- (1) Regulation 6A is repealed and the following regulation is inserted instead —

“

6A. Prescribed qualifications for sales representatives

The prescribed qualifications for the purposes of section 47(2) of the Act are the successful completion of —

- (a) the TAFE Sales Representatives Registration Course provided by a registered training provider;
- (b) the REIWA Sales Representatives Registration Course provided by the Real Estate Institute of Western Australia Incorporated; or
- (c) both —
 - (i) Real Estate Business 305; and
 - (ii) Property Management 330, provided by the Curtin University of Technology.

”

- (2) Despite the amendment effected by subregulation (1), the qualification referred to in regulation 6A(c) of the *Real Estate and Business Agents (General) Regulations 1979*, as in force immediately before the commencement of these regulations, continues to be a prescribed qualification for the purposes of section 47(2) of the Act in respect of an application for registration as a real estate and business sales representative made under the Act on or before 1 January 2004.

6. Regulation 6B amended

Regulation 6B is amended as follows:

- (a) by deleting paragraph (a) and inserting the following paragraph instead —

“

- (a) who applies within one year of successfully completing a qualification prescribed in regulation 6A;

- (b) in paragraph (b) by deleting “his” and inserting instead —

DOG ACT 1976

Shire of Jerramungup

DOGS LOCAL LAW

Under the powers conferred by the *Dog Act 1976* and under all other powers enabling it, the Council of the Shire of Jerramungup resolved on 20 November 2002 to make the following local law.

The Shire of Moora Dogs Local Law as published in the *Government Gazette* of 29 November 1999, is adopted as a local law of the Shire of Jerramungup with the modifications which follow—

1. Preliminary

Whenever the Shire of Moora is mentioned in the local law substitute “Shire of Jerramungup”.

2. Clause 1.2—Repeal

Delete Clause 1.2 and substitute—

“1.2 The Gnowangerup Road Board Dog Act 1903-1928 By-law published in the *Government Gazette* on 13 December 1929; Shire of Gnowangerup By-law of the control of Dogs published in the *Government Gazette* on 7 February 1963; and the Shire of Jerramungup By-laws Relating to Dogs published in the *Government Gazette* on 4 March 1988, applicable to the Shire of Jerramungup, are repealed.”

3. Clause 3.2—Limitation on the number of dogs

Delete Paragraph (2) and substitute—

- “(i) The limit on the number of dogs, which may be kept on any premises outside a townsite, is, for the purpose of section 26(4) of the Act, 6 dogs over the age of 3 months and the young of those dogs under that age; and
- (ii) The limit on the number of dogs, which may be kept on any premises located within a townsite, is, for the purpose of section 26(4) of the Act, 2 dogs over the age of 3 months and the young of those dogs under that age.”

4. Clause 5.1—Places where dogs are prohibited absolutely

In Clause 5.1(1)—delete paragraphs (i), (ii), and (iii) and substitute—

- “(i) John Cove, south of Wellstead Estuary;
- (ii) All parks within the Bremer Bay townsite, unless listed under clause 5.2 (1);
- (iii) Little Boat Harbour Beach;
- (iv) Sports grounds located at Bremer Bay, Boxwood Hill, Gairdner and Jerramungup; and
- (v) All parks within the Jerramungup townsite, unless listed under 5.2 (1).”

5. Clause 5.2—Places which are dog exercise areas

In Clause 5.2 (1)—delete paragraphs (a), (b), and (c) and substitute—

- “(a) Bremer Bay Golf course, part of Reserve 511;
- (b) Back Beach, Bremer Bay;
- (c) Bremer Beach, north of Wellstead Estuary; and
- (d) Jerramungup Golf Course, part of Reserve 28169.”

AMENDMENTS TO THE PERTH PARKING LOCAL LAW 1999

Under the power conferred by the Local Government Act 1995 and under all other powers enabling it, the Council of the City of Perth resolved on 26 November 2002 to make the following amendments to the Perth Parking Local Law 1999.

CLAUSE 1.4 IS AMENDED AS FOLLOWS:

- 1.1.1 the following definitions are inserted at the appropriate alphabetical position;
 - 1.1.1.1 “bicycle crossing” means a portion of a carriageway near each end of which may be erected, on each side of the carriageway, bicycle crossing lights;
 - 1.1.1.2 “charter bus zone” means a parking bay designated for use by a charter bus;
 - “public bus zone” means a parking bay designated for use by a public bus;
 - 1.1.1.4 “T-Intersection” means an intersection where the end of a road intersects with the continuous side of a continuing road;
 - 1.1.1.5 “unattended” means the driver has left the vehicle so that the driver is more than 3 metres from the closest point of the vehicle.
- 1.1.2 the definition of “commercial vehicle” is deleted and the following is inserted;
 - 1.1.2.1 “commercial vehicle” means a motor vehicle constructed, equipped or fitted principally for the conveyance of goods or merchandise but does not include a delivery vehicle;
- 1.1.3 the definition of “park” is amended as follows;
 - 1.1.3.1 delete after “whether attended or” the word “not” and substitute “unattended.”
 - 1.1.3.2 insert at paragraph (c) after “persons or goods” the words “within 2 minutes of the vehicle becoming stationary;”
- 1.1.4 the definition of “parking station” is amended by deleting the following:—
 - 1.1.4.1 “a metered zone,”

1.2 CLAUSE 2.3 IS AMENDED AS FOLLOWS:

1.2.1 at the beginning of subclause (2)(e) the following is inserted;
“in”

1.2.2 at the beginning of subclause (2)(f) the following is inserted;
“in”

1.2.3 at the beginning of subclause (2)(g) the following is inserted;
“in”

1.2.4 at the beginning of subclause (2)(h) the following is inserted;
“in”

1.2.5 the following subclauses are re-numbered as follows:—

1.2.5.1 at subclause (3) the “3” is deleted and “4” inserted;

1.2.5.2 at subclause (4) the “4” is deleted and “5” inserted;

1.2.5.3 at subclause (5) the “5” is deleted and “6” inserted;

1.2.5.4 at subclause (6) the “6” is deleted and “7” inserted;

1.2.5.5 at subclause (7) the “7” is deleted and “8” inserted.

1.2.6 after clause 2.3(2) the following is inserted:—

1.2.6.1 “(3) a person must not park a vehicle in a no parking area.”

1.3 CLAUSE 3.4(3)(D) IS DELETED AND THE FOLLOWING IS INSERTED:

1.3.1 (d) on a carriageway within 20 metres from the nearest point of an intersecting carriageway at an intersection with traffic-control signals, unless the vehicle stops or parks at a place on a length of carriageway, or in an area, to which a parking control sign applies and the vehicle is permitted to stop or park at that place under this Local Law; or

(da) on a carriageway so that any portion of the vehicle is within 10 metres of the prolongation of the nearest edge of any intersecting carriageway without traffic-control signals, intersecting that carriageway on the side on which the vehicle is stopped or parked unless the vehicle stops or parks;

(i) at a place on a carriageway, or in an area, to which a parking control sign applies and the vehicle is permitted to stop or park at that place under this Local Law; or

(ii) if the intersection is a T-intersection along the continuous side of the continuing road at the intersection;”

1.4 CLAUSE 4.4 IS AMENDED AS FOLLOWS:

1.4.1 where it appears in clause 4.4 “space” is deleted and “zone” is inserted.

1.5 CLAUSE 10 IS AMENDED AS FOLLOWS:

1.5.1 at the beginning of clause 10.3(1) insert:—

1.5.1.1 “Subject to subclauses 10.3(3) and (4),”

1.5.2 after clause 10.3(3) the following clause is inserted:—

1.5.2.1 “(4) Where the time period within which a person may stop or park a vehicle on a road is controlled by a sign and a person commits an offence under this Local Law by stopping or parking a vehicle for a time period which exceeds that shown on the sign—

(a) the amount of the modified penalty shall be the amount referred to in clause 10.3(2) where the time period during which the vehicle was stopped or parked in excess of the time period shown on the sign was not greater than that shown on the sign; and

(b) the amount of the modified penalty shall again be payable in respect of each successive time period during which the vehicle continues to be parked or stopped in excess of the time period shown on the sign.”

1.6 SCHEDULE 1 IS AMENDED:

1.6.1 in Schedule 1, Notice of Offence and Infringement Notice;

1.6.1.1 in footnote (7), “Name and title” is deleted and “Title” is ; inserted; and

1.6.1.2 In footnote (8) the words “of the authorised officer giving the notice” are inserted after the word “signature”.

1.7 SCHEDULE 3 IS AMENDED AS FOLLOWS:—

1.7.1 in Item Penalty No 2, “2.3(3);” and “2.3(6) is deleted and “2.3(5);” and “2.3(8);” are inserted.

1.7.2 in Item Penalty No 2 at the appropriate numerical position “3.4(3)(a); 3.4(3)(b); 3.4(3)(c);” are inserted.

1.7.3 in Item Penalty No 2, “6.6(1);” is deleted.

1.7.4 in Item Penalty No 3, “3.4(3)(a); 3.4(3)(b); 3.4(3)(c);” are deleted.

1.7.5 in Item Penalty No 4, “2.3(5);” is deleted and “2.3(3);” is inserted.

1.8 SCHEDULE 4 IS AMENDED AS FOLLOWS:

1.8.1 after "Additional days storage fee or part thereof¹³" the following is inserted;

1.8.1.1 "If your vehicle is not collected within two (2) months after the date of this notice the City may either;

- (a) under section 3.46 of the local Government Act 1995 refuse to allow the vehicle to be collected until the City's costs of removing and keeping the vehicle have been paid to the City; or
- (b) under section 3.47 of the Local Government Act 1995 sell or otherwise dispose of the vehicle and credit the money received from that sale or disposal to the City's trust fund except to the extent required to meet the cost and expenses incurred by the City in the removing, impounding and selling of the vehicle.

If you are convicted of an offence against this Local Law the section 3.48 of the Local Government Act 1995 allows the City to recover from you its outstanding expenses incurred in the removing, impounding and selling of the vehicle."
