Veterinary Surgeons Act 1960

### Veterinary Surgeons Amendment Regulations 2003

Made by the Governor in Executive Council.

#### 1. Citation

These regulations may be cited as the *Veterinary Surgeons Amendment Regulations 2003*.

#### 2. The regulations amended

The amendments in these regulations are to the *Veterinary Surgeons Regulations 1979\**.

#### 3. Regulation 60 amended

Regulation 60 is amended as follows:

- (a) at the end of subregulation (1)(m) by deleting the full stop and inserting a semicolon instead;
- (b) after subregulation (1)(m) by inserting the following paragraph —

“

- (n) perform vivisection and other experiments or operations on animals including, where necessary, the giving of an anaesthetic, where the person is authorised to do so under the *Animal Welfare Act 2002* and does so in accordance with any conditions imposed under that Act.

”.

Community Services Act 1972

**Community Services (Child Death Review  
Committee) Order 2003**

Made by the Governor in Executive Council under section 22 of the Act.

**1. Citation**

This order may be cited as the *Community Services (Child Death Review Committee) Order 2003*.

**2. Commencement**

This order comes into operation on the day on which it is published in the *Gazette*.

**3. Definitions**

In this order unless the contrary intention appears —

“**child**” means a person under 18 years of age who, in accordance with criteria approved by the Minister, is taken to be a child known to the Department;

“**Committee**” means the Child Death Review Committee established by clause 4;

“**Department**” has the same meaning as it has in the Act;

“**Director-General**” has the same meaning as it has in the Act;

“**meeting**” means a meeting of the Committee;

“**member**” means a member of the Committee.

**4. Child Death Review Committee established**

A committee called the Child Death Review Committee is established.

**5. Objects**

The general objects of the Committee are —

- (a) to assist the Director-General and the Department in bringing about the provision of quality services to vulnerable children and their families; and

- (b) to facilitate accountability in relation to the operations of the Department through the provision of an additional quality assurance mechanism in particular cases where children have died.

## **6. Functions**

- (1) The functions of the Committee are —
  - (a) at the request of the Minister or the Director-General, to carry out a review of the operation of relevant policies, procedures and organisational systems of the Department in circumstances where a child has died;
  - (b) on completion of the review to prepare a written report setting out —
    - (i) advice or comments on the operation of the policies, procedures and systems referred to in paragraph (a); and
    - (ii) recommendations (if any) for the improvement or modification of those policies, procedures and systems,and to give the report to the Minister and the Director-General;
  - (c) to identify particular classes of child deaths or related issues that may benefit from further investigation or research; and
  - (d) to perform such other functions in relation to child deaths as the Minister directs.
- (2) The Committee may do all things necessary or convenient to be done in the performance of its functions.

## **7. Membership**

- (1) The Committee is to consist of not less than 3 members appointed by the Minister.
- (2) Each member appointed under subclause (1) is to be a person who, in the opinion of the Minister, has qualifications, skills or experience relevant to the functions of the Committee.
- (3) A person is not eligible for appointment under subclause (1) if the person is an officer of the Department.

## **8. Chairperson**

The Minister is to appoint one of the members to be the chairperson of the Committee.

## **9. Term of office**

- (1) The term for which a person is appointed to be a member of the Committee is to be fixed in the instrument of appointment and is to be not longer than 2 years.

- (2) The Minister may in writing extend the term fixed under subclause (1) for a further period not longer than one year.
- (3) A person's eligibility for reappointment is not affected by an earlier appointment.

**10. Meetings**

- (1) The chairperson is to preside at all meetings at which the chairperson is present.
- (2) If the chairperson is absent from a meeting the members present are to appoint one of their number to preside.

**11. General procedure**

The procedure for the calling of meetings and for the conduct of business at meetings is, except as otherwise stated in this order or in a regulation referred to in clause 14, to be determined by the Committee.

**12. Protection from liability**

An action in tort does not lie against a member for anything that the member has done or omitted to do, in good faith, in the performance or purported performance of a function under this order.

**13. Annual report**

- (1) The Committee, as soon as practicable after 1 July in each year, is to prepare and give to the Minister a report on its operations and proceedings for the year ending on the preceding 30 June.
- (2) The Committee is to give a copy of the report to the Director-General.
- (3) The Minister is to cause the report to be made publicly available in any manner that the Minister considers appropriate.
- (4) For the purposes of subclause (1) the period beginning on the day on which this order comes into operation and ending on 30 June 2003 is to be regarded as a year.

**14. Application of certain regulations**

Regulations 7, 18 and 21 of the *Community Welfare Organizations Regulations 1980* apply to the Committee.

### Legal Practice Board Amendment Rules 2003

Made under section 6 by The Legal Practice Board.

**1. Citation**

These rules may be cited as the *Legal Practice Board Amendment Rules 2003*.

**2. The rules amended**

The amendments in these rules are to the *Legal Practice Board Rules 1949\**.

**3. Rule 13 amended**

Rule 13 is amended by deleting “Meetings” and inserting instead —

“ Subject to rule 13A, meetings ”.

**4. Rule 13A inserted**

After rule 13 the following rule is inserted —

“

**13A. Urgent convening of meetings**

If at a meeting of a Committee of the Board at which not less than 4 members of the Board are present the Committee has a bona fide belief that the urgency of the situation requires an immediate decision of the Board, that Committee may immediately sit as the Board for the purposes of making that decision.

”.

**5. Rule 97A inserted**

After rule 97 the following rule is inserted —

“

**97A. Electronic transfer of funds**

- (1) An electronic transfer of funds in a trust account by a practitioner shall be effected by —
  - (a) the practitioner;
  - (b) a partner of the practitioner; or
  - (c) 2 persons authorised by the practitioner in writing to effect an electronic transfer of the funds from the trust account concerned.
- (2) The practitioner must ensure that the following particulars are kept in relation to each transfer effected under subrule (1) —
  - (a) the name of the practitioner or partner who effected the transfer or, if the transfer was effected by 2 persons authorised in writing, the names of those persons;



- (b) details identifying the trust ledger account from which the funds were transferred and the name of the person on whose behalf the funds were transferred;
- (c) brief particulars of the subject matter and the purpose for which the funds were transferred;
- (d) a number or other means of identification of the transfer by reference to a numerical sequence of payments from the trust account concerned;
- (e) the name or type of the bank account to which the funds were paid, its number and the identifying numbers of the receiving bank and its branch;
- (f) the date of the transfer and the amount transferred.

”

**1. Citation**

This instrument may be cited as the *Western Australian Reproductive Technology Council (Appointment of Members and Deputies) Instrument 2003*.

**2. Interpretation**

In this instrument—

“table” means a table in the schedule to this instrument; and

“the Act” means the *Human Reproductive Technology Act 1991 (WA)*; and

“the Council” means the Western Australian Reproductive Technology Council established under section 8(1) of the Act.

**3. Appointment of Members**

Each of the persons named in column 2 of the table are appointed as members of the Council, pursuant to the provision of the Act specified in column 1 of the table adjacent to the name of that person, for a period as shown in column 4.

**4. Appointment of Deputies**
