East Perth Redevelopment Act 1991

East Perth Redevelopment (Extension of Redevelopment Area) Regulations 2003

Made by the Governor in Executive Council under sections 4 and 57 of the Act, following consultation between the Minister and the community, the Town of Vincent, and the City of Perth.

1. Citation

These regulations may be cited as the *East Perth Redevelopment (Extension of Redevelopment Area) Regulations 2003*.

2. The Act amended

The amendments in these regulations are to the *East Perth Redevelopment Act 1991*.*

3. Schedule 1 amended

Schedule 1 is amended as follows:

(a) after “defining the redevelopment area” by inserting —

“

, together with an additional area described as “the extension of the redevelopment area” in a supplementary Plan (also held at the office of the Authority), that Plan being certified by the Minister as being “the plan prepared for the purpose of defining the extension of the redevelopment area”.

(b) after “For guidance, the redevelopment area” by inserting —

“

(without the additional area described in the previous paragraph)

(c) after “representation of Plan No. 2.” by inserting —

“

For further guidance, the additional area that is the extension to the redevelopment area may be described as the land bounded by a line —

- (a) starting at the north-east corner of Newcastle street and William street and extending in a north-westerly direction along the eastern boundary of William street for a distance of approximately 50.3 m to the north-west corner of Lot 77;
- (b) then in a south-easterly direction for approximately 41 m to the north-east corner of Lot 77;
- (c) then in a north-easterly direction for approximately 12.3 m to the north-east corner of Lot 100;
- (d) then in a south-easterly direction for approximately 40.4 m to the north-east corner of Lot 3, and intersecting with boundary of the redevelopment area set out in Plan No. 2;
- (e) then following the boundary of the redevelopment area back to the starting point,

so as to comprise Lots 1(A), 2(A), 3, 4, 28, 77, 78, 79, 80, 81, 82, 83(A) and 83(B), and a passageway between Lots 1(A) and 2(A).

City of Mandurah

HEALTH AMENDMENT LOCAL LAWS 2003

Made by the Council of the City of Mandurah under section 342 of the *Health Act 1911* in accordance with subdivision 2 of Part 3 of the *Local Government Act 1995*.

Citation

1. These local laws may be cited as the *City of Mandurah Health Amendment Local Laws 2003*.

Principal local laws

2. In these local laws, the *City of Mandurah Health Local Laws 1996* made under the *Health Act 1911* and passed by the Council of the City of Mandurah on 12 December 1995, and published in the *Government Gazette* on 23 August 1996, are referred to as the principal local laws.

Principal local laws amended

3. The principal local laws are amended as described in the following schedule—

The whole of the district of the City of Mandurah is prescribed for the purposes of section 112A(1) of the Act as an area which no person shall remove any house or trade refuse or other rubbish from premises unless authorised by the Council to do so." |
| 3 | 49 | Delete sub-clause 49(1)(b) and rename sub-clause 49(1)(c) to read as 49(1)(b). |

AGRICULTURE AND RELATED RESOURCES PROTECTION ACT 1976

Agriculture Protection Board,
South Perth 23 September 2003.

Pursuant to Section 37 of the *Agriculture and Related Resources Protection Act, 1976*, the Agriculture Protection Board hereby lists the classes of plants that are for the time being the subject of a declaration made under Section 35 of that Act, together with the matters specified pursuant to Subsection (2) of that Section in relation to each class—

Declared Plants

Aquarium Plants (plants of any class used or grown in aquariums unless they are plants that are on premises for the time being accredited by the Chief Agriculture Protection Officer as premises free from any snails capable of acting as intermediate hosts for the fluke *Fasciola hepatica*, or are in the course of being moved from such premises.);

P1; for the whole of the State.

Aquatic Weeds—

Alligator weed (*Alternanthera philoxeroides*); P1, P2; for the whole of the State.

Arrowhead (*Sagittaria montevidensis*); P1, P2; for the whole of the State.

Salvinia (*Salvinia molesta*); P1, P2; for the whole of the State.

Senegal tea (*Gymnocoronis spilanthoides*); P1, P2; for the whole of the State.

Shield pennywort (*Hydrocotyle verticillata*); P1, P2; for the whole of the State.

Water hyacinth (*Eichhornia crassipes*); P1, P2; for the whole of the State.

Water lettuce (*Pistia stratiotes*); P1, P2; for the whole of the State.

Acacias (*Acacia* spp.) all species not native to Australia (except *Acacia farnesiana*);

African rue (*Peganum harmala*);

African thistle (*Berkheya rigida*);

Apple of Sodom (*Solanum linnaeanum*);
