Liquor Licensing Act 1988

Liquor Licensing Amendment Regulations (No. 6) 2003

Made by the Governor in Executive Council.

1. Citation

These regulations may be cited as the *Liquor Licensing Amendment Regulations (No. 6) 2003*.

2. The regulations amended

The amendments in these regulations are to the *Liquor Licensing Regulations 1989**.

3. Regulation 8 amended

(1) Regulation 8(1) is amended as follows:

- (a) at the end of paragraph (j)(vi) by deleting the full stop and inserting a semicolon instead;
- (b) after paragraph (j) by inserting the following paragraph —

“

- (k) the sale or supply of liquor during a special event, if —
 - (i) the liquor is produced as a part of an approved viticulture course by —
 - (I) the W A College of Agriculture at either the Denmark or the Harvey campus;
 - (II) Manjimup Senior High School;
 - (III) Margaret River Senior High School; or
 - (IV) Mount Barker Senior High School;
 - (ii) the liquor is only sold or supplied on campus or school grounds;
 - (iii) the liquor is only sold or supplied by, and to, persons aged 18 years or older; and
 - (iv) the amount of liquor being sold or supplied is limited —
 - (I) in the case of liquor supplied for consumption on the campus or school grounds, to supply of free 30 ml samples for tasting purposes; and
 - (II) in the case of packaged liquor, to provision of no more than 9 litres per person and per transaction.

”

(2) After subregulation (2) the following subregulation is inserted —

“

(3) In subregulation (1)(k) —

“approved viticulture course” means a course that delivers “Units of Competency” from the Food Processing Industry Training Package (Wine Sector) endorsed by the Australian National Training Authority;

“**special event**” means a graduation ceremony, speech night or annual open day that relates to that campus or school, and any other related event approved in writing by the Director.

FORRESTDALE LAKE NATURE RESERVE AND THOMSONS LAKE NATURE RESERVE

Notice of Draft Management Plans

The Conservation Commission of Western Australia advises that the draft management plans for Forrestdale Lake Nature Reserve and Thomsons Lake Nature Reserve are available for public comment.

These reserves are internationally significant Ramsar wetlands, providing an important habitat and refuge for water birds. They are both situated approximately 30 kilometres south of Perth, Forrestdale Lake in the City of Armadale and Thomsons Lake in the City of Cockburn. The draft management plans contain information about the management of the reserves and make recommendations for adoption in the final plans.

All submissions received will be considered in the preparation of a final management plan and analysis of public submissions, and will remain confidential.

CONSERVATION AND LAND MANAGEMENT (ABOLITION OF STATE FOREST) ORDER (NO. 1) 2003

Made by the Governor in Executive Council under section 9(2) of the *Conservation and Land Management Act 1984*.

1. Citation

This order may be cited as the *Conservation and Land Management (Abolition of State Forest) Order (No. 1) 2003*.

2. Background to this order

(1) Under section 9(2) of the Act a proposal that, among other things, a total area of about 5.6 hectares situated approximately 5 kilometres north east of Kirup be revoked from State forest Nos. 29 and 49 was laid before the Legislative Assembly and the Legislative Council in November 2000.

(2) Resolutions that the proposal referred to in subclause (1) be carried out were passed by the Legislative Assembly on 22 November 2000 and by the Legislative Council on 23 November 2000.

(3) The lands referred to in subclause (1) have been surveyed and are now described in Schedules 1 and 2.

3. Portions of State forest Nos. 29 and 42 abolished

The lands described in Schedules 1 and 2 are declared to be no longer State forest.

Notice to all owners or occupiers of land in the district of the City of Joondalup regarding firebreaks.

The City of Joondalup hereby gives notice pursuant to Section 33 of the Bush Fires Act 1954, to all owners, or occupiers of land, in its district that they are required on, or before, the 31 October (annually), or within 14 days of becoming the owner, or occupier of the land, if that occurs after the 31 October (annually) to plough, cultivate, scarify, burn or otherwise clear, firebreaks as specified in this Notice and thereafter, up to and including 31 May (annually) to maintain the firebreaks clear of flammable matter.

1 Land having an area of 2000m² or more—A firebreak not less than 3 metres wide, immediately inside, and around, all external boundaries of the land must be cleared.

2 Land having an area of less than 2000m²—A firebreak, not less than 2 metres wide, immediately inside and around all external boundaries of the land must be cleared.

3 Buildings—A firebreak not less than 3 metres wide immediately around all external walls of every building.

Whenever a firebreak is cleared by burning, the provision of the Act and Regulations made thereunder must be observed.

If pursuant to Item (2) of this Notice, mowing or slashing is carried out, the height of the vegetation thereafter must not exceed, as far as is reasonably practicable, 20mm over the entire area of the firebreak. The use of chemicals is subject to all restrictions imposed by the Department of Agriculture.

Where the land is in the WARRADARGE BUSHFIRE BRIGADE AREA, the firebreak is to be twenty (20) metres wide around scrub areas that is to be burnt.

2. TOWNSITES

Coorow, Leeman and Green Head, all townsite lots must be cleared and kept clear of all accumulation of inflammable materials. (For the purpose of this notice, trees, shrubs and plants in established gardens do not constitute inflammable material).

3. FUEL DUMPS AND/OR DEPOTS
