WEST COAST ROCK LOBSTER FISHERY MANAGEMENT PLAN AMENDMENT (NO. 2) 2004

FD 1064/01 [663]

## Citation

1. This instrument may be cited as the West Coast Rock Lobster Fishery Management Plan Amendment (No. 2) 2004.

# Commencement

2. This instrument commences operation on 31 October 2004.

# Management plan amended

3. The amendments in this instrument are to the West Coast Rock Lobster Management Plan 1993\*.

#### Clause 14F replaced

4. Clause 14F is deleted and the following clause is inserted instead—

## "Temporary transfer of part of an entitlement

14F. (1) Subject to subclause (2), part of an entitlement under a licence may be temporarily transferred to another licence for a period ending at the time the licences expire.

(2) Part of an entitlement under a licence may only be temporarily transferred to another licence where—  $\!\!\!$ 

(a) both licences relate to the same zone of the Fishery; and

(b) the proposed temporary transfer is of a whole number of units of entitlement.".

# LOCAL GOVERNMENT ACT 1995

## District of Esperance

# (CHANGE OF WARD BOUNDARIES AND REPRESENTATION) ORDER 2004

Made by the Governor in Executive Council.

## 1. Citation

This Order may be cited as the District of Esperance (Change of Ward Boundaries and Representation) Order 2004.

#### 2. Abolition of existing wards (s.2.2 (1) (d) of the Act)

The West, East and North Wards of the district of Esperance are abolished immediately before the first ordinary elections day after the commencement of this Order.

#### 3. New ward created (s.2.2 (1) (c) of the Act)

On and after the first ordinary elections day after the commencement of this Order, there shall be a new ward created in the district of Esperance known as the Rural Ward, which consists of the land described in the Schedule.

# 4. Change of name of existing Ward (s.2.3 (3) of the Act)

On and after the first ordinary elections day after the commencement of this Order, the Esperance Ward shall be renamed the Town Ward which consists of the land described in the Schedule.

## 5. Number of councillors for the district changed (s. 2.18 (3) of the Act)

On and after the first ordinary elections day after the commencement of this Order, the number of offices of councillor on the council of the Shire of Esperance is eleven (11) instead of thirteen (13).

# 6. Number of Councillors for Rural and Town Wards (s. 2.18 (3) of the Act)

On and after the first ordinary elections day after the commencement of this Order-

- (a) the number of offices of councillor for the Rural Ward is four (4); and
- (b) the number of offices of councillor for the Town Ward is seven (7).

#### 7. Declaration of vacant offices (s. 2.35 and 9.62 of the Act)

All offices of member of council of the Shire of Esperance become vacant immediately before the first ordinary elections day after the commencement of this Order.

#### 8. Elections and transitional directions (s. 4.11 and 9.62 of the Act)

(1) An election is to be held to fill the offices that become vacant under clause 7.

(2) Any poll needed for an election to fill the offices is to be held on the first ordinary elections day after the commencement of this Order.

(3) Any office of councillor on the council of the Shire of Esperance that is vacant prior to the day of ordinary elections held in 2005 is to remain unfilled until the day of the ordinary elections held in 2005.

(4) Part 4 of the Act applies to preparing for and conducting the elections as if the changes effected by clauses 2, 3, 4, 5, 6 and 7 had taken effect on the day on which this Order commenced.

(5) For the purposes of subclause (3)—

- (a) Part 4 of the Act is modified to the extent necessary to give effect to subclauses (1), (2) and (3); and
- (b) without limiting paragraph (a), a reference in Part 4 of the Act to a ward in relation to the district of Esperance, is to be read as reference to the Town Ward and Rural Ward of the district as the respective ward is or will be, as a result of the operation of clauses 3, 4, 5 and 6 on and after the first ordinary elections day after the commencement of this Order.

boundary of Lot 96, as shown on Deposited Plan 226440; thence northerly and northwesterly along eastern and northeastern boundaries of that lot to a southwestern side of Cherry Well Road; thence generally northwesterly along southwestern sides of that road to a western side of Connolly Street; thence generally northerly along western sides of that street and onwards to the centreline of Pink Lake Road; thence northwesterly along that centreline to the prolongation southerly of the eastern boundary of Esperance Lot 872 (Reserve 39709), as shown on Deposited Plan 187608; thence northerly to and along that boundary and generally northeasterly along southeastern boundaries of the western severance of Lot 691 (Reserve 31300), as shown on Plan 9468 and onwards to the southern boundary of Esperance Location 180, as shown on Deposited Plan 226440; thence easterly and northerly along southern and eastern boundaries of that location to its easternmost northeastern corner; thence northeasterly to the southernmost southwestern corner of Lot 129, as shown on Deposited Plan 226439; thence generally southeasterly, southwesterly and southerly along northeastern, southeastern and eastern sides of Rowse Street to the northern side of Dean Street; thence easterly along that side to a northwestern side of Symons Street; thence generally northeasterly along northwestern sides of that street to a southwestern side of Sims Street; thence generally northwesterly and generally northeasterly along southwestern and northwestern sides of that street to the prolongation northwesterly of the southwestern side of Hancock Road; thence northwesterly along that prolongation to the prolongation southerly of the westernmost western boundary of Lot 17, as shown on Plan 22892; thence northerly to and along that boundary and onwards to the southwestern corner of Lot 15; thence northerly along the western boundary of that lot and onwards to a northern side of Stable Road; thence easterly along that side to the southeastern corner of Lot 1, as shown on Diagram 39749; thence northerly along the eastern boundary of that lot to the southern boundary of the western severance of Lot 7, as shown on Diagram 85289; thence westerly and northerly along the southern and western boundaries of that severance to the southwestern corner of Lot 214, as shown on Deposited Plan 226439; thence northerly along the western boundary of that lot and onwards to the southwestern corner of Lot 282; thence northerly and easterly along western and northern boundaries of that lot and onwards to a northeastern side of Norseman Road; thence generally southeasterly along northeastern sides of that road to a northern side of Stable Road; thence easterly along that side and easterly along a northern side of Frearson Street and onwards to the eastern side of Claire Street; thence southerly along that side and onwards to a southeastern side of Fisheries Road; thence generally northeasterly along southeastern sides of that road to the northeastern corner of Lot 2001, as shown on Deposited Plan 29315; thence southerly along the eastern boundary of that lot and onwards to the northern corner of the northern severance of Lot 134, as shown on Deposited Plan 40414; thence southerly along the eastern boundary of that severance and onwards to a southern side of Daw Drive; thence easterly and generally southeasterly along the southern and southwestern sides of that drive to the northwestern corner of Lot 53, as shown on Diagram 71266; thence generally southeasterly and southwesterly along northeastern and the southeastern boundaries of that lot to the northern boundary of Lot 15, as shown on Deposited Plan 251102; thence easterly along that boundary to a northwestern boundary of Lot 881 (Reserve 39635), as shown on Deposited Plan 217292; thence southwesterly, southeasterly and again southwesterly along boundaries of that lot to the northeastern corner of Lot 1, as shown on Diagram 68919; thence southwesterly and southeasterly along the northwestern and southwestern boundaries of that lot to a northwestern corner of Lot 881 (Reserve 39635); as shown on Deposited Plan 217292; thence southeasterly along a southwestern boundary of that lot to the High Water Mark of Esperance Bay; a point on a present southeastern boundary of the Shire of Esperance, and thence generally northeasterly, generally southeasterly, generally easterly, again generally northeasterly, northerly, westerly, generally northerly, again westerly, southerly, easterly, generally southerly and again generally easterly along boundaries of that shire to the starting point. Including all Islands adjacent to the Shire of Esperance.

# BUSH FIRES ACT 1954 City of Melville FIRE BREAK NOTICE

Notice to all owners and/or occupiers of land situated in the City of Melville.
