#### 1. Citation

These regulations are the *Plant Diseases Amendment Regulations (No. 2) 2005*.

#### 2. The regulations amended

The amendments in these regulations are to the *Plant Diseases Regulations 1989\**.

##### 57. Prevention of Blueberry Rust (*Pucciniastrum vaccinii*)

###### (1) Application

This procedure applies to —

- (a) the potential carriers of the disease Blueberry Rust (*Pucciniastrum vaccinii*) listed in item 2 that have been grown, packed or used within 200 km of a detection of Blueberry Rust; and

- (b) any agricultural equipment that has been used in association with those listed potential carriers.
- (2) Potential carriers of Blueberry Rust
- (a) Plants, parts of plants and dried plant material (other than seed and dried fruit) of —
- (i) *Vaccinium* spp. (Blueberries and Cranberries);
  - (ii) *Gaylussacia* spp. (Huckleberries);
  - (iii) *Tsuga* spp. (Hemlock);
  - (iv) *Rhododendron* spp. (Azalea);
  - (v) *Lyonia* spp.;
  - (vi) *Menziesia* spp.;
  - (vii) *Pernettya* spp.;
  - (viii) *Hugeria* spp.;
  - (ix) *Leucothoe* spp.;
  - (x) *Oxycoccus* spp.; and
  - (xi) *Pieris* spp.,
- are potential carriers of Blueberry Rust;
- (b) Any agricultural equipment that has been used in association with those listed potential carriers is also a potential carrier of Blueberry Rust.

(3) Potential carriers prohibited, subject to conditions

Potential carriers of the disease Blueberry Rust (*Pucciniastrum vaccinii*) listed in subitem (2) that have been grown, packed or used within 200 km of the detection of Blueberry Rust cannot be brought into Western Australia unless they comply with the conditions in subitems (4), (5) and (6).

(4) Conditions — Fruit

Potential carriers comprising fresh fruit may be brought into Western Australia if an officer from the exporting State or Territory's quarantine authority has certified the following in relation to that fruit —

- (a) that the plants of origin have been inspected no more than 14 days before the fruit is harvested and that no Blueberry Rust was detected;
- (b) that the crop has been sprayed within 14 days of harvest with a fungicide, registered for the treatment of Blueberry Rust, as per the label recommendation, together with the name of the fungicide used, and the date on which it was applied;
- (c) that each consignment is free from soil and plant debris and in new packages;
- (d) that each container bears the name and address of the property where the fruit was grown and the name and address of the pack-house where the fruit was packed.

(5) Conditions — Agricultural equipment

Potential carriers comprising agricultural equipment may be brought into Western Australia if an officer from the exporting State or Territory's quarantine authority has certified the following in relation to that equipment —

- (a) that the equipment is free from soil and plant debris;
- (b) that the equipment is identified with the locality where it was last used;
- (c) that the equipment has been —
  - (i) steam cleaned;
  - (ii) treated with a solution containing not less than 100 ppm available chlorine, used as a spray rinse or dump treatment; or
  - (iii) treated in a manner approved by the Quarantine Plant Pathologist, Department of Agriculture, Western Australia.

(6) Conditions — Plants

- (a) Potential carriers comprising plants may be brought into Western Australia if the entry is approved by the Director General of Agriculture, Western Australia;
- (b) Plants that have entered Western Australia under subitem (1) are to be grown in post-entry quarantine, screened and cannot be released unless they are found to be free of Blueberry Rust;
- (c) If Blueberry Rust is detected on plants growing in post-entry quarantine, the plants must be destroyed in a manner approved by an Inspector.

**LOCAL GOVERNMENT ACT 1995***City of Cockburn***(LOCAL GOVERNMENT ACT) LOCAL LAWS 2000**

Pursuant to its powers conferred upon it by the *Local Government Act 1995*, the City of Cockburn hereby records having resolved on the 15th March 2005 to make the following amendments to the City of Cockburn (Local Government Act) Local Laws 2000 published in the *Government Gazette* on 9 October 2000.

1. In section 9.3 delete the word 'or' at the end of the paragraph (m). Delete '.' after the word 'place' in paragraph (n) and insert ': or'.
2. In section 9.3 after paragraph (n) insert the new paragraph as follows—
  - (o) '...unless at the direction of the local government, or an authorised person, damage, remove or interfere with any signpost, direction plate, guidepost, notice, shelter, shed, fence or any structure erected on a thoroughfare by the local government or person acting under the authority of a written law.'
3. In section 9.11 delete subsections (4), (5) and (6) and substitute the following—
  - (4) A retailer shall clearly mark its name or its trading name on any shopping trolley made available for the use of its customer.
  - (5) A person shall not leave a shopping trolley in a public place, other than in an area set aside for the storage of shopping trolleys.
  - (6) Where a shopping trolley is found in a public place, other than in an area set aside for the storage of shopping trolleys and the retailer whose name is marked on the trolley has been advised verbally or in writing of its location by the local government, the retailer or their agent shall remove the shopping trolley from the public place within twenty four (24) hours of being advised.

(6A) In the absence of any proof to the contrary, a shopping trolley is to be taken to belong to the retailer whose name is marked on the trolley.
4. 'Schedule 2 Modified Penalties—Part IX—Streets and Public Places' is amended by inserting the following modified penalties in the appropriate numerical sequence:

9.3 (o)	Damage, alter, deface, remove or destroy any sign on a street or reserve.....	500.00
9.11 (4)	Retailer not clearly marking name on shopping trolley.....	100.00
9.11 (5)	Leaving shopping trolley in a public place other than an area set aside for storage of shopping trolleys.....	100.00
9.11 (6)	Failure of retailer or agent to remove shopping trolley within 24 hours after being advised.....	100.00

#### AGRICULTURAL PRODUCE COMMISSION ACT 1988

##### APC VEGETABLE PRODUCERS' COMMITTEE DIRECTIONS 2005

Given under Section 11.3 of the Agricultural Produce Commission Act 1988.

#### Citation

1. These directions may be cited as the *APC Vegetable Producers' Committee Directions 2005*.

#### Commencement

2. These directions come into operation on the day on which they are published in the *Government Gazette*.

#### Interpretation

3. In these directions, unless the contrary intention appears—

- (a) “**vegetable producer**” means a person who produces vegetables for sale except herb, potato, mushroom, tomato and Kununurra vegetable producers.
- (b) “**member**” means a member of the committee and includes the chairperson.
- (c) “**the Committee**” means the APC Vegetable Producers' Committee established under section 11 of the Act.

#### Constitution of the Committee

4.1 Subject to the Act, there is to be a Committee consisting of 9 members appointed by the Commission.

4.2 If the Commission is of the opinion that a poll of Western Australian vegetable producers should be held to elect committee members then a poll shall be conducted.

4.3 A committee member is appointed as the first chairperson by the Commission for a three year term, thereafter committee members elect one of their number as chairperson.

#### Term of member

5. A member holds office for such term, not exceeding 3 years, as is fixed by the Commission.

#### Removal from office

6. The Commission may remove a member from office on the ground that that member is mentally or physically incapable of performing the duties of a member, or for incompetence, neglect of duty, misconduct or a breach of these directions.

**Vacation of office**

7. The office of a member becomes vacant if the member—

- (a) dies;
- (b) is absent from 4 consecutive meetings of the Committee without the permission of the Committee;
- (c) is an undischarged bankrupt or a person whose property is subject to an order or arrangement under the laws relating to bankruptcy; or
- (d) is removed from office by the Commission under direction 6.
- (e) tenders in writing to the Commission their resignation from the office.

**Casual vacancy**

8. (1) Where an office of a member of the Committee becomes vacant otherwise than by effluxion of time, the Commission is to appoint a person to take the place of the person who has vacated the office.

(2) A person appointed under subdirection (1) holds office for the balance of the term of the member whose place he or she takes.

**Disclosure**

9. (1) A member of the Committee who has a direct or an indirect pecuniary interest in a matter being considered or about to be considered at a meeting of the Committee must, as soon as possible after the relevant facts have come to his or her knowledge, disclose his or her interest at a meeting of the Committee.

(2) A disclosure under subdirection (1) is to be recorded in the minutes of the meeting of the Committee and the member must not, unless the meeting otherwise determines—

- (a) be present during any deliberation of the Committee with respect to that matter; or
- (b) take part in any decision of the Committee with respect to that matter.

(3) For the purpose of the making of a determination by the Committee under subdirection (2), in relation to a member who has made a disclosure under subdirection (1), a member who has a direct or an indirect interest in the matter to which the disclosure relates must not—

- (a) be present during any deliberation by the Committee for the purpose of making that determination; or
- (b) take part in the making by the Committee of that determination.

**Meetings**

10. (1) Subject to subdirection (2), meetings may be held at such times and places as the Committee determines.

(2) A special meeting of the Committee may at any time be convened by the chairperson of the Committee provided 7 days notice is given or shorter period if unanimously agreed by Committee members.

(3) The chairperson of the Committee presides at any meeting of the Committee at which the chairperson is present and, in the absence of the chairperson, the members present are to elect one of their members to preside.

(4) At a meeting of the Committee, 5 members constitute a quorum.

(5) At any meeting of the Committee the member presiding at the meeting has a deliberative vote, and in the case of an equal number of votes being cast for and against any question, has a casting vote.

(6) The Committee shall conduct its proceedings, and cause to be kept minutes of all its proceedings. Minutes of meetings are to be confirmed by the Committee as soon as possible and signed by the Chairperson as being true and accurate account of the meeting.

**Resolution without meeting**

11. A resolution in writing signed or assented to by letter, or electronic means of communication, by each member of the Committee is as valid and effectual as if it had been passed at a meeting of the Committee.

**Procedures of the Committee**

12. Except to the extent that they are prescribed or as set out in these directions, the Committee may determine its own procedures.

**Code of Conduct**

13. A member of the Committee shall observe the provision of any code of conduct prepared by the Commission and provided to the Committee.

**Remuneration and expenses of Committee members**

14. (1) The remuneration, travelling and other expenses is payable to Committee members in respect of their attendance at meetings and carrying out their duties at a rate agreed to by the Commission

(2) Application for remuneration to be made within two months of incurring the expense.

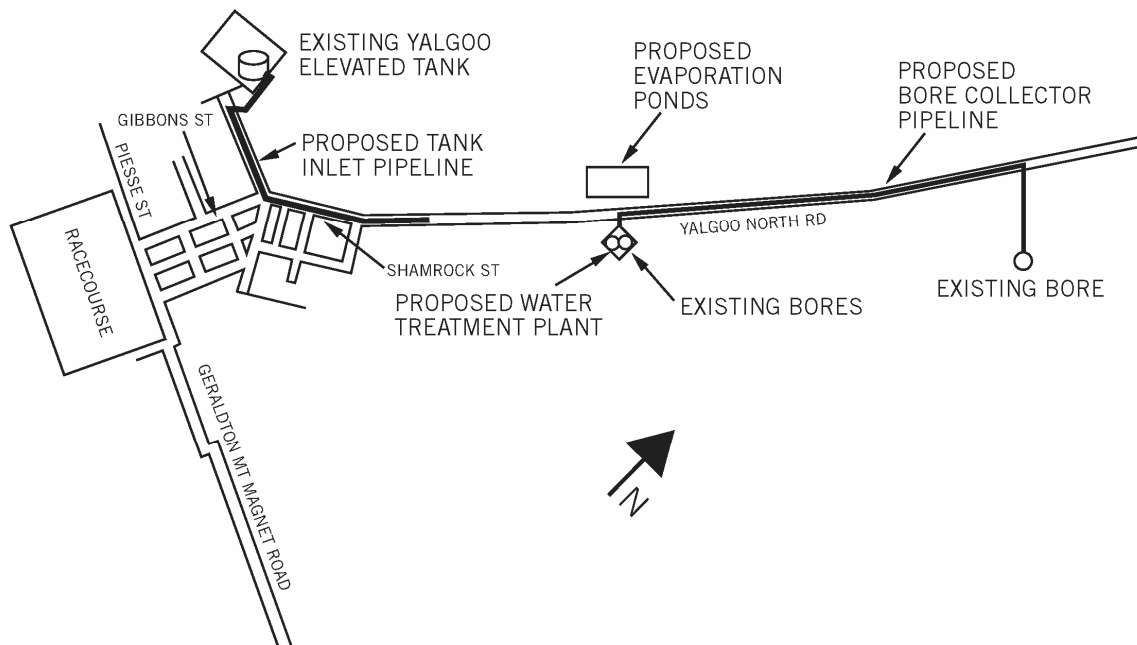
