## **Country Taxi-cars (Fares and Charges) Amendment Regulations (No. 3) 2005**

Made by the Lieutenant-Governor and Administrator in Executive Council.

**1. Citation**

These regulations are the *Country Taxi-cars (Fares and Charges) Amendment Regulations (No. 3) 2005*.

**2. The regulations amended**

The amendments in these regulations are to the *Country Taxi-cars (Fares and Charges) Regulations 1991\**.

**3. Regulation 2A inserted**

**2A. Terms used in these regulations**

In these regulations, unless the contrary intention appears —

“**business entity**” includes an individual, body corporate, trust or partnership, who or that carries on business;
