## Plant Diseases Act 1914

**Plant Diseases Amendment Regulations  
(No. 4) 2005**

Made by the Lieutenant-Governor and Administrator in Executive Council.

**1. Citation**

These regulations are the *Plant Diseases Amendment Regulations (No. 4) 2005*.

**2. The regulations amended**

The amendments in these regulations are to the *Plant Diseases Regulations 1989*\*.

**3. Schedule 1 amended**

(1) Schedule 1 Part A is amended in the Table as follows:

- (a) by deleting “31,” in each place where it occurs;
- (b) in the item relating to “Apricot” —
  - (i) in columns 3 and 4 by inserting —  
“ see Stonefruit ”; and
  - (ii) in column 5 by inserting —  
“ 31 ”.

(2) Schedule 1 Part B item 1(1) is amended as follows:

- (a) by deleting “Entry” and inserting instead —  
“ Unless specifically dealt with elsewhere, entry ”;
- (b) by deleting “Stonefruit: fruit — brown rot (*Monilinia sclerotinia*) *fructicola* and *M. laxa*.” and inserting instead —  
“  
Stonefruit: fruit other than apricot fruit (*Prunus armeniaca*) and cherry fruit (*Prunus avium*) from South Australia and Tasmania, general diseases.  
”.

- (3) Schedule 1 Part B item 26 is amended as follows:
- (a) in subitem (1) by deleting the definition of “appropriate officer” and inserting instead —
- “
- “**AQIS**” means the Australian Quarantine and Inspection Service of the Commonwealth;
- ”;
- (b) in subitem (2) by deleting “under any condition” and inserting instead —
- “ except in accordance with subitem (8) ”;
- (c) after subitem (2) by inserting the following item —
- “
- (2a) For South Australia and Tasmania cherry fruit entry not allowed except in accordance with subitems (3) to (7) or subitem (8).
- ”;
- (d) in subitem (4) by deleting “a written verification from an appropriate officer” and inserting instead —
- “ certification ”;
- (e) in subitem (7) by inserting before “item” —
- “ Schedule 1 Part B ”;
- (f) after subitem (7) by inserting the following item —
- “
- (8) Cherry fruit originating from New Zealand may enter Western Australia via another State or a Territory subject to —
- (a) equivalent entry requirements to those applied by AQIS to cherry fruit imported directly from New Zealand to Western Australia; and
- (b) any further requirements considered necessary by the Director General.
- ”.
- (4) Schedule 1 Part B item 31 is deleted and the following item is inserted instead —
- “
31. Apricot fruit (fresh fruit of *Prunus armeniaca*) — Oriental fruit moth (*Grapholita molesta*), general diseases.
- (1) In this item —
- “**apricot fruit**” means fresh fruit of *Prunus armeniaca*;
- “**AQIS**” has the same meaning as in item 26;
- “**FPE**” means Part A and Part B of the document entitled *Final Policy Extension Fresh Apricot (Prunus armeniaca) Fruit Imported from South Australia and Tasmania into Western Australia* completed by the Department of Agriculture in December 2003 as amended from time to time;
- “**fruit fly**” means —
- (a) *Bactrocera kraussi* (Krauss’ fruit fly);

- (b) *Bactrocera mayi*;
- (c) *Bactrocera melas*;
- (d) *Bactrocera neohumeralis* (Lesser Queensland fruit fly);  
or
- (e) *Bactrocera tryoni* (Queensland fruit fly);

“**oriental fruit moth**” means *Grapholita molesta*;

“**relevant department**” has the same meaning as in item 26.

- (2) For States and Territories other than South Australia or Tasmania, apricot fruit entry not allowed except in accordance with subitem (10).
- (3) For South Australia and Tasmania apricot fruit entry not allowed except in accordance with subitems (4) to (9) or subitem (10).
- (4) From South Australia or Tasmania to be certified as from a property and packed in a packing house registered in accordance with the FPE.
- (5) From South Australia or Tasmania to be accompanied by certification stating —
  - (a) the name, address and registration number of —
    - (i) the property on which the apricot fruit was grown; and
    - (ii) the packing house in which it was packed; and
  - (b) that the property and packing house have been registered by the relevant department for export to Western Australia in accordance with the FPE,

and displaying the following words on the certification —

“

THE PROPERTY AND PACKING HOUSE  
HAVE BEEN REGISTERED FOR EXPORT TO  
WESTERN AUSTRALIA IN ACCORDANCE  
WITH THE FPE

”

- (6) From South Australia or Tasmania to be —
  - (a) transported in containers with —
    - (i) the registration number or the name of the producer of the apricot fruit and the address of the property on which it was grown; and
    - (ii) the registration number or the name of the packer of the apricot fruit and the address of the property on which it was packed,  
printed on the external surface in letters not less than 5 mm in height;
  - (b) packed in clean new packaging; and
  - (c) substantially free from leaves, soil and other plant debris, other than a peduncle or pedicel.

(7) From South Australia or Tasmania to be inspected on arrival in Western Australia in accordance with the sampling procedures set out in the FPE Appendix 3.

(8) From South Australia and Tasmania to be certified as —  
(a) grown on a property which is declared to be an area of low pest prevalence for oriental fruit moth in accordance with the FPE,

and displaying the following words on the certification —

“

GROWN ON A PROPERTY WHICH IS  
DECLARED TO BE AN AREA OF LOW PEST  
PREVALENCE FOR ORIENTAL FRUIT MOTH  
IN ACCORDANCE WITH THE FPE

”;

or

(b) fumigated with methyl bromide in accordance with AQIS Quarantine Treatments Aspects and Procedures Version 1.0 and specifying —

- (i) the name of the fumigation facility;
- (ii) the date of fumigation;
- (iii) the rate of methyl bromide used, being the initial dosage (g/m<sup>3</sup>);
- (iv) concentration time (CT) product of methyl bromide achieved by the fumigation (ghr/m<sup>3</sup>);
- (v) duration of fumigation (hours);
- (vi) ambient air temperature during fumigation (°C); and
- (vii) minimum apricot pulp temperature during fumigation (°C),

and displaying the following words on the certification —

“

FUMIGATED IN ACCORDANCE WITH AQIS  
QUARANTINE TREATMENTS ASPECTS AND  
PROCEDURES

”.

(9) From South Australia or Tasmania to be certified as —

- (a) fumigated in accordance with item 31(8)(b); or
- (b) from an area free from fruit fly in accordance with the Code of Practice or as approved by the Director General,

and displaying the following words on the certification —

“

FROM AN AREA FREE FROM FRUIT FLY IN  
ACCORDANCE WITH THE CODE OF  
PRACTICE

”.

- (10) Apricot fruit originating from New Zealand may enter Western Australia via another State or a Territory subject to —
- (a) equivalent entry requirements to those applied by AQIS to apricot fruit imported directly from New Zealand to Western Australia; and
  - (b) any further requirements considered necessary by the Director General.
- (11) The Department of Agriculture is to make available —
- (a) a summary of the FPE from its website at [www.agric.wa.gov.au](http://www.agric.wa.gov.au); and
  - (b) a current version of the FPE from the offices of the Department of Agriculture at Baron-Hay Court, South Perth.

”.

- (1a) For the purposes of the application, a CodeMark certificate issued for a building product is sufficient evidence that the building product complies with the provisions of the Building Code specified in the certificate.
- (1b) In subregulation (1a) —
- “**building product**” includes a building product, method, design, component and system;
- “**CodeMark certificate**” means a certificate, issued under the CodeMark Scheme administered by the Australian Building Codes Board, which certifies that a building product, method, design, component or system complies with the specified provisions of the Building Code.

”.

### LOCAL GOVERNMENT ACT 1995

#### *Shire of Wyalkatchem*

#### LOCAL LAW TO REPEAL DEFUNCT AND OBSOLETE LOCAL LAWS, 2005

Under the powers conferred by the Local Government Act 1995 and under all other powers enabling it, the Council of the Shire of Wyalkatchem resolved on 17th November 2005 to make the “Shire of Wyalkatchem Local Law to Repeal Defunct and Obsolete Local Laws, 2005”.

#### **Citation**

1. This local law may be cited as the Shire of Wyalkatchem Local Law to Repeal Defunct and Obsolete Local Laws, 2005.

#### **Repeal**

2. The Local Laws hereunder following are repealed—

- (1) Discount on Rates By-Law published in the *Government Gazette* on 1 April, 1926;
- (2) Date of payment of Rates By-law published in the *Government Gazette* on 19 April, 1929;

- (3) By-laws relating to Buildings within the Townsite of Wyalkatchem published in the *Government Gazette* on 10 May, 1929;
- (4) By-law re Discount on Rates published in the *Government Gazette* on 15 September, 1939;
- (5) By-law re Appointment of Employees published in the *Government Gazette* on 17 October, 1941;
- (6) Amendment to General By-laws published in the *Government Gazette* on 17 January, 1947;
- (7) By-Laws re Straying Stock published in the *Government Gazette* on April 16, 1948; and
- (8) By-Laws Relating to Clearing of Land and Removal of Refuse, Rubbish and Disused Material published in the *Government Gazette* on 17 December, 1969; and
- (9) Adoption of Draft Model By-laws Relating to (Caravan and Camping Grounds) No. 2 published in the *Government Gazette* on 22 December, 1978.

#### HEALTH ACT 1911

##### *City of Albany*

HEALTH (EATING-HOUSES AND ITINERANT FOOD VENDORS) LOCAL LAW 2005  
Made by the Council of the City of Albany under section 342 of the *Health Act 1911* in accordance with subdivision 2 of Division 2 of Part 3 of the *Local Government Act 1995*.

#### Citation

1. This local law may be cited as the *City of Albany Health (Eating-Houses and Itinerant Food Vendors) Local Law 2005*

#### Repeal

2. The Health Local Laws of the City of Albany described as “*Health (Eating-Houses and Itinerant Food Vendors) Local Laws 2001*” made by the City of Albany and published in the *Government Gazette* on 17 April 2002 are repealed.

#### Interpretation

3. In this local laws, unless the context otherwise requires—

“**Act**” means the Health Act 1911 (as amended).

“**Certificate of Registration**” means a registration certificate issued pursuant to the provisions of these local laws by Council.

“**Council**” means the Council of the City of Albany.

“**CEO**” means the Chief Executive Officer of the City of Albany and includes the Acting Chief Executive Officer;

“**Eating-House**” means an eating-house as defined in Division 3, Section 160, of the Health Act 1911 (as amended).

“**Environmental Health Officer**” means an Environmental Health Officer appointed under the Act, and includes any acting or assistant environmental health officer.

“**Itinerant food vendor**” means a person who sells food from his vehicle parked temporarily on the road to customers who stop him or come to him while he is so parked

“**Licence**” means a licence to conduct an eating-house granted pursuant to the provisions of these local laws by Council.

“**Proprietor**” means the person having the management or control of premises.

“**Registered premises**” means any premises that are registered as an eating-house under these local laws.

#### Requirement for Registration and Licensing

4. No person shall occupy or use any premises as an eating-house unless—

- (a) The premises are registered under these local laws as an eating-house;

- (b) The proprietor of the said premises is the holder of a licence issued by Council authorising him to conduct on the premises the business of an eating-house; and
- (c) The premises and the operations conducted within the premises comply with the requirements of the *Health (Food Hygiene) Regulations 1993*.

#### **Registration of an Eating House**

5. (1) An application for registration of an eating-house made to Council shall be accompanied by—

- (i) payment of an eating-house registration fee as fixed from time to time by Council under Section 344C of the Act;
- (ii) detailed plans and specifications of the eating-house which shall include the following details—
  - (a) The use of each room;
  - (b) The structural finish of each wall, floor and ceiling;
  - (c) The position and type of each fitting and fixture;
  - (d) All sanitary conveniences, changerooms, ventilating systems, drains, grease traps and provisions for waste disposal; and
  - (e) The proposed number of persons, including the proprietor or proprietors, expected to be engaged in the preparation, manufacture, processing, cooking or serving of meals.

(2) The provisions of Clause 5(1)(ii) shall not apply to currently registered eating-houses or to eating-houses that were established before these local laws were made.

(3) Council may approve an application for registration of an eating-house subject to any conditions as it deems necessary to ensure compliance with the requirements of the Act.

(4) Upon approval of an application for registration of an eating-house, Council shall provide the applicant with a Certificate of Registration.

#### **Prescribed Date**

6. (1) For the purposes of Section 162 of the Act, the prescribed date is fixed as the 1 July 1998.

(2) For the purpose of Section 163 of the Act, the 30th day of June in each year is prescribed as the date on or before which the annual application for registration of an eating-house and licence for the proprietor of an eating-house shall be made.

#### **Licence to Conduct an Eating-House**

7. Before any licence to conduct an eating-house is issued to any proprietor by Council under these local laws, the proprietor shall make an application in writing and shall—

- (i) include the full name and address of the applicant;
- (ii) specify the location for which the licence is sought;
- (iii) specify the nature of the proposed foods and services;
- (iv) include details of any previous experience in the operations of eating-houses.

The applicant shall forward the application, together with the fee as may be fixed from time to time by Council under Section 344C of the Act, to Council and if the application is approved, Council shall issue to the proprietor a licence.

#### **Register of Registrations and Licences**

8. Every certificate of registration of premises registered as an eating-house and every licence issued to a proprietor shall be entered in a register maintained by Council for that purpose.

#### **Certificates of Registration and Licences**

9. Every proprietor of registered premises shall keep the certificates of registration and the licence on the registered premises in a position visible to the general public and shall, when requested to do so by an Environmental Health Officer, produce the certificate of registration and the licence issued to the proprietor in respect of such premises.

#### **Period of Registration and Licence**

10. Every certificate of registration and every licence shall be in force from the day of issue to the next 30th day of June, inclusive, unless the same is cancelled in the meantime in accordance with the provisions of the Act.

#### **Renewal Applications**

11. Applications for renewal of certificates of registration and licences shall be made annually during the month of June.

**Fees**

12. The fees payable to Council on the registration of premises, the issue of a licence and on the renewal of any registration or licence shall be the fee as fixed from time to time by Council under Section 344C of the Act.

**Change of Address**

13. Whenever any person identified as the proprietor on a certificate of registration and/or a licence issued pursuant to these local laws changes his place of abode he shall, within seven days of such a change, give notice in writing to Council specifying his new place of abode and he shall, at the same time, produce such certificate of registration and/or licence to Council, and the amendment shall be endorsed thereon.

**Licence Personal to Holder**

14. Any licence issued under the provisions of these local laws to any proprietor to conduct an eating-house shall not be transferable to any other person except as specified in Section 168 Subsection 2 of the Act.

**New Proprietors to Apply for Licence**

15. If the licensed proprietor of any premises registered as an eating-house ceases to be the proprietor as defined under these local laws then any person wishing to become the proprietor of such premises must make application to Council for a licence to conduct an eating-house as required by Clause 7 of these local laws.

**Power to Grant or Refuse an Application or Cancel a Registration or Licence**

16. Where application is made to Council either for—

- (a) The registration of an eating-house; or
- (b) The licensing of an eating-house proprietor, then—
  - (i) such application may be granted or refused subject to Sections 165 and 166 of the Act,
  - (ii) any such registration or licence, if granted, may be cancelled at any time for any one of the reasons described in Subsections 165(3) and 166(3) of the Act.

**Itinerant Food Vendor's Licence**

17. (1) An itinerant food vendor shall not offer for sale or sell food unless he or she—
- (a) Is the holder of an itinerant food vendor's licence issued by Council under this clause; and
  - (b) Complies with any condition to which the itinerant food vendor's licence is subject.
- (2) An application for an itinerant food vendor's licence shall be—
- (a) Made by the proprietor or, where there is more than one proprietor, by each proprietor in writing; and
  - (b) Forwarded to Council together with the fee as may be fixed from time to time by Council under Section 344C of the Act.
- (3) An application for a itinerant food vendor's licence under this clause shall be determined by Council which may—
- (a) Approve the application, with or without conditions; or
  - (b) Reject the application.
- (4) A food vendor's licence issued under this clause shall be valid until 30 June next following the date of issue of the food vendor's licence by Council.

**Offences and Penalties**

18. Any person who commits a breach of any of the provisions of these local laws shall be guilty of an offence and upon conviction shall be liable to a fine that is not more than \$2,500 and not less than—

- (i) in the case of a first offence \$250;
- (ii) in the case of a second offence \$500;
- (iii) in the case of a third or subsequent offence \$1,250; and if that offence is a continuing offence, a daily penalty which is not more than \$250 and not less than \$125.

**LOCAL GOVERNMENT ACT 1995***City of Albany***PREVENTION AND ABATEMENT OF SAND DRIFT (AMENDMENT) LOCAL LAW**

Under the powers conferred by the *Local Government Act 1995* and by all other powers, the Council of the City Of Albany resolved on 20th September 2005 to make the following amendment to the *City of Albany Prevention and Abatement of Sand Drift Local Law* published in the *Government Gazette* on 5 December 2000.

**Title**

1. This local law may be cited as the *City of Albany Prevention and Abatement of Sand Drift (Amendment) Local Law*.

**Operation**

2. This local law will come into operation on the fourteenth day after the day on which it is published in the *Government Gazette*.

**Principal Local Law**

3. In this local law, the *City of Albany Prevention and Abatement of Sand Drift Local Law* made under the *Local Government Act 1995* and published in the *Government Gazette* on 5 December 2000 is referred to as the principal local law.

**Principal Local Law Amendment**

4. The principal local law is amended as described below:—

- Clause 8(c)  
Clause 8(c) is deleted.
- Clause 12

The number “12.” is to be inserted immediately before the words “(a) A person who —” in the third line of Clause 11 to create Clause 12.

**1. Citation**

**3. Rule 94 amended**
