PUBLIC SECTOR MANAGEMENT ACT 1994**AMALGAMATION OF DEPARTMENTS AND DETERMINATION OF OFFICES
IN SPECIAL DIVISION**

Pursuant to Sections 35(2) and 38 of the *Public Sector Management Act 1994*, notice is hereby given that the Governor has—

- (a) under the *Public Sector Management Act 1994* section 35(1)(b), and on the recommendation of the Minister for Public Sector Management, amalgamated the Department of Environment and the Department of Conservation and Land Management and designated the resulting department as the Department of Environment and Conservation, with effect on and from 1 July 2006; and
- (b) under the *Public Sector Management Act 1994* section 38, and on the recommendation of the Minister for Public Sector Management, determined that the offices in the Department of Environment and Conservation known as the Director General, Deputy Director General Parks and Conservation and Deputy Director General Environment are offices included in the Special Division of the Public Service, with effect on and from 1 July 2006.

PUBLIC SECTOR MANAGEMENT ACT 1994**NOTICE OF DISPOSITION OF OFFICES AND PUBLIC SERVICE OFFICERS
(AND OTHER CONSEQUENTIAL CHANGES) IN THE NEW DEPARTMENT
OF ENVIRONMENT AND CONSERVATION PURSUANT TO SECTION 36(4)**

Notice is hereby given that upon amalgamation of the Department of Conservation and Land Management (CALM) and the Department of Environment, resulting in the new Department of Environment and Conservation, the following disposition of offices and public service officers shall have effect on and from 1 July 2006—

1. Mr Keiran McNamara shall be the substantive occupant of the new CEO office of Director General, Department of Environment and Conservation (the Director General), on the basis of the current terms and conditions of his contract of employment;
2. Subject to paragraph 3, all existing staff in the Departments of CALM and Environment whose employment or appointments have not otherwise expired or terminated as at midnight on 30 June 2006 shall be taken to have retained their current offices, substantive classifications and terms and conditions of employment, and to be performing their current functions within the new respective departmental divisions of “Parks and Conservation” and “Environment” within the Department of Environment and Conservation - such disposition of offices and officers to apply unless or until changed by the Director General; and
3. Messrs Jim Sharp and Kim Taylor shall be taken to be acting in the new offices of Deputy Directors General, Parks and Conservation and Environment (as heads of the respective divisions)—such disposition of offices and officers to apply unless or until changed by the Director General.
