1. Citation

2. Commencement

These regulations come into operation on 31 March 2007.

3. The regulations amended

8. Transitional

- (1) In this regulation
 - "new term", in relation to a trade, means the term prescribed in relation to that trade in the *Industrial Training* (Apprenticeship Training) Regulations 1981 Schedule 1, as amended by these regulations;

"new trade" means -

- (a) Carpentry Fixing (Housing);
- (b) Carpentry Formwork (Housing);
- (c) Carpentry Framing (Housing);
- (d) Painter and Decorator;
- (e) Painting (Housing);
- (f) Signwriter;
- (g) Stonemason;

"old trade" means —

- (a) Carpentry and Joinery;
- (b) Carpentry (Housing);
- (c) Joinery (Housing);
- (d) Painting and Decorating;
- (e) Signwriting;
- (f) Stonemasonry.
- (2) Subject to this regulation the *Industrial Training* (Apprenticeship Training) Regulations 1981 as in force immediately before 31 March 2007 continue to apply to and in relation to —
 - (a) an apprentice who commenced service in an old trade under an apprenticeship agreement before
 31 March 2007 (an "existing apprentice"); or
 - (b) a person who
 - (i) commenced employment as a probationer in an old trade before 31 March 2007; and
 - (ii) completes that probationary employment after 31 March 2007; and
 - (iii) on completing that probationary employment commences service under an apprenticeship agreement,
 - (an "existing probationer").

- (3) The parties to the apprenticeship agreement of an existing probationer may, with the approval of the Director, agree in the apprenticeship agreement that
 - (a) the apprentice is to be employed in a new trade (instead of the old trade in which he or she was employed as a probationer); and
 - (b) the term of the apprenticeship is to be the new term for that new trade.
- (4) If the parties to an apprenticeship agreement agree in the manner described in subregulation (3), subregulation (2) ceases to apply to and in relation to the apprentice when he or she commences service under the apprenticeship agreement.
- (5) The parties to the apprenticeship agreement of an existing apprentice may, with the approval of the Director, vary the apprenticeship agreement to
 - (a) change the trade in which the apprentice is employed to a new trade; and
 - (b) if the new term for that new trade is different to the term of the apprenticeship, change the term of the apprenticeship to the new term (plus any extension made by the Director under subregulation (7)).
- (6) An application for approval under subregulation (5) must be made
 - (a) before 1 July 2007; and
 - (b) in a form and manner approved by the Director.
- (7) If, when an application is made for approval under subregulation (5)
 - (a) the apprentice has not
 - (i) attended all the classes; or
 - (ii) obtained all the instruction; or
 - (iii) undertaken all the courses and skills training programmes,

that the apprentice is required under section 33(1) of the Act to attend, obtain or undertake in relation to the trade in which he or she is to be employed under the varied agreement; and

(b) the Director is satisfied that the apprentice will not reasonably be able to complete those requirements during the term of the apprenticeship under the varied agreement,

the Director may, before approving the variation, extend the term of the apprenticeship under the varied agreement by such period as the Director considers reasonably necessary for the apprentice to complete those requirements.

- (8) A variation of an apprenticeship agreement under subregulation (5) takes effect on the date on which it is approved by the Director.
- (9) If an apprenticeship agreement is varied under subregulation (5), subregulation (2) ceases to apply to and in relation to the apprentice on the date the variation takes effect.

Local Government Act 1995

City of Geraldton-Greenough (Creation) Order 2007

Made by the Governor in Executive Council.

Part 1 — Preliminary

1. Citation

This order is the *City of Geraldton-Greenough (Creation) Order 2007.*

Part 2 — Abolition of districts of Geraldton and Greenough

2. Districts abolished

The districts of Geraldton and Greenough are abolished at the beginning of 1 July 2007.

3. Offices of members declared vacant

The offices of all of the members of the council of the City of Geraldton and the Shire of Greenough are declared to be vacant with effect on and from 30 April 2007.

4. Commissioners appointed for City of Geraldton

- (1) The following people are appointed to be the commissioners of the City of Geraldton
 - (a) Jeffrey Phillip Carr of 11 Clarence Street, South Perth;
 - (b) Malcolm Robert Smith of 57 Francis Street, Geraldton;
 - (c) Janet Grimoldby of 28 Stirling Road, Claremont.
- (2) Jeffrey Phillip Carr is appointed to be the chairperson of the commissioners.
- (3) Malcolm Robert Smith is appointed to be the deputy chairperson of the commissioners.
- (4) The appointments made in this clause take effect on 1 May 2007 and end when the district of Geraldton is abolished.

5. Commissioners appointed for Shire of Greenough

- (1) The following people are appointed to be the commissioners of the Shire of Greenough
 - (a) Jeffrey Phillip Carr of 11 Clarence Street, South Perth;
 - (b) Malcolm Robert Smith of 57 Francis Street, Geraldton;
 - (c) Janet Grimoldby of 28 Stirling Road, Claremont.
- (2) Jeffrey Phillip Carr is appointed to be the chairperson of the commissioners.
- (3) Malcolm Robert Smith is appointed to be the deputy chairperson of the commissioners.
- (4) The appointments made in this clause take effect on 1 May 2007 and end when the district of Greenough is abolished.

Part 3 — City of Geraldton-Greenough

6. District declared

- (1) On and from 1 July 2007, the area described in Schedule 1 is declared to be a district.
- (2) The district is named Geraldton-Greenough.
- (3) The district is designated a city.

7. Polling day for inaugural election

The poll for the inaugural election of members of the council of the City of Geraldton-Greenough is to be held on 20 October 2007.

8. Method of election of first mayor

The first mayor of the City of Geraldton-Greenough is to be elected by the council from amongst the councillors under Schedule 2.3 Division 1 of the Act.

9. Commissioners appointed for City of Geraldton-Greenough

- (1) The following people are appointed to be commissioners of the City of Geraldton-Greenough
 - (a) Jeffrey Phillip Carr of 11 Clarence Street, South Perth;
 - (b) Malcolm Robert Smith of 57 Francis Street, Geraldton;
 - (c) Janet Grimoldby of 28 Stirling Road, Claremont.
- (2) Jeffrey Phillip Carr is appointed to be the chairperson of the commissioners.
- (3) Malcolm Robert Smith is appointed to be the deputy chairperson of the commissioners.
- (4) The appointments made in this clause take effect on 1 July 2007 and end when the offices of members of the council are filled for the first time and the council holds its first meeting.

10. Division of District into wards

On and from 1 July 2007, the District of Geraldton-Greenough is divided into wards as described and named in Schedule 2.

11. Number of offices of councillor on the council and for the wards

On and from 1 July 2007 —

- (a) the number of offices of councillor on the council of the City of Geraldton-Greenough is 12; and
- (b) the number of offices of councillor for each ward described and named in Schedule 2 is 2.

Part 4 — Consequential directions

12. Plan for the future: modification of s. 5.56

The City of Geraldton-Greenough is not required to prepare a plan under section 5.56 of the Act in the financial year ending on 30 June 2008.

13. Appointment of authorised person continues

A person who, immediately before 1 July 2007, holds an appointment made under a written law by the City of Geraldton or Shire of Greenough for the purpose of enforcing or administering that written law becomes a person appointed by the City of Geraldton-Greenough for those purposes.

southern boundary of Lot 1891, as shown on Deposited Plan 231627, and extending easterly to and along that boundary and onwards to an eastern side of the North West Coastal Highway, as shown on Diagram 13375; thence generally southeasterly along sides of that highway to the prolongation westerly of the southern boundary of Lot 1, as shown on Diagram 13375; thence easterly to and along that boundary and easterly along the southern boundary of Lot 11, as shown on Plan 15501 and onwards to a western side of Lot 10770 (Reserve 27663), as shown on Deposited Plan 220591; thence southerly along that side and onwards to the prolongation westerly of the northern side of Cooper Street; thence easterly to and along that side to the southwestern corner of Lot 33, as shown on Plan 7045; thence northerly along the western boundary of that lot and northerly and easterly along the western and northern boundaries of Lot 34 and onwards to the westernmost southwestern corner of Lot 8, as shown on Plan 27870; thence easterly along the westernmost southern boundary of that lot to the northernmost northwestern corner of Lot 81, as shown on Plan 15415; thence easterly, southerly and again easterly along boundaries of that lot and onwards to the prolongation northerly of the easternmost eastern boundary of that lot; thence southerly to and along that boundary to the northeastern corner of Lot 80; thence southerly, westerly and again southerly along boundaries of that lot and onwards to an eastern side of Hackett Road; thence southerly along that side and onwards to a southeastern side of Chapman Valley Road; thence generally northeasterly, generally southeasterly and again generally northeasterly along sides of that road to the northernmost corner of Lot 23 as shown on Deposited Plan 232393; thence southeasterly along the northernmost northeastern boundary of that lot to the prolongation southwesterly of the westernmost northwestern boundary of Lot 101, as shown on Diagram 95744; thence northeasterly along that prolongation to the western corner of that lot; thence generally southeasterly along southwestern boundaries of that lot to the western boundary of the western severance of Lot 22, as shown on Deposited Plan 232393; thence southerly along that boundary and southerly along the western boundary of Lot 1, as shown on Diagram 16737, to a northwestern corner of the western severance of Lot 601, as shown on Deposited Plan 300433; thence southerly, southwesterly, again southerly, easterly and northerly along boundaries of that severance to the prolongation westerly of the southern boundary of the eastern severance of that lot; thence easterly to and along that boundary and easterly along the southern boundary of Lot 21, as shown on Deposited Plan 231877 to its southernmost southeastern corner; thence northeasterly to the southwestern corner of Lot 6876, as shown on Deposited Plan 254456; thence easterly and northerly along the southern and eastern boundaries of that lot and northerly along the eastern boundary of Lot 2176, as shown on Deposited Plan 255637, to the southernmost southern boundary of Lot 20, as shown on Deposited Plan 232394; thence easterly, northerly, again easterly and again northerly along boundaries of that lot and northerly along the eastern boundary of Lot 19 and onwards to the right bank of the Chapman River; thence generally southwesterly, generally westerly and again generally southwesterly downwards along that bank to the prolongation southerly of the eastern boundary of the eastern severance of Lot 14, as shown on Deposited Plan 232393; thence northerly to and along that boundary to the southwestern corner of Lot 4, as shown on Deposited Plan 232394; thence northerly and easterly along the western and northern boundaries of that lot to the westernmost southwestern corner of the western severance of Lot 2, as shown on Deposited Plan 232576; thence easterly, northerly, northeasterly, generally southeasterly, again northeasterly and southeasterly along boundaries of that lot and onwards to the western corner of the eastern severance of that lot; thence southeasterly, easterly and northerly along boundaries of that severance to the northernmost northwestern corner of Lot 12, as shown on Plan 20466; thence easterly and southeasterly along northern and northeastern boundaries of

that lot to the prolongation westerly of the southern boundary of Lot 2183, as shown on Deposited Plan 255650; thence easterly to and easterly and northerly along the southern and eastern boundaries of that lot to the southernmost southwestern corner of Lot 2, as shown on Diagram 6356; thence easterly along the southern boundary of that lot to the western boundary of Lot 2620, as shown on Deposited Plan 255323; thence southerly along the western boundary of that lot to the northernmost northwestern corner of Lot 2722, as shown on Deposited Plan 115353; thence easterly, southerly and again easterly along boundaries of that lot to the northwestern corner of Lot 2140, as shown on Deposited Plan 250927; thence easterly along the northern boundary of that lot to the western boundary of Lot 2, as shown on Diagram 82190; thence northerly along that boundary to the southeastern corner of the southern severance of Lot 2823, as shown on Deposited Plan 123522; thence northerly, northwesterly and northeasterly along boundaries of that severance and onwards to the southernmost southeastern corner of the northern severance of that lot; thence northeasterly along the southeastern boundary of that severance to the northwestern corner of Lot 1, as shown on Diagram 82190; thence generally easterly along northern boundaries of that lot and onwards to the northwestern corner of Lot 9847, as shown on Deposited Plan 205900; thence easterly along the northern boundary of that lot to the westernmost northwestern corner of Lot 2284, as shown on Deposited Plan 101236; thence northerly along the prolongation northerly of the western boundary of that lot to the prolongation westerly of the northern boundary of that lot; thence easterly to and along that boundary and onwards to the northernmost northwestern corner of Lot 23, as shown on Plan 21093; thence easterly and southerly along the northern and eastern boundaries of that lot to the prolongation westerly of the northern boundary of the western severance of Lot 6, as shown on Plan 16373; thence easterly to and along that boundary and onwards to and easterly along the northern boundary of the eastern severance of that lot and again onwards to the westernmost northwestern corner of the western severance of Lot 7260, as shown on Deposited Plan 202296; thence southerly, easterly, northerly and again easterly along boundaries of that severance and onwards to the southwestern corner of the southeastern severance of that lot; thence easterly along the southern boundary of that severance and onwards to the left bank of the Greenough River; thence generally northeasterly and generally northwesterly upwards along that bank to the prolongation westerly of the northern boundary of the western severance of Lot 6614, as shown on Deposited Plan 82737; thence easterly to and along that boundary and onwards to the northernmost northwestern corner of the eastern severance of that lot; thence easterly, southerly and westerly along boundaries of that severance to the northeastern corner of late Pastoral Lease 2034/93; thence southerly along the eastern boundary of that late pastoral lease and onwards to a southern side of the Geraldton-Mullewa Railway Reserve; thence southwesterly, generally northwesterly and generally southwesterly along sides of that railway reserve to the prolongation northerly of the eastern boundary of Lot 15 as shown on Diagram 94992; thence southerly to and along that boundary and onwards to the northeastern corner of the northern severance of Lot 19, as shown on Plan 22588; thence southerly along the eastern boundary of that lot and onwards to and southerly along the eastern boundary of the southeastern severance of that lot and again onwards to the northwestern corner of the northern severance of Lot 6724, as shown on Deposited Plan 82895; thence easterly and southerly along the northern and eastern boundaries of that severance and onwards to and southerly along the eastern boundary of the southern severance of that lot to the northernmost northwestern corner of Lot 1, as shown on Deposited Plan 51717; thence easterly and southeasterly along northern and northeastern boundaries of that lot to the northwestern corner of Lot 9841, as shown on Deposited Plan 163279; thence easterly and southeasterly along the northern and

SALARIES AND ALLOWANCES TRIBUNAL

Determination made on the remuneration of Commissioners of the Western Australian Industrial Relations Commission

Section 6(1)(e) of the Salaries and Allowances Act 1975 (The Act) requires the Tribunal, at intervals of not more than twelve months, to enquire into and determine the remuneration to be paid to the Chief

Commissioner, Senior Commissioner and Commissioners of the Western Australian Industrial Relations Commission (WAIRC).

BACKGROUND

The Tribunal's last determination of the remuneration of the members of the WAIRC was issued on the 22nd of March 2006.

CURRENT ENQUIRY

As part of conducting its current enquiry, the Tribunal placed an advertisement in "The West Australian" newspaper on Friday, 22nd of December 2006 and on its official website calling for submissions from interested persons and organisations. It also wrote directly to the Chief Commissioner informing him of its current enquiry and inviting a submission.

The Tribunal received a submission from the WAIRC. No submissions were received in response to the newspaper advertisement.

SUBMISSION

Some of the main issues submitted to the Tribunal were-

- Maintenance of previous practices in reviewing the remuneration of Commission members.
- Consideration of economic and other relevant indices.
- Consideration of interstate relativities.

CONSIDERATIONS

The Tribunal has sought details of the impact of the Commonwealth's *Work Choices* legislation on the work of the WAIRC in this year's enquiry. The information available to the Tribunal indicates that the impact is in a state of flux with the Commission losing some functions but acquiring new ones. More time will need to elapse before the impact can be determined accurately. The Tribunal will continue to monitor this matter.

In its deliberations on the Commissioners' remuneration rates, the Tribunal has given consideration to the issues raised in the submission and to a range of economic and other indices. These have included the latest relevant data issued by the Australian Bureau of Statistics, such as the December 2006 Quarter Consumer Price Index and the December 2006 Quarter Labour Price Index. It also has considered the Western Australian Wage Cost Index and Consumer Price Index and the Government's current Wages Policy. The Tribunal has also been mindful of increases received by other officeholders under its jurisdiction over the past twelve months.

DETERMINATION

The Tribunal has considered all of the information available to it in formulating this determination on the remuneration of the Commissioners of the WAIRC.

The Tribunal, accordingly, pursuant to section 6(1)(e) of the *Salaries and Allowances Act 1975*, determines the Commissioners of the Western Australian Industrial Relations Commission will receive an increase of 4.4 percent in remuneration with effect from the 1st of May 2007 as set out in the attached Schedule.

The determination will now issue.

2. Motor Vehicles

The following arrangements apply to the entitlement of each Commissioner to the provision of a fully maintained motor vehicle for business and private use.

2.1 The Chief Commissioner is entitled to the provision of a prestige vehicle, selected from the Government's Common Use Contract no. 012A1994, Items 1008 (Prestige Class) and 1009 (Restricted Prestige Class), as amended from time to time.

2.2 The Senior Commissioner and Commissioners are entitled to the provision of a prestige vehicle selected from Item 1008 (Prestige Class), as amended from time to time.

2.3 Vehicles with supercharged, turbo or V8 engines are not included.

2.4 The Chief Commissioner, Senior Commissioner and Commissioners may choose any vehicle and accessories in the Common Use Contract the total cost of which does not exceed the maximum cost of accessing a vehicle to which an entitlement exists in the relevant Prestige Class.

The total cost will be based on individual usage patterns. Each lease should be tailored to achieve the most cost-effective arrangement, but with the maximum lease term being two years, and include any standard accessories (including a tow bar or, for those entitled to a prestige vehicle selected from Item 1009, also a sunroof).

Where the total cost of the chosen vehicle and accessories exceeds the maximum cost of accessing a vehicle to which an entitlement exists in the relevant Prestige Class, the additional cost must be borne by the individual. This includes the purchase cost of accessories, the installation cost and removal costs if required before disposal of the vehicle.

2.5 The Chief Commissioner must approve the selection of the vehicle for the Senior Commissioner and Commissioners.

2.6 The Chief Commissioner must approve that the provision of a 4-wheel drive vehicle is clearly substantiated by demonstrated operational need.

2.7 All vehicles (being part of the Government-owned State Fleet) should be managed in accordance with the policies and conditions established and amended from time to time by the Department of Treasury and Finance (the effective owner of the State Fleet). Applicable terms and conditions are currently set out in the document, "State Fleet—Agency General Agreement".

2.8 Selection of appropriate vehicles should be subject to consultation between the Chief Commissioner and the Department of the Registrar of the Western Australian Industrial Relations Commission (as the department administratively supporting the Commission and therefore the "Agency" responsible for managing the leasing arrangements for vehicles provided to Commissioners of the WAIRC).

Although the cost of the vehicles is centrally funded, as a consequence of the vehicle being an emolument recommended under the *Salaries and Allowances Act 1975*, it remains an administrative responsibility of the Department of the Registrar of the Western Australian Industrial Relations Commission to manage.
