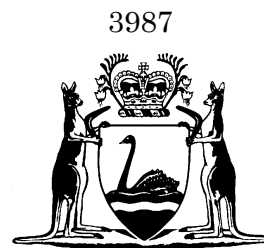

### Local Government (Elections) Amendment Regulations 2007

Made by the Governor in Executive Council.

**1. Citation**

These regulations are the *Local Government (Elections) Amendment Regulations 2007*.

**2. Commencement**

These regulations come into operation as follows:

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;

- (b) regulations 3, 15, 16, 17, 18(1) and (2) and 19 — on the day after that day;
- (c) the rest of the regulations — on the day on which the *Local Government Amendment Act 2007* (other than sections 1 and 2) comes into operation.

### 3. The regulations amended

The amendments in these regulations are to the *Local Government (Elections) Regulations 1997*.

### 4. Regulation 3 amended

- (1) Regulation 3 is amended in the definition of “election papers” as follows:

- (a) after paragraph (b) by inserting —

“

- (ba) if 3 or more candidates were named on the ballot paper for the election, a record of the manual count that shows how the number of votes obtained or received by each candidate was ascertained or, if an electronic counting system was used for the election —

- (i) a paper copy of the electronic record of preferences indicated on ballot papers that was used as data by the system to ascertain the number of votes obtained or received by each candidate; and

- (ii) a paper copy of the electronic count that shows how the number of votes obtained or received by each candidate was ascertained;

and

”.

- (b) after each of paragraphs (a) and (b) by inserting —

“ and ”.

- (2) Regulation 3 is amended by inserting in the appropriate alphabetical position —

“

“**first preference vote**” has the meaning given in clause 1(1) of Schedule 4.1 to the Act;

”.

### 5. Regulation 27 amended

Regulation 27(2) and (3) are repealed and the following subregulations are inserted instead —

“

- (2) If only 2 candidates are named on the ballot paper for the election and the number of votes received by a

candidate is at least 5% of the total number of votes included in the count, that candidate's deposit is to be refunded.

- (3) If 3 or more candidates are named on the ballot paper for the election and the number of first preference votes received by a candidate is at least 5% of the total number of all the first preference votes received by candidates, that candidate's deposit is to be refunded.

”.

#### 6. Regulation 31 amended

Regulation 31(1)(i) is deleted and the following paragraph is inserted instead —

“

- (i) the place or places where votes are to be counted including, if an electronic counting system is to be used for the election, the following —
- (i) any place or places appointed by the RO under regulation 75C where ballot boxes are to be opened;
  - (ii) any place or places appointed by the RO under regulation 75C where preferences indicated on ballot papers are to be recorded electronically;
  - (iii) the place or places where the electronic counting system is accessible for data input and output.

”.

#### 7. Regulations 34 and 35 replaced

Regulations 34 and 35 are repealed and the following regulations are inserted instead —

“

##### 34. One office and only 2 candidates — s. 4.69(1)

If only one office is to be filled at the election and only 2 candidates are named on the ballot paper, an elector is to mark the ballot paper by writing the numeral “1” in the box opposite the name of the candidate whom the elector wishes to be elected.

##### 35. One office and 3 or more candidates or 2 or more offices — s. 4.69(2)

If —

- (a) only one office is to be filled at the election and 3 or more candidates are named on the ballot paper; or

(b) 2 or more offices are to be filled at the election,

an elector is to mark the ballot paper by writing the numeral “1” in the box opposite the name of the candidate for whom the elector votes as the elector’s first preference, the numeral “2” in the box opposite the name of the candidate for whom the elector votes as the elector’s second preference, and so on, until the elector has numbered every box to indicate the order of the elector’s preferences for all the candidates.

”.

**8. Regulation 56 amended**

Regulation 56(3)(b) and “or” after it are deleted.

**9. Regulation 71 amended**

Regulation 71(e) is amended by deleting “opened” and inserting instead —

“

opened, when preferences indicated on ballot papers are recorded electronically

”.

**10. Part 12A inserted**

After Part 12 the following Part is inserted —

“

**Part 12A — Electronic counting of votes**

**75A. Application of Part**

- (1) This Part applies to an election if 3 or more candidates are named on the ballot paper for the election.
- (2) Nothing in this Part is intended to preclude the use of an electronic counting system for an election if only 2 candidates are named on the ballot paper for the election.

**75B. Use of electronic counting system**

For the purposes of ascertaining the result of an election, the RO may, if the RO thinks fit —

- (a) cause the preferences indicated on ballot papers to be recorded electronically; and
- (b) on the basis of the data so recorded, use an electronic counting system to ascertain the number of votes obtained or received by each candidate in accordance with Schedule 4.1 to the Act.

**75C. Transmission of data between counting places**

- (1) This regulation applies in relation to an election if an electronic counting system is to be used for the election.
- (2) If the RO believes that the counting of votes would be unduly delayed by the need to deliver a ballot box after the close of poll to a place where the electronic counting system is accessible for data input and output (an “**electronic counting place**”), the RO may do the things set out in subregulation (3) or (4) to facilitate the counting of votes.
- (3) The RO may —
  - (a) before the election notice is given under section 4.64, appoint a place other than an electronic counting place to be a place where —
    - (i) the ballot box is to be opened; and
    - (ii) the preferences indicated on ballot papers are to be recorded electronically;and
  - (b) permit the transmission, by data file or any other electronic means, of the data so recorded to an electronic counting place for use as data by the electronic counting system to ascertain the number of votes obtained or received by each candidate in accordance with Schedule 4.1 to the Act.
- (4) The RO may —
  - (a) before the election notice is given under section 4.64, appoint a place other than an electronic counting place to be a place where the ballot box is to be opened; and
  - (b) permit the transmission, by fax or any other electronic means, of an image of a ballot paper to an electronic counting place —
    - (i) for recording electronically the preferences indicated on the ballot paper; and
    - (ii) for using the data so recorded as data by the electronic counting system to ascertain the number of votes obtained or received by each candidate in accordance with Schedule 4.1 to the Act.

**11. Regulation 77 amended**

Regulation 77(2)(b) is amended by deleting “to the RO as soon as possible.” and inserting instead —

“ as soon as possible to a place as directed by the RO. ”.

**12. Regulation 77A inserted**

After regulation 77 the following regulation is inserted —

“

**77A. Drawing lots under Schedule 4.1 to the Act —  
s. 4.74**

- (1) In this regulation —  
“**clause**” means a clause of Schedule 4.1 to the Act;  
“**tied candidates**” means the candidates between whom the drawing of lots is required under clause 2(2), 7, 8, 18, 21 or 23.
- (2) As soon as possible after the occurrence of a circumstance under which the RO is required to draw lots under clause 2(2), 7, 8, 18, 21 or 23, the RO is to make out in respect of each of the tied candidates a slip bearing the candidate’s name.
- (3) The RO is to place each of the slips in separate hollow opaque spheres of exact similarity, securely close the spheres, deposit the spheres in an empty container, and securely fasten the container.
- (4) Then the RO is to shake and rotate the container and permit anyone else present to do likewise if they so wish.
- (5) Then the RO is to open the container, take out and open one of the spheres to obtain the slip enclosed in it.
- (6) The steps set out in subregulations (2) to (5) are to be carried out in front of all the people present.
- (7) The candidate whose name appears on the slip obtained by the RO in accordance with subregulation (5) is —
  - (a) if the drawing of lots is required under clause 2(2), 7 or 18 — to be elected;
  - (b) if the drawing of lots is required under clause 8 or 23 — to be excluded;
  - (c) if the drawing of lots is required under clause 21 — to be taken to have had the larger or largest surplus.

”.



**13. Regulation 80 amended**

(1) Regulation 80(2) is amended as follows:

- (a) by deleting paragraph (c) and “and” after it and inserting instead —

“

- (c) if voting by electors took place and 3 or more candidates were named on the ballot paper, the order of election or exclusion of each candidate; and

”;

- (b) after each of paragraphs (a) and (b) by inserting —

“ and ”.

(2) After regulation 80(3) the following subregulations are inserted —

“

- (4) If voting by electors took place and a person so requests, the RO is also to give to the person the following details as soon as practicable —

- (a) if only 2 candidates were named on the ballot paper — the number of votes received by each candidate;

- (b) if 3 or more candidates were named on the ballot paper —

- (i) the number of first preference votes received by each candidate;

- (ii) the votes obtained or received by each candidate at election or exclusion.

- (5) The RO is to be taken to have given to a person the requested details under subregulation (4) if the RO gives the person a copy of the record of the manual count, or a paper copy of the electronic count, that shows how the number of votes obtained or received by each candidate was ascertained.

”.

**14. Regulation 80A inserted**

After regulation 80 the following regulation is inserted —

“

**80A. Drawing lots under Schedule 4.2 to the Act — s. 4.78**

(1) In this regulation —

“**clause**” means a clause of Schedule 4.2 to the Act;

“**tied councillors**” means the councillors the order of whose retirement is to be determined by the drawing of lots under clause 6, 7, 8(b) or 9(a).

- (2) As soon as possible after the occurrence of a circumstance under which the RO is required to draw lots under clause 6, 7, 8(b) or 9(a), the RO is to make out in respect of each of the tied councillors a slip bearing the councillor's name.
- (3) The RO is to place each of the slips in separate hollow opaque spheres of exact similarity, securely close the spheres, deposit the spheres in an empty container, and securely fasten the container.
- (4) Then the RO is to shake and rotate the container and permit anyone else present to do likewise if they so wish.
- (5) Then the RO is to open the container, take out and open the spheres one by one to obtain the slips enclosed in them.
- (6) The steps set out in subregulations (2) to (5) are to be carried out in front of all the people present.
- (7) The retirement of the tied councillors is to be in the inverse order of that in which the slips bearing their names were obtained by the RO in accordance with subregulation (5).

”.

**15. Regulation 83 amended**

Regulation 83(b) is amended by deleting “Executive Director” and inserting instead —

“ Departmental CEO ”.

**16. Regulation 84 amended**

Regulation 84(3) is amended by deleting “given to justices by the *Justices Act 1902*.” and inserting instead —

“ of the Magistrates Court in its civil jurisdiction. ”.

**17. Regulation 86 replaced**

Regulation 86 is repealed and the following regulation is inserted instead —

“

**86. Notice and report of effect of Court's decision — s. 4.81(2) and (4)**

If the Court makes a declaration under regulation 85(1)(a), (b) or (c), the RO is, as soon as practicable —

- (a) to give local public notice in a form that conveys the effect of the declaration; and
- (b) to provide to the Minister a report in a form that conveys the effect of the declaration.

”.

**18. Schedule 1 amended**

- (1) The amendments in this regulation are to Schedule 1.
- (2) Form 9A is amended by deleting “Details of Gifts (Money or value above \$200)” and inserting instead —

“

Details of Gift (value of which is \$200 or more, or which is one of 2 or more gifts with a total value of \$200 or more)

”

- (3) Form 10 is deleted and the following form is inserted instead —

“

**BUSH FIRES ACT 1954**

*Shire of Murray*

**FIREBREAK NOTICE**

Pursuant to the powers contained in Section 33 of the Bush Fires Act 1954, notice is hereby given to all owners and/or occupiers of land within the Shire of Murray that Council has adopted the following requirements to prevent the outbreak or spread of a bush fire within the Shire.

All owners and/or the occupiers of land in the Shire are required to carry out fire prevention work in accordance with this notice by November 30 each calendar year or within fourteen days of the date of becoming the owner or occupier of the land, should this be after November 30. All work required by this Notice shall be maintained until April 30 in the following calendar year.

**DEFINITIONS**

For the purpose of this Notice the following definitions apply—

**“Firebreak”** means an area of ground, of a specified width that is kept and maintained totally clear of all material (living or dead) by scarifying, cultivating, ploughing or other means, and includes the pruning and removal of any living or dead trees, scrub or other material that overhang the cleared firebreak area to a vertical height of 4.5 metres from the ground.

**“Fuel Depot”** means an area of land, a building or structure where fuel, i.e. (petrol, diesel, kerosene, liquid gas or any other fossil fuel) is kept in any container or manner.

**“Urban Land”** means Residential, Commercial or Industrial land within a townsite or within any area subdivided for any purpose. The following areas are townsites- Pinjarra, Dwellingup, Furnissdale, Coolup, North Dandalup, Barragup, South Yunderup, North Yunderup, Ravenswood and Murray Bend.

**“Flammable Material”** means material that can be easily ignited, i.e.—dead or dry grass, leaves, timber, paper, plastic and any other material or thing deemed by an authorised officer to be capable of combustion.

**“Hills Landscape Protection Land”** means land zoned or defined as in the Town Planning Scheme as Hills Landscape Protection Land.

**“Plantations”** means any area of planted pines, eucalypt, hardwood or softwood trees exceeding (3) hectares in area.

**FIRE PREVENTION REQUIREMENTS****1. RURAL LAND**

- (a) Firebreaks of at least three (3) metres wide are to be constructed within fifty (50) metres of the boundaries of the land, where the land abuts—gazetted roads, railway reserves, CALM controlled land or a Plantation.
- (b) If the land abuts “*Special Rural*”, “*Special Use*”, “*Special Residential*”, “*Hills Landscape Protection Land*” or “*Urban*” or “*Farmlet Land*” a Firebreak of at least three (3) metres wide shall be constructed along that portion of the Rural Land that abuts the *abovementioned land*. The Firebreak is to be located immediately inside the boundary of the rural land where it abuts the *abovementioned land*.
- (c) **Firebreaks** of at least two (2) metres shall be constructed to surround all buildings, sheds, haystacks and fuel depots/storage areas on the land. The inner perimeter of the **Firebreak** is to be within twenty (20) metres of all buildings, sheds, haystacks and fuel depots/storage areas.

**SPECIAL RURAL, SPECIAL RESIDENTIAL, SPECIAL USE OR FARMLAND**

(Other than Rural Land previously described)

- (a) Where the area of land is less than 20000 square metres (two (2) Hectares) in size, all flammable material on the entire property (*except living standing trees*) shall be reduced and maintained to a height of less than 5 centimetres by slashing, mowing, rotary hoeing or by other means. Alternatively a firebreak can be installed in accordance with the following subclause. (A mixture of fuel reduction work and the installation of a firebreak will not be acceptable on this sized lot, unless a variation is approved).

(b) Where the area of land is more than 20000 square metres (two (2) Hectares) in size a Firebreak of at least three (3) metres wide shall be installed or constructed immediately inside all external boundaries of the land and also immediately surrounding all buildings situated on the land. Where several adjoining lots are held or used by the owner/occupier the Firebreak may be constructed inside and along all the external boundaries of the group of lots.

### **3. URBAN LAND (Excluding land abutting canals)**

(a) Where the area of land is 4000 square metres or less, all flammable material on the entire property (except living standing trees) shall be reduced and maintained to a height of less than 5 centimetres by slashing, mowing, rotary hoeing or chemical spraying.

(b) Where the area of land is more than 4000 square metres a Firebreak of at least three (3) metres wide shall be installed or constructed immediately inside all external boundaries of the land and also immediately surrounding all buildings situated on the land.

### **4. CANAL SYSTEM LOCATIONS**

All owners of property that abut a canal shall undertake fire prevention work in accordance with Clause 3 (a) and (b) of this Notice, depending on the total square metre area their land. The owners of undeveloped Lots i.e.- (*Vacant Land*) of LESS than 4000 square metres in size shall remove all flammable material from the land by slashing or mowing all material to a height of less than 5 centimetres or by or burning only. (Bush Fire permits may be required if burning is undertaken, consult your Fire Control Officer).

### **5. COOLEENUP, BALLEE AND YUNDERUP ISLANDS**

All owners of land on the abovementioned islands shall undertake fire prevention work in accordance with Clause 2 (a) or 2 (b) of this Order, depending on the total square metre area of their land.

### **6. HILLS LANDSCAPE PROTECTION LAND**

Each owner of land zoned "*Hills Landscape Protection*" shall undertake fire prevention work in accordance with Clause 2 (a) and 2 (b) of this Order, depending on the total square metre area of their land. All work required by this Notice, shall be in addition to any work required by the Fire Management Plan that exists for each lot zoned Hills Landscape Protection Land.

### **7. PLANTATIONS**

All plantations established after the 30 November 1984 that exceed 3 hectares in total area shall have a twenty (20) metres wide firebreak completely surrounding the perimeter of planted trees. A plantation that abuts a used road shall have a 10 metres wide firebreak along that portion of the plantation that abuts the road.

Each compartment of a plantation is limited to area of less than 30 hectares in size, each 30 hectare area shall have a 10 metres wide firebreak surrounding the perimeter of planted trees. This will permit unrestricted access to each compartment of planted trees by fire fighting equipment.

### **8. VARIATIONS**

If you consider it to be impractical to comply with the provisions of this Notice on your land, you may apply for a variation by contacting Shire Ranger Service on 95317777 prior to November 21 each year to arrange for an onsite inspection to discuss the alternate positions of the firebreaks or other methods of fire prevention work you propose to undertake. Variations can be approved for a 1 or 3 year period, subject to the owner/occupier of the land remaining the same. If the request to vary this Notice is not approved, you will be required to comply with the requirements of this Notice by November 30 each year.

#### **RESTRICTED BURNING TIME**

1st November to 14th December each year (inclusive)

15th March to 30th April each year (inclusive)

Permits to burn will not be issued to burn on a Public Holiday

### **CAMP OR COOKING FIRES**

Pursuant to Section 25 (1a) of the Bush Fires Act, 1954 the Shire of Murray hereby advises that the lighting of a fire in the district for the purpose of camping or cooking (other than a gas appliance) is prohibited during the Prohibited Burning Period, December 15 to March 14 each year. (Alterations to this date may occur, contact Council prior to lighting any camp fires).

### **BURNING OF GARDEN REFUSE**

Pursuant to Section 24 G (2) of the Bush Fires Act 1954 the Shire of Murray prohibits the burning of garden refuse on any land within the district that is under 1000 square metres during the restricted and prohibited burning times (limited burning times). On land over 1000 square metres dry garden waste may be burnt during the restricted burning time (without a fire permit) on the ground in small heaps, between 6pm and 11pm, unless the day is a declare a **very high or extreme fire danger day**. Five (5) meters must be cleared around the dry garden waste and the person who lit the fire

must remain in attendance. The Shire of Murray Health Local Laws prohibits the burning of green garden refuse outside of the limited burning times. Dry garden waste may be burnt outside of the limited burning times.

The Firebreak Notice previously published in the *Government Gazette* No. 187 on 20 November 2006 is hereby revoked.

Town Planning Scheme No. 14—Amendment No. 47

It is hereby notified for public information, in accordance with Section 87 of the Planning and Development Act 2005 that the Minister for Planning and Infrastructure approved the City of Belmont local planning scheme amendment on 18 July 2007 for the purpose of—

1. Adding Clause 5.1.9 as follows—

5.1.9 Notwithstanding any other provision of this Scheme—

- (a) subject to sub-paragraph (b) of this Clause, the prior planning approval of the Council must be obtained for the erection of any portion of a boundary fence which is within the street setback area of a lot; and
- (b) on a lot zoned "Residential", prior planning approval is not required for the erection of—
  - (i) a front fence; or
  - (ii) a boundary fence within the street setback area,

provided that in either case the fence is no more than 1.8 metres in height, when measured from natural ground level and is visually permeable from 1.2 metres above natural ground level.

2. Modifying Clause 10.5.7 as follows—

10.5.7 Fencing and Walls

- (a) It is the Council's intention that in the Mixed Use zone fencing facing any street frontage should be kept to a minimum to allow for an attractive and open streetscape. In special circumstances, the Council may allow fencing facing a street frontage or along a secondary street frontage, provided that in the opinion of the Council it is of exceptionally high quality, is visually permeable, and visually appealing.
- (b) Notwithstanding Clause 10.15, in the Mixed Use zone—
  - (i) the use of cyclone link mesh fencing is prohibited for any fence other than a boundary fence; and
  - (ii) the use of barbed wire in any fence is prohibited.

## 3. Modifying Clause 10.6.6 as follows—

## 10.6.6 Fencing and Walls

- (a) It is the Council's intention that in the Industrial Zone, fencing facing any street frontage should be kept to a minimum to allow for an attractive and open streetscape. In special circumstances the Council may allow fencing facing a street frontage, provided that in the opinion of the Council it is of exceptionally high quality, is visually permeable and is visually appealing.
- (b) In the Industrial Zone, fencing shall be constructed only out of high quality materials, such as brick piers with open infill, which open infill may include wrought iron, powder coated steel, painted wood pickets or other comparable materials specifically approved by the Council.
- (c) Notwithstanding the desirability of allowing fencing only if it is visually permeable and otherwise compliant with the provisions of this Clause, sections of solid fencing will be permitted where they are required in order for a development to comply with sub-clause 10.6.2(a)(ii). In these cases the Council may require the solid fencing to be visually enhanced and complemented by landscaping areas.
- (d) Notwithstanding Clause 10.15, in the Industrial zone—
  - (i) the use of cyclone link mesh fencing is prohibited for any fence other than a boundary fence; and
  - (ii) the use of barbed wire in any fence is prohibited.
