## Notes and instructions for move on order form —

1. The *Criminal Investigation Act 2006* s. 27(1) allows a police officer to order a person who is in a public place, or in a vehicle used for public transport, to leave it, or a part of it if the officer reasonably suspects that the person is doing one of the things listed in s. 27(1) (see the conduct part of the form).

An officer giving a move on order to a person must take into account the likely effect of the order on the person, including but not limited to the effect on the person's access to the places where he or she usually resides, shops and works, and to transport, health, education or other essential services. (See s. 27(3)).

2. Specify the public place, or vehicle used for public transport, or the part of it, from which the person is being ordered to move.
3. This distance or area must be reasonable (see s. 27(2)(a)).

4. This period must be reasonable and not longer than 24 hours (see s. 27(2)(b)).
5. E.g. tattoos, scars, marks, piercings.
6. Ethnic appearance must be stated and recorded on IMS.

### LOCAL GOVERNMENT ACT 1995

*City of Bayswater*

#### THOROUGHFARES AND TRADING IN THOROUGHFARES AND PUBLIC PLACES LOCAL LAW 2008

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the Council of the City of Bayswater resolved on [date] to make the *City of Bayswater Activities on Thoroughfares and Trading in Thoroughfares and Public Places Amendment Local Law 2008*.

#### 1. Citation

This local law may be cited as the *Thoroughfares and Trading in Thoroughfares and Public Places Local Law 2008*.

#### 2. Principal local laws

In this local law, the *City of Bayswater Activities on Thoroughfares and Trading in Thoroughfares and Public Places Local Law* as published in the *Government Gazette* on 3 January 2001 and as amended and published on 28 December 2001 and as amended and published on 14 September 2007 is referred to as the principal local law. The principal local law is amended as follows—

##### Clause 2.2(1)(h) amended

Clause 2.2(1)(h) is amended to read as follows—

‘(h) fell, poison, remove, replace, ring bark, vandalise or through any other method kill any tree so that the tree falls onto a thoroughfare;’.

##### Clauses 2.2(1)(l) and (m) amended

(i) Clause 2.2(1)(l) is amended by deleting ‘or’ at the end of the clause.

(ii) Clause 2.2(1)(m) is amended by deleting the full-stop at the end of the clause and inserting ‘; or’ in its place.

##### Clause 2.2(1)(n) inserted

New Clause 2.2(1)(n) is inserted in the appropriate order as follows—

‘(n) fell, poison, remove, replace, ring bark, vandalise or through any other method kill any tree on a thoroughfare.’.

#### Schedule 1 amended

Schedule 1 is amended by—

(i) amending the description of the prescribed offence for Clause 2.2(1)(h) to be ‘Killing any tree and causing it to fall onto a thoroughfare without a permit’;

(ii) deleting the amount of modified penalty of ‘100’ for the prescribed offence for Clause 2.2(1)(h) and substituting ‘500’;

- (iii) inserting in the appropriate order, the new clause number '2.2(1)(n)' and description of the prescribed offence for Clause 2.2(1)(n) 'Killing any tree on a thoroughfare without a permit'; and
- (iv) inserting in the appropriate order, the amount of modified penalty of '500' for the prescribed offence for Clause 2.2(1)(n).
