WATER SUPPLY IMPROVEMENTS—CHERITON ROAD, GINGIN

To improve the supply of water in Gingin, the Water Corporation proposes to construct the following—

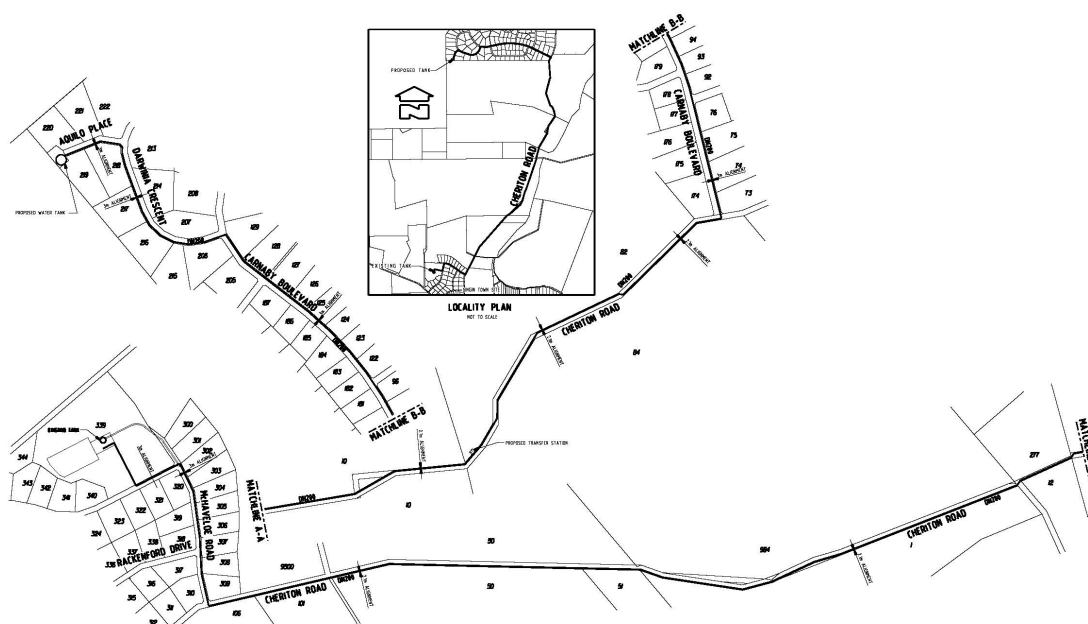

- Water Main—200mm diameter PVC underground water pipeline, approximately 8km long.

The proposed works are scheduled to commence in August 2008 and will continue for a duration of approximately 4 months.

Construction of the proposed works will be via open trench excavation which will be backfilled and verges reinstated.

PROPOSAL TO CONSTRUCT HARVEY SUMMIT TANK

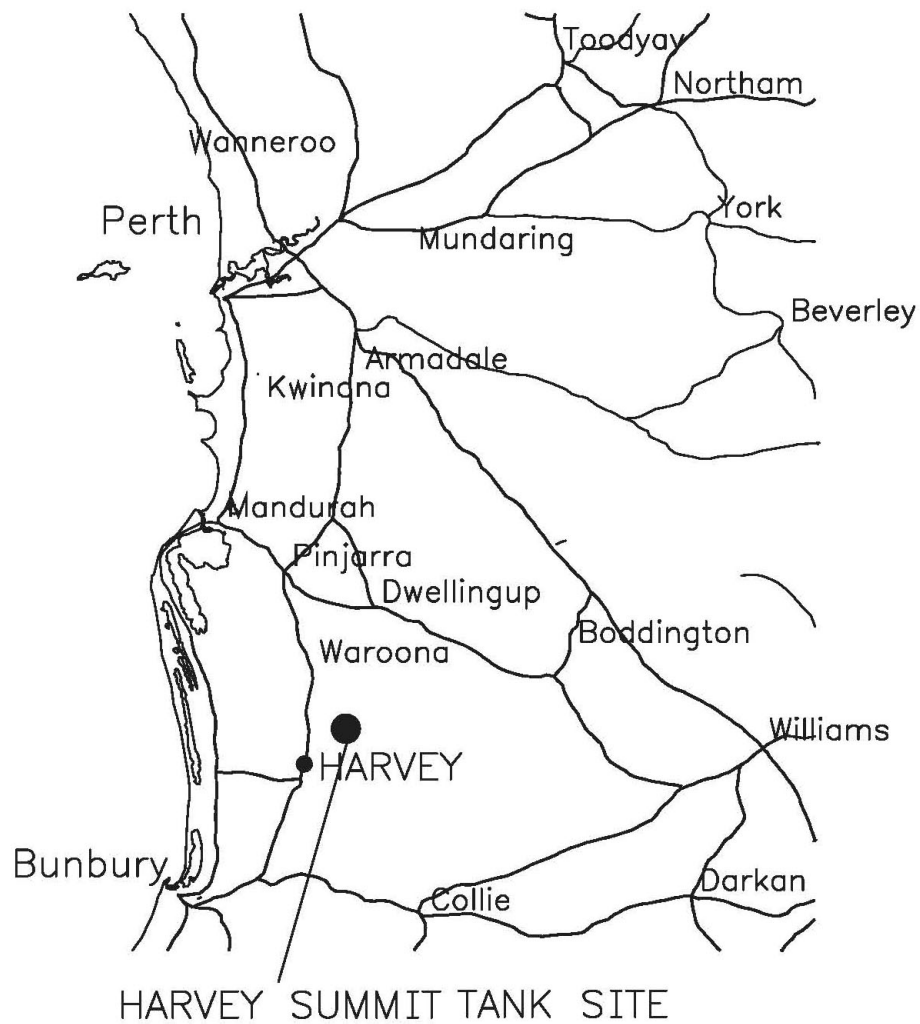
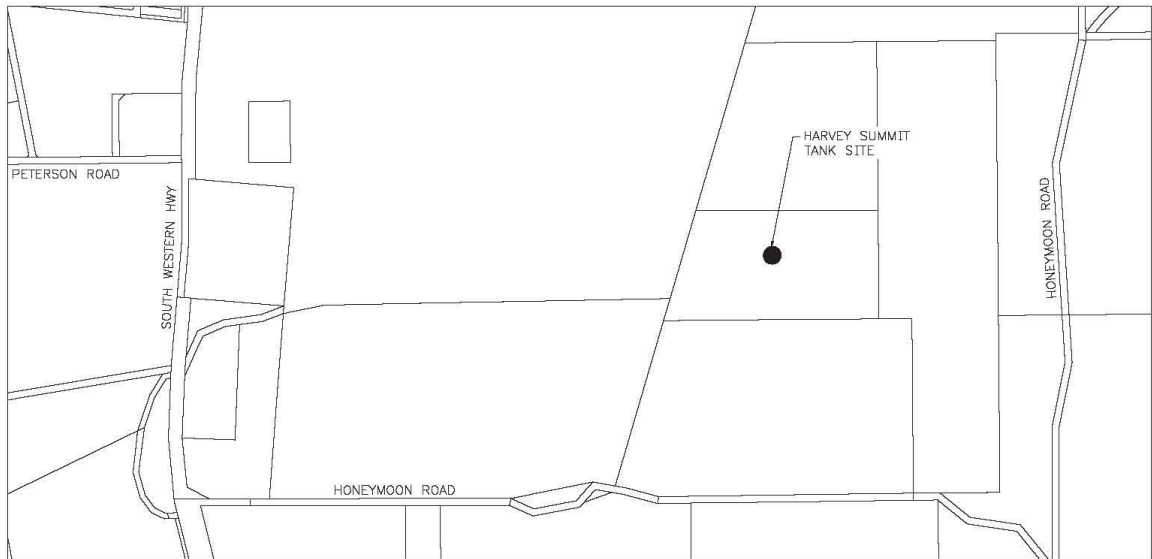
The proposed Southern Seawater Desalination Project has been chosen as the next major water source for Western Australia and will produce around 50 gegalitres of drinking water per year, with the potential to increase to 100 gegalitres. The works will include a desalination plant at Taranto Rd, Binningup, a 30km pipeline and a summit tank near Harvey as shown in the map. This notice is for the construction of the Harvey Summit Tank.

Construction of the tank is scheduled to begin in April 2009 and will continue for approximately 20 months. It is important to note the project will not go ahead until final environmental approvals have been gained.
