### Taxation Administration Amendment Regulations (No. 3) 2008

Made by the Governor in Executive Council.

**1. Citation**

These regulations are the *Taxation Administration Amendment Regulations (No. 3) 2008*.

**2. Commencement**

**4. Regulation 6A inserted**

**6A. Amount for writing off unused credit  
(section 55A(1)(a))**

The amount for the purposes of writing off credits under section 55A(1)(a) of the Act is \$5.01.

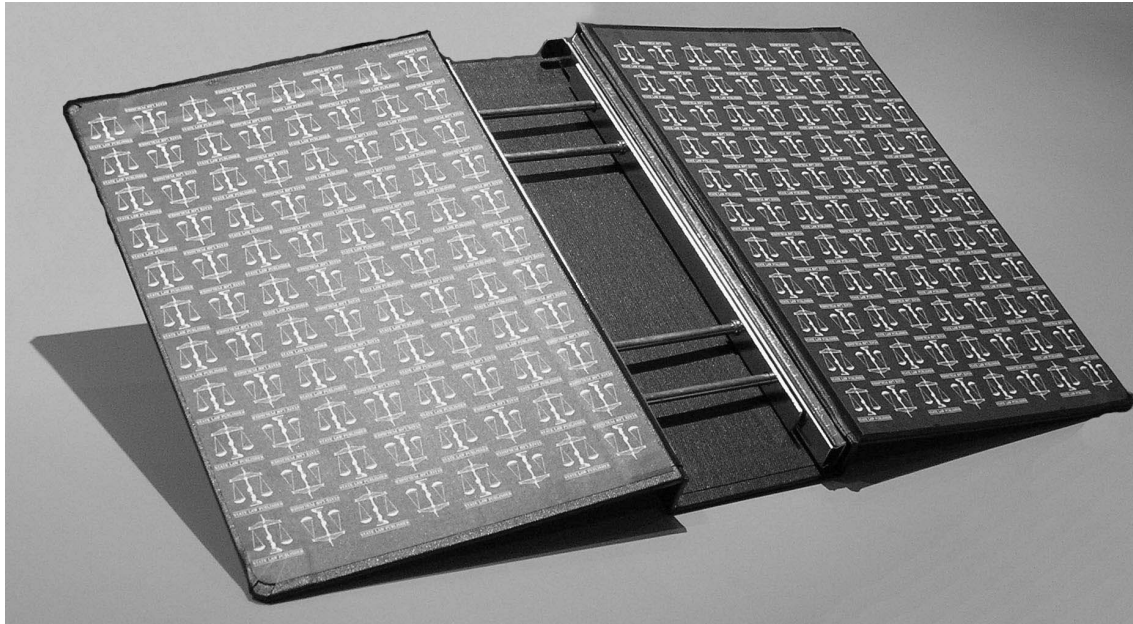
