Motor Vehicle Repairers Act 2003

Motor Vehicle Repairers Amendment Regulations 2009

Made by the Governor in Executive Council under sections 6 and 114 of the Act.

1. Citation

These regulations are the *Motor Vehicle Repairers Amendment Regulations 2009*.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day after that day.

3. Regulations amended

These regulations amend the *Motor Vehicle Repairers Regulations 2007*.

4. Regulation 7H inserted

After regulation 7G insert:

7H. Exemption from requirement for planning certificate

- (1) In this regulation —
relevant day means the day on which the *Motor Vehicle Repairers Amendment Regulations 2009*, other than regulations 1 and 2 of those regulations, come into operation.

- (2) On and after the relevant day, an application by an existing repair business for a business licence is exempt from the operation of sections 13(3)(b), 58(1)(b) and 60 of the Act in respect of each of the premises specified in the application.

Energy Coordination Act 1994

Energy Coordination Exemption Order 2009

Made by the Governor in Executive Council under section 11H of the Act.

1. Citation

This order are the *Energy Coordination Exemption Order 2009*.

2. Commencement

This order come into operation as follows —

- (a) clauses 1 and 2 — on the day on which this order is published in the *Gazette*;
- (b) the rest of the order — on the day after that day.

3. Exemption from s. 11G(1) — developer constructing distribution system

- (1) A person who subdivides land (the *developer*) is exempt from the *Energy Coordination Act 1994* section 11G(1) in relation to the construction of a distribution system for the transportation of gas to lots resulting from that subdivision.
- (2) The exemption provided for in subclause (1) is subject to the conditions set out in subclauses (3), (4) and (6).

- (3) Before construction of the distribution system starts, or within such further time as the Coordinator allows, the developer must provide the Coordinator with evidence to the satisfaction of the Coordinator that the developer has entered into an agreement with the holder of a distribution licence (the *licensee*) making provision for the following matters —
 - (a) the licensee's design and construction requirements for the distribution system;
 - (b) an audit by the licensee or its nominee of the distribution system, after construction is completed, to ensure compliance with the requirements mentioned in paragraph (a) and all relevant statutory requirements;
 - (c) arrangements for the transfer of ownership of the distribution system to the licensee;
 - (d) the allocation of responsibility for maintenance of the distribution system before gas is transported through it;
 - (e) a requirement for the licensee to be given plans and other documentation relating to the distribution system.
 - (4) Before construction of the distribution system starts, or within such further time as the Director allows, the developer must give the Director a written notice that —
 - (a) sets out or is accompanied by information about the design and attributes of the distribution system including pipe pressure, materials to be used in construction and projected gas load; and
 - (b) sets out the name and contact details of the entity with primary responsibility for carrying out construction of the distribution system; and
 - (c) sets out the projected timeframe for construction of the distribution system; and
 - (d) sets out or is accompanied by a map showing the location of the distribution system.
 - (5) The Director may, by written notice given to the developer, specify guidelines that are to be observed in the construction of the distribution system.
 - (6) The developer must ensure that guidelines specified under subclause (5) are observed.
- 4. Exemption from s. 11G(2) — on-sale of gas to residential premises**
- (1) In this clause —

administering body has the meaning given in the *Retirement Villages Act 1992* section 3(1);

residential premises means premises or any part of premises used, or intended to be used, as a person's principal place of residence;

retirement village has the meaning given in the *Retirement Villages Act 1992* section 3(1);

scheme has the meaning given in the *Strata Titles Act 1985* section 3(1);

strata company has the meaning given in the *Strata Titles Act 1985* section 3(1).

- (2) A person (the **supplier**) who sells gas to a small use customer for consumption on residential premises under the control or management of the supplier is exempt from the *Energy Coordination Act 1994* section 11G(2) in relation to that sale.
- (3) For the purposes of subclause (2) residential premises are under the control or management of a supplier if the supplier is —
 - (a) the owner of the premises; or
 - (b) in the case of premises on land to which a scheme relates, the strata company for the scheme; or
 - (c) in the case of premises in a retirement village, the administering body of the retirement village.
- (4) The exemption provided for in subclause (2) is subject to the condition that the amount paid by the small use customer to the supplier for the gas must not exceed the sum of —
 - (a) the volumetric charge for the gas; and
 - (b) any service fee or charge attributable to the supply of the gas,paid or payable by the supplier.

Cancellation of Registration Nurses for Health

 - (b) A nominated team to win the Grand Final either outright or by a nominated points margin.
 - (c) A nominated team to play in the Grand Final.
 - (d) A nominated team or teams to finish in a nominated position at the completion of a nominated round.
 - (e) A nominated player to score the most goals or to score a nominated minimum number of goals at the completion of the qualifying rounds or at the completion of the AFL or WAFL season.
 - (f) A nominated player to score the most goals in a nominated match or round of matches.
 - (g) A nominated team to win the pre-season night competition.
 - (h) A nominated match to result in a draw.
 - (i) A nominated team to achieve the highest winning margin in a nominated round of matches.
 - (j) A nominated team to be leading a nominated match at a nominated time during that match.

 - (l) A nominated team to kick the first goal in a nominated quarter of a nominated match.

 - (n) A nominated team or teams to achieve a nominated score in a nominated match.
 - (o) A nominated player to accumulate the most disposals (total of kicks and handpasses) in a nominated match.
 - (p) Nominate whether the combined total number of points scored by the two teams in a nominated match will be under or over a specified amount.
3. **EVENT:** **Brownlow and Sandover Medal Competitions.**
- CONTINGENCIES:
- (a) A nominated player to win the Medal competition.
 - (b) A nominated player to be placed 2nd, 3rd, 4th or 5th in the Medal Competition.
 - (c) A nominated player to achieve a nominated placing in the Medal competition.
 - (d) A nominated player or players to receive more Medal votes than another nominated player or players.
 - (e) A nominated team to receive more Medal votes than another nominated team or teams.
 - (f) A nominated player or group of players to be awarded more votes than another nominated player or group of players.

- (g) A nominated player to finish in a nominated position or group of positions at the completion of the Medal Count.
- (h) A nominated team for which the Medal winner plays.
- (i) A nominated player to achieve a nominated amount of Medal votes.

- CONTINGENCIES: (a) A nominated player or group of players to win or achieve a nominated placing in a nominated tournament or a nominated round of a nominated tournament.
- (b) A nominated player or group of players to achieve a better score than another nominated player or group of players in a nominated tournament or in a nominated round of a nominated tournament.
- (c) A nominated player or group of players to achieve a hole in one at a nominated hole or group of holes during a nominated round of a nominated tournament.
- (d) A nominated player or group of players to achieve a nominated score in a nominated tournament or at the conclusion of a nominated round of a nominated tournament.
7. EVENT: **CART (Championship Auto Racing Teams) Championship Series, World Formula 1 Motor Racing Championship, NASCAR Series, the Indianapolis 500 Race (Indy500 Race), Australian Touring Car Motor Racing Championship, World 125cc, 250cc and 500cc Motorcycle Racing Championships, Australian 500cc Motorcycle Racing Championship, World and Australian Rally Championships or any other touring car event sanctioned by the Confederation of Australian Motor Sports.**

 (b) A nominated competitor or team to win a Final or Series.
 (c) A nominated competitor or team to beat another nominated competitor or team in a nominated race or series of races.
 (d) A nominated competitor or team to win Pole Position in a nominated race.
 (e) A nominated competitor or team to achieve a nominated placing or result in, or fail to finish, a nominated race.
 (f) A nominated competitor or team to complete a nominated number of laps in a nominated race or series of races.
 (g) A nominated competitor or team to achieve the fastest lap in a nominated race.
8. EVENT: **International and Interstate Rugby League and Rugby Union matches, Super League and NRL Rugby League matches, NSW and Queensland State Competition Rugby Union matches.**
- CONTINGENCIES: (a) A nominated team to win the Grand Final either outright or by a nominated points margin.
 (b) A nominated team to qualify for the finals matches.

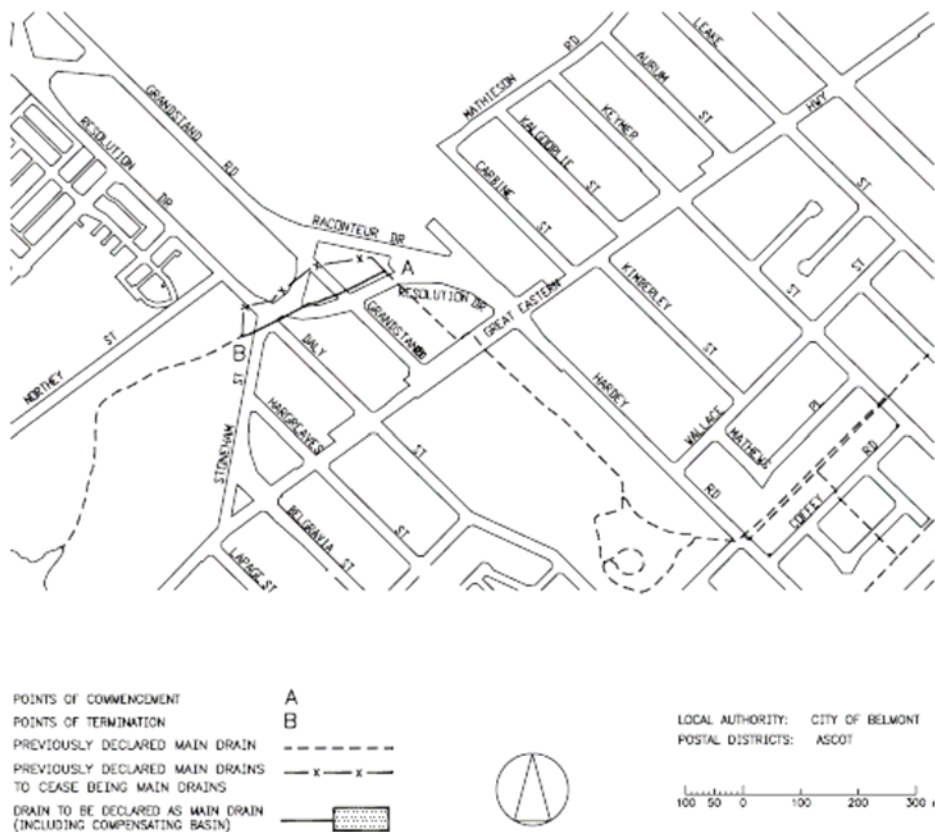

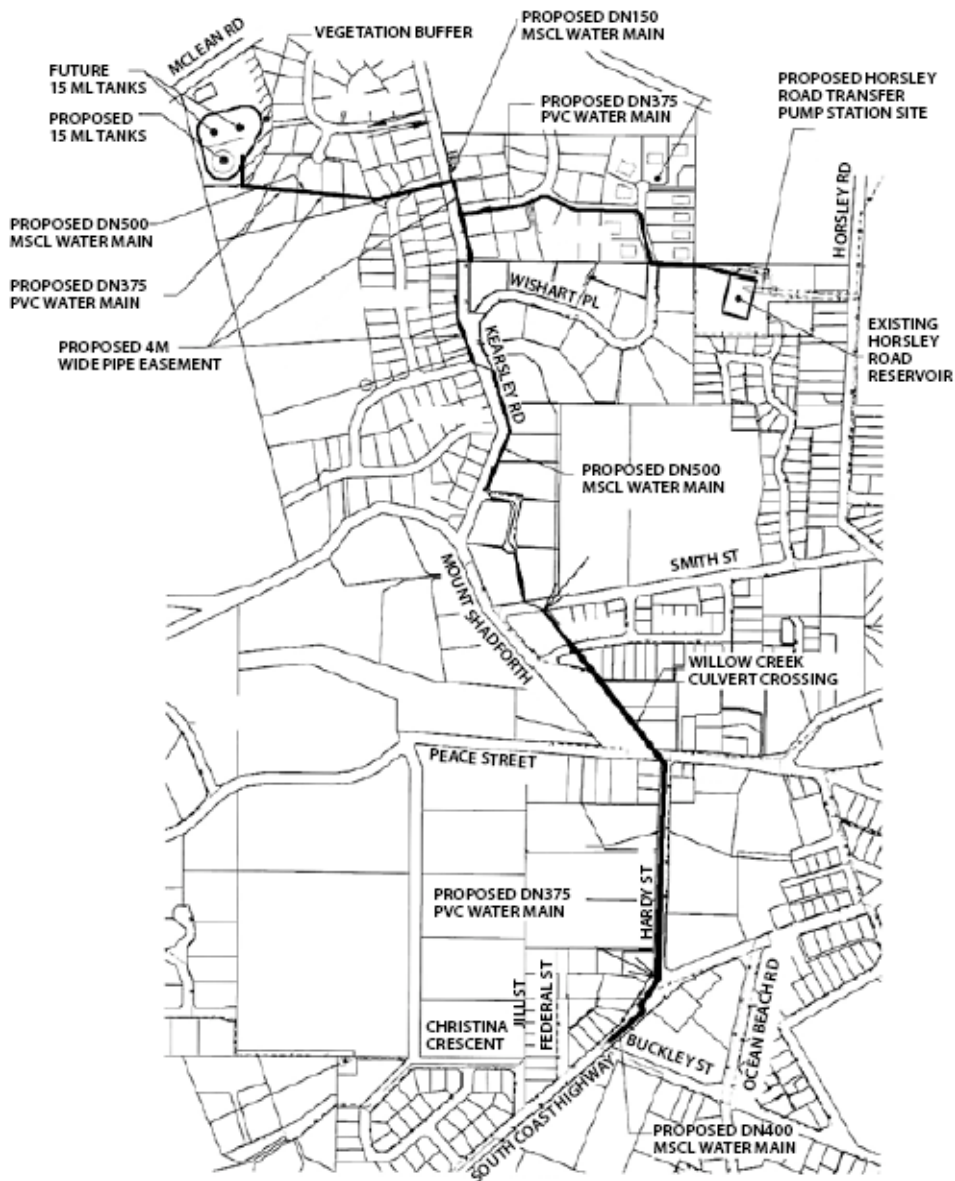
