These regulations are the *Building Amendment Regulations (No. 2) 2009*.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day after that day.

3. Regulations amended

These regulations amend the *Building Regulations 1989*.

4. Schedule 2 amended

RG301*

Racing and Wagering Western Australia Act 2003

Racing and Wagering Western Australia (Sportsbet Rules) Notice 2009

Given by Racing and Wagering Western Australia under section 61 of the Act.

1. Citation

This notice is the *Racing and Wagering Western Australia (Sportsbet Rules) Notice 2009*.

2. Interpretation

In this notice –

“**the Act**” means the *Racing and Wagering Western Australia Act 2003*;

“**the Rules**” means the rules described in clause 3 adopted by Racing and Wagering Western Australia.

3. Rules adopted under section 61 of the Act

(1) The Board of Racing and Wagering Western Australia by resolution dated 14 May 2009 resolved:-

- (a) to adopt and operate under a new set of rules relating to a jointly operated fixed odds wagering system in accordance with section 61(2) and (4) of the Act; and
- (b) to revoke with effect from 29 May 2009
 - (i) the resolution of 19 December 2005 to adopt and operate under rules relating to a jointly operated fixed odds wagering system.

4. Rules published for public information (section 61(6)(c) of the Act

The Rules adopted by resolution on 14 May 2009 are published in the Schedule to this notice for public information as required by section 61(6)(c) of the Act.

Schedule 1 – Adopted Rules

SPORTSBET RULES

1. General

Not Adopted—Refer to RWWA Account opening terms and conditions

2. General Betting Terms & Conditions

2.1 Right to Refuse / Limit Bets

We reserve the right to decline, or limit, any bet a client wishes to place. No bet stands until the operator has called it back to you and confirmed it, or you have received an 'Accepted' message when your bet is processed through our website. Once placed, no bet may be altered or cancelled*.

*Refer to rule 2.2 Conditions of Placing a Bet and 2.3 Correction Of Errors for further information.

2.2 Conditions of Placing a Bet

Bets will generally be accepted up to the official starting time of an event unless stated otherwise. A bet is deemed void (even if accepted) if it's submitted after the official starting time of an event—unless of course 'live betting' or 'betting in the run' is being conducted during the event.

Any leg of a multiple bet is deemed void (even if accepted) if the bet is submitted after the official starting time of that leg. In any such instance the remaining leg(s) of the multiple bet will stand, at the original amount bet.

The official starting time is that stated by the controlling body for the relevant event.

If an event other than an Australian horse racing meeting is abandoned or postponed from the scheduled date, and is not officially scheduled to be replayed or conducted within three (3) calendar days of the original scheduled date, all single bets are void and wagers refunded except where there is a different individual sport rule (eg Tennis, Golf and Winter Sports). If a bet is void at any time, affected multiple bets will be recalculated excluding that leg.

If an Australian horse racing meeting is postponed from the original scheduled date, and is not officially rescheduled to be run within 72 hours of the original scheduled date, all single bets are void and wagers refunded.

In the event that the postponed meeting is rescheduled within 72 hours of the original scheduled date, all bets will stand.

If the venue of the postponed meeting is altered from the original scheduled venue all bets will be deemed void.

Any bets in an 'All In' market on the postponed meeting will stand until the meeting is rescheduled. If the postponed meeting is not rescheduled to be run within 30 days all bets will be deemed void.

If an Australian horse racing meeting is officially abandoned (not rescheduled) all bets will be deemed void.

If a bet is void at any time, affected multiple bets will be recalculated excluding that leg.

2.3 Corrections of Errors

Notwithstanding anything contained elsewhere in these rules, if we publish, post or quote any incorrect betting information for any racing or sporting event, such as posting wrong odds or lines, then regardless of the cause or source of such error—

1. If the error is identified prior to the commencement of the event, all single bets are void and will be cancelled with the bet amount refunded. Where this bet is part of a multiple bet, that leg of the multiple bet is removed and the dividend for the multiple bet is recalculated excluding that leg.
2. If the error is identified after the commencement of the event, the bet shall stand.

The only exception is where we can demonstrate that the error was manifest or obvious or that the customer otherwise should reasonably be aware of the error, when the bet was placed.

2.4 The Dead Heat Rule

In the event of a **tie/dead heat** where dividends were not offered on such an outcome, bets will be paid at face value of the ticket divided by the number of competitors tying for that placing.

In any event for which each way betting is available, place ties will be paid such that the place portion of the face value of the ticket is multiplied by the remaining number of places available and divided by the number of competitors tying for those available number of placings.

In the event of a tie/dead heat where odds were offered on such an outcome, then all win or place bets are losers and the draw option is paid as the winner.

2.5 The Competitor Dependency Rule

Multiple bets are not accepted where the outcome of one part of the bet contributes to the outcome of another, also known as competitor dependency. If such bets are inadvertently accepted, we reserve the right to declare the whole multi bet void and funds will be returned.

2.6 Markets / Odds / Prices

Opening markets are posted as early as practical each week. Exceptions include events whose rounds are spread throughout each week. These include the NHL, NBA, and tennis tournaments etc. For sports like these, the odds are generally framed (pre-determined) on the day prior to the event.

Odds are subject to change at anytime but can be confirmed or updated by telephoning, or visiting our website.

We make every effort to ensure that our publicised odds are correct. But we do not take responsibility for any inadvertent errors and reserve the right to correct them.

2.7 Determining the Payout on Events

Not adopted—refer to RWWA Rules of Wagering—Rule 13

2.8 Bet Limits / Payout Limits

Individual bet limits may be determined on a bet-by-bet basis by a bookmaker.

2.9 Event Venues

Where possible we will follow the European method of listing home teams as the first competitor in any event (excluding American competitions).

We make every effort to list event venues, but accept no responsibility for any neutral venues not being listed as such, or failure to correctly describe event venues.

2.10 Live Betting

2.10.1 Placing Live Bets

Live bets submitted are not actually placed until—

1. if submitted by telephone, the bet has been called back and confirmed by a telephone operator
2. if submitted over the internet, an “Accepted” message has been processed through our website.

In order to ensure the integrity of live betting, live bets may be subject to a time delay as part of the bet placement process.

Where a live bet has been submitted by a client but has not yet been placed as described above, and there is a price change (increase or decrease) in relation to the bet selection, or betting on the market is suspended, the bet will not be placed but will be rejected. The client is then free to submit a new bet at the new price if desired when or while the market remains available for betting.

2.10.2 Prohibition on ‘Live Betting’ (Betting In Run) in Australia

If you are presently in Australia, you agree you will not make or attempt to make a bet on those bet types offered on an event which is currently in progress (live).

Any bet placed on an event either by internet or telephone, not deemed to be “live” constitutes betting after an event has started.

Any bets made in breach of this condition are void.

2.11 Handicap Betting: Push or Tie

Under handicap betting, where the line is specified as a flat number, all bets are declared void and refunded (a push) if the score lands on the line.

All multiple bets (parlays) affected will be recalculated to exclude the ‘push’ leg.

2.12 Minimum Bet Stake for Telephone Betting

Not adopted

3. Sports Terms & Conditions

3.1 Athletics

Overall winner of event markets are on an **all-in** basis. Refunds are not available for non-starters, Payouts will be based on the podium positions. For head to head and group betting refer to individual market rules.

3.2 Australian Rules Football

Payouts are based on the official declared result, but conditions may apply to specific betting options (e.g. end of normal time, including extra time—an extension of normal time—etc).

When the draw option is offered, the bet is decided on the result at the end of normal time (i.e. extra time—an extension of normal time—not included). When the draw option is not offered, the **The Dead Heat Rule** applies.

For match winners and goal kicking options, all players must be in the starting line-up for bets to stand unless otherwise specified. The statistics used by the official AFL website (www.afl.com.au) will be the statistics used for payout purposes.

3.3 Baseball

Games are official after five innings of play. If the home team is leading, the game is official after four and half innings of play. If a game goes past five innings (including

any extra innings) and is subsequently called off, the winner is determined by the score after the last full inning of play (except in the case when the home team score to tie, or take the lead in the bottom half of the inning in which the game is called off—the runs do count). However if any game is in delay or play is suspended and subsequently the game is played to completion (on the original start day or the next) the result will be determined by the final score upon completion of the game.

For run line betting, the game is official after 9 innings if the visitor team is winning and after 8.5 innings if home team winning.

For run totals the game is official after 9 innings (8.5 innings if home team is winning) with the exception that at any time the run total is exceeded the wager is official.

Should either of the nominated pitchers (i.e. the pitchers who throw the first pitch of the game for their teams) withdraw before throwing a pitch, all single bets are void and wagers refunded while affected multiple bets will be recalculated excluding that leg.

All baseball betting is conducted on the understanding the nominated pitchers (i.e. the pitchers who throw the first pitch of the game for their teams) are playing.

If a game is abandoned or rescheduled in its entirety to another date, single bets are void and wagers refunded but multiple bets (parlays) will be recalculated excluding that leg.

3.4 Basketball

Payouts will be based on the official final score, extra time (an extension of normal time) included, unless otherwise specified.

In handicap betting, where the line is a flat number, if the score lands on the line all bets are void and bets refunded. Affected multiple bets (parlays) will be recalculated excluding that leg.

If a game is abandoned, postponed to another date, or fails to meet the above criteria, single bets are void and refunded. Multiple bets (parlays) will be recalculated excluding that leg.

3.5 Boxing

All bets on either boxer to win will be decided by the judges' decision, which includes points, technical knockout (TKO), knockout (KO) or disqualification.

If a price is offered for the draw, in the event of a draw all bets on either boxer to win will be losers.

In round-by-round betting, if a boxer fails to answer the bell, the fight will be deemed to have ended in the previous round.

3.6 Cricket

Limited Overs (including one-day internationals)

In one-day matches shortened by weather the outcome will be that determined by the competition rules.

If the match is declared a 'no-result' all single bets are void and bets refunded. Affected multiple bets will be recalculated excluding that leg.

For batting or bowling match-ups both batsmen must reach the crease or both bowlers must bowl one ball for bets to stand. Otherwise all bets are void and bets refunded.

If the match is abandoned before a batsman is dismissed or has passed the other batsman's score then bets are void.

If the match is abandoned before a bowler can complete his allotted overs or take more wickets than the other bowler then bets are void.

Affected multiple bets will be recalculated excluding that leg.

If a match is transferred to a reserve day all bets accepted prior to the toss of the original game will carry over. All bets accepted after that time are void and bets refunded. Affected multiple bets will be recalculated excluding that leg.

Test Cricket (including other non-limited overs)

In the event of a tie—i.e. where both teams have completed two(2) innings each and have the same score—all bets to win on either team will be paid as per **Dead Heat Rule**. Bets on the draw will be losers.

At least one ball must be bowled for bets to stand—otherwise all single bets are void.

For bets to stand in batting or bowling match-ups, both batsmen must reach the crease or both bowlers must bowl one ball. Otherwise all single bets are void and bets refunded. Affected multiple bets will be recalculated excluding that leg.

For series betting we pay on official result. For exact series result betting all scheduled matches must commence for bets to stand..

Betting on Australian domestic cricket is based on the most points awarded in the match.

3.7 Cycling

In cycling events, betting is on an **all-in** basis. Refunds are not available for non-starters and bets will stand, unless otherwise specified.

Payouts will be based on the podium positions.

3.8 Darts

For bets to stand, both players must start a match and the match must reach full completion.

3.9 Field Hockey

Betting is based on regulation time. Extra time (an extension of normal time) is excluded unless otherwise specified.

3.10 Golf

Tournament betting and betting on tournament groups with nine players or more

For bets on a particular player to stand, that player must tee-off. Playoffs are included in determining the winner and every player beaten in a playoff is deemed to have tied for second. If a player is disqualified, only completed rounds prior to the round, where the disqualification occurred, will count.

If a tournament is shortened after commencement then a minimum of 36 holes must be played for bets to stand.

Bets accepted after the end of a day's play are void unless there is further play, which counts towards the result of the tournament (other than a playoff), or the betting is specifically stated to be on the outcome of a playoff.

If a tournament is officially abandoned, all bets on the tournament are void, except options that have already been decided.

Single betting and betting on tournament groups with eight players or less

Both players (or all players in group) must tee off for bets to stand. Playoffs are excluded.

The winner is the player who plays the most holes (excluding playoffs). If they are equal on holes, the best score wins. Holes played in a round that is subsequently abandoned, or for any reason not counted towards the result of the tournament, do not count.

Single Round Betting (two balls, three balls, groups)

Both players (or all players in the three ball or group) must tee off and 18 holes completed for bets to stand.

Where no tie or draw option is offered, the **Dead Heat Rule** applies. Playoffs are excluded unless otherwise stated.

The winner is the player who plays the most holes (excluding playoffs). If they are equal on holes, the best score wins. Holes played in a round that is subsequently abandoned, or for any reason not counted towards the result of the tournament, do not count. If a round, or part of a round is postponed to another day, wagers placed on single round betting will stand.

Make The Cut Betting

For bets to stand, the named player must play 36 holes (or 54 or 72 holes where the cut is made at that point).

A player is deemed to have made the cut if the player is eligible to play in the round after the cut is made (even if the player chooses not to do so). If a player is not eligible to do so (even if the rules for the cut have been changed during the tournament) that player is deemed to have missed the cut.

3.11 Gridiron / American Football

Payouts will be based on the official final score, including extra time (an extension of normal time).

Under handicap betting, where the line is specified as a flat number, all bets are declared void and refunded (a push) if the score lands on the line. All multiple bets (parlays) affected will be recalculated to exclude the 'push' leg.

First-half lines and bets relate solely to the score in the first half. The first half must be completed for such bets to stand. Second half/half time lines and bets relate solely to the score in the second half (including any extra time, i.e. an extension of normal time).

3.12 Handball

Payouts are based on the score at the end of normal time. Extra time (an extension of normal time) will not count unless specified.

3.13 NHL (National Hockey League)

Outright/Handicap Betting/Totals

When the draw option is included, payouts are based on the score at the end of normal time (extra time, i.e. an extension of normal time, not included). In handicap and totals betting, extra time is included.

When the game total is a 'flat' number (e.g. seven), and if the total score lands on that number, all bets are void and wagers refunded. Multiple bets will be recalculated excluding that leg.

Pick The Score Betting

Is based on the score at the end of normal time (i.e. extra time—an extension of normal time—is not included).

If a game is abandoned, or postponed to another date, all single bets are void and wagers refunded. Affected multiple bets will be recalculated excluding that leg.

Total Goals For Day

All of the day's games set down for decision must reach their official conclusion or bets are void. The exception being that if the total is exceeded without all games being played to their official conclusion then bets will stand.

3.14 Non-NHL Ice Hockey Games

Bets are determined on the result after normal time (extra time—an extension of normal time—not included). In World Cup games, shoot-outs count in determining the winner.

Pick The Score

Betting is based on the score at the end of normal time (i.e. extra time—an extension of normal time -not included).

When a game starts, but is subsequently abandoned and/or stopped before the completion of normal time, even if a result is declared by the governing association of the match or the event, all bets are void excepting those that may already have been decided.

3.15 Motor Racing

Podium placings determine the standings for the settlement of bets.

Classified/Not Classified is paid based on whether the driver has been 'classified' by the ruling body. (See FIA Rules 166-169)

In match-ups or group betting, those participants must line up on the official starting grid for bets to stand. The official starting grid is the grid after the warm up lap.

For betting on drivers' and constructors' championships, the result is declared once the podium positions for the final listed event are known. Post-podium, we do not recognise overturned decisions for betting purposes.

3.16 Rugby League

Payouts are based on the official declared result. Conditions may apply to specific betting options (e.g. end of normal time, including extra time—an extension of normal time—etc).

When the draw option is offered, the bet is decided on the result at the end of normal time (i.e. extra time—an extension of normal time -not included). When the draw option is not offered, the **Dead Heat Rule** applies.

3.17 Rugby Union

Payouts will be based on the official declared result, but conditions may apply to specific betting options (e.g. end of normal time, including extra time—an extension of normal time—etc).

Where the draw option is offered, the bet is decided on the result at the end of normal time (i.e. extra time—an extension of normal time -not included). Where the draw option is not offered, the **Dead Heat Rule** applies.

3.18 Snooker

For bets to stand, both players must start a match and the match must reach full completion.

3.19 Soccer / Football

3.19.1 General

Bets are determined on the result after normal time. Normal time includes any stoppage time added by the referee. The result is the official result as first declared by the governing association of the match or the event, as the full time result, notwithstanding any later changes of the official result and/or errors, unless otherwise stipulated.

Where odds are offered for both the 'normal time' result and the 'outright' result, (e.g. cup finals, etc.), you have the option of betting on either outcome.

When betting on 'first goal scorer' own goals (goals accidentally scored by the opposition for the other team) do not count unless otherwise specified.

When betting on 'number of cards' for the match, one red card beats any number of yellow cards unless otherwise specified.

3.19.2 Each Way First Scorer

- a. Singles and upwards accepted.
- b. The place part of each way bets will be settled at one third the odds on the first, second and third goals. Players who do not score until after three goals have been scored will be treated as losing selections. However, where one of the first three goals is an own goal then the bet will carry forward to the fourth goal and two own goals to the fifth goal etc.
- c. If less than three goals are scored then settlement will be based on the actual goals scored. Where no goals are scored all each way bets will be treated as losing selections.
- d. Where a player scores the first goal, both the win and place part of the bet are successful and will be settled at the appropriate win and place odds. If the same player scores the second or third goal no additional winnings will be paid.
- e. Where a player scores the second or third goal, the place part of the bet is successful. If the same player scores the second and third goals, no additional winnings will be paid for the third goal.
- f. Where the selection does not take part, or comes on after the first goal is scored, both the win and place part of the bet will be void, unless the first goal is an own goal, in which case bets will stand.
- g. Players that are substituted/sent off before the first goal is scored are treated as losing selections in both the win and place part of the bet.
- h. Each way bets on no goalscorer or last goalscorer are not accepted and if taken in error will be settled "all up to win", i.e. the total stake will be invested as a win only bet.
- i. Each way selections are not accepted in first goalscorer/correct score doubles and if taken in error will be settled "all up to win".
- j. Place only bets are not accepted and if taken in error will be settled as each way with the stake divided.
- k. Own goals do not count.
- l. Extra time does not count.

3.20 Table Tennis

Pay on official result as declared by the applicable governing body. Matches must start and be completed for match bets to stand. If a match does not start or ends prematurely for any reason, all single bets on that match are void and wagers refunded, while affected multiple bets will be recalculated excluding that leg.

3.21 Tennis

If a match ends prematurely due to either player's retirement or disqualification, all single bets are void and wagers refunded, while affected multiple bets will be recalculated excluding that leg.

For sets betting, if the match doesn't start, or is unfinished due to either player's incapacity or disqualification, then all single bets are void and bets refunded. Affected multiple bets will be recalculated excluding that leg.

If a game is postponed and rescheduled, all bets stand. If the game is not played, all single bets are void and bets refunded. Affected multiple bets will be recalculated excluding that leg.

Bets stand regardless of any change of venue or court surface.

3.22 Winter Sports

Upon postponement of any event (e.g. due to bad weather) all bets stand until the event takes place. If the event is re-scheduled to another venue then all single bets are void and wagers refunded. Affected multiples will be recalculated excluding that leg.

Unless otherwise stated, betting is on an 'all-in' basis. (No refunds for non-starters)

Payouts will be based on the podium positions

In the event of a tie, all bets to win will be paid as per **Dead Heat Rule**

Head-to-Head and Group Betting

- Downhill and Super G: All skiers must leave the start gate and at least one competitor must complete the event for bets to stand. If all skiers fail to finish, all bets will be void.
- Slalom and Giant Slalom: All skiers must leave the start gate and at least one skier must complete both runs for bets to stand.
- Nordic Combined: Both jumpers/skiers must start both the 1st and 2nd part of the event for Head to Head bets to stand. All jumpers/skiers must start the first part of the event (irrespective of whether this is Ski Jumping or Cross Country) for Group bets to stand. If no listed jumpers/skiers finish the 2nd part of event then all Head to Head and Group bets are void.

- **Ski Jumping:** All jumpers must jump at least the first run for bets to stand.
- **All Other Winter Sports Head-to-Head Betting:** All skiers, teams, jumpers must leave the start line and at least one competitor must finish for bets to stand.

3.23 Other Sports

Bets are decided on the official result as declared by that particular sports governing body.

3.24 Water Polo

Outright betting—When the draw option is included, payouts are based on the score at the end of normal time (end of 4th quarter)—extra time and penalties are NOT included.

Handicap Betting/Total Goals—payouts are based on final result, both extra time and penalties (if played) are included.

When the goals total is a 'flat' number (e.g. seven), if the total score lands on that number, all single bets are void and stakes are refunded. Multiple bets are recalculated excluding that leg.

4. Racing Terms & Conditions

4.1 Definitions

All-in: Regardless of whether or not a particular runner starts or completes the event on which a bet is placed, all bets stand and no refunds shall be payable.

Betting Receipt: A receipt (ticket) issued in accordance with these rules, including any form of electronic record.

Dead Heat: Occurs when two or more runners are officially declared to have finished equal. This applies to both winners and place-getters in a single race. Payout on runners involved in a dead heat is equal to the face value of the bet divided by the total number of runners involved in the dead heat.

Dividend: The agreed payout or return, including any stake, on a bet.

Each Way: A bet that combines a win and a place on the same selection. The place odds are derived from the win odds by means of a divisor (typically 1/4 for 3 places)—as opposed to a 'Win & Place' bet—where the place odds can be set independently of the win odds.

The stake is applied to each 'line' (for the win portion and the place portion). If the selection wins, then both the win and the place dividends are paid. If the selection places, then only the place dividend will be paid.

The number of place dividends paid (typically 3) may vary according to the conditions of the event—these are known as the "Place Terms".

Each Way Multi: When Each way (or Win & Place) legs are used together in a Multi, the only 2 'lines' (combinations) used are—all of the wins together and all of the places together.

Exotic Bet: Not adopted

Fixed Odds: The dividend you receive at the time you place your bet is fixed and does not change no matter how the market fluctuates (with the exception of deductions to betting in the event of a late withdrawal, in which case the deductions are as per official announcements)

SuperOdds: Not adopted

Maxi Bet: Not adopted.

Odds: The figure by which you multiply your stake to calculate your potential winnings. Also known as 'price'. Either—

1. When expressed in monetary terms, the return for an outlay of a certain monetary unit, inclusive of the unit of outlay, or
2. When expressed in fractional terms, the ratio of win to stake agreed to at the time the bet is made.

Place Terms: Where any form of place betting is available (Each Way, Win & Place, Place Only) the number of places to be paid out and (for Each Way) the divisor used to derive the place odds forms the Place Terms for that event.

Rules: The Terms and Conditions contained herein, as amended from time to time, including explanation of terms and jargon as stated in the terms and Conditions and Help pages.

Racing Bet: Any bet or wager made on a racing event.

SuperNSW Odds: Not adopted

SuperVIC Odds: Not adopted

Stake: The monetary outlay by the client in placing a bet.

Win: The profit portion of a dividend. That is, dividend less any stake wagered by the client.

Win & Place: A bet that combines a win bet and a place bet on the same horse where the place odds are independent of the win odds (as distinct from Each Way).

Jockey Challenge: Is betting on a jockey achieving the highest aggregate points scored in races conducted at a particular race meeting or over a specified period. e.g Spring Carnival

4.2 Determination of Results

4.2.1 Racing Betting General

Determination of Result: Unless otherwise agreed all racing bets will be settled on the official declaration of the result of the race made by the relevant racing authority on the day of the race.

The result will not be affected by subsequent processes or amendments to placings.

In the Run or Live Betting: Unless otherwise agreed bets will only be accepted after the commencement of an event if the event is covered by the 'Live Betting' service.

For all other events any bets placed after the commencement of an event shall be deemed void.

4.2.2 Payment of SuperOdds Dividend exotic bets where no official dividend is declared on the correct finishing order

4.3 Australian Racing Betting

Futures Betting: Markets are made available on an **all-in** basis as early as possible. Usually this will occur soon after the closing date for nominations.

With no guarantee of a start there are no refunds on **all-in** bets if a runner does not run. Consequently there are no deductions from the price taken. In a large field prices are usually longer at this stage than they will be closer to race date.

When the final field is declared a few days before the race, the conditions of placing a win or each way bet change and a start is then guaranteed.

Bets placed after the declaration of the final field are refunded if subsequently withdrawn and bets on the remaining runners may be subject to a deduction determined by the price of the scratched horse.

Multi bets (features doubles) remain on an **all-in** basis after the final field is declared.

Pre-post: Pre-Post markets are available for most metropolitan and other selected race meetings from approximately one hour prior to the first race.

Deductions: A percentage reduction of the dividend due to late withdrawal or a scratching.

4.6 Jockey Challenge

Unless otherwise specified by the market rules (typically for Jockey Challenge based on events outside of Australia) ;

'Jockey Challenge' is betting on a jockey achieving the highest aggregate points scored in races conducted at a particular race meeting or over a specified period. e.g Spring Carnival

The winner will be the jockey who has the most points accumulated at the end of the meeting, specified races or period. Points will be accrued per race and calculated as follows—

- 3 points for a winning ride
- 2 points for a second placed ride
- 1 point for a third placed ride.

Betting on the Jockey Challenge is Win Only. In the case of two or more jockeys finishing the day on the same amount of points the Dead Heat Rule applies. This is regardless of the amount of outright winners ridden by either of these jockeys.

All wagers on Jockey Challenge are on a 'All-in' basis.

In the event of a race meeting being abandoned or postponed all bets are void and monies are to be refunded except as in the following two scenarios;

1. In the event of a race meeting not being completed as originally programmed all bets shall be deemed void and monies are to be refunded, except when it is determined by Racing NSW Stewards that a jockey has an unassailable lead, in which case all bets stand.
2. In the case of a Jockey Challenge betting on a racing carnival race meeting which is not completed in its entirety, all bets shall be deemed void and monies are to be refunded, except when it is determined by Racing NSW Stewards that a jockey has an unassailable lead, in which case all bets stand.

Points will only be allocated to the jockey(s) who actually ride the winning or placed horse(s) in a race. Points will not be allocated to any rider who may have been engaged to ride a horse but was subsequently replaced by permission or direction of the Stewards.

There will be no refunds of bets should a jockey be replaced by another rider.

Payment will be declared at the end of each race meeting or a racing carnival, unless otherwise directed by the Stewards.

Note: The option 'Any Other Individual Jockey' covers any jockey in the particular meeting whose odds are not listed in the market.

FIREBREAK ORDER 2009 / 2010

Notice to all owners and / or occupiers of land in the Shire of Dandaragan

Notice is hereby given to landowners / occupiers within the Shire of Dandaragan that firebreaks must be installed by 1st November and maintained clear of inflammable material up to and including 30th April as per the requirements in relation to Section 33 of the *Bush Fires Act 1954*.

RURAL FARM / FIREBREAKS**Properties 20 hectares (50 acres) or larger**

1. Clear a firebreak consisting of mineral earth, to a width of no less than 3m, as close as practical, inside the external boundaries of the property.
2. Firebreaks must be maintained to provide a vertical clearance of a minimum 3.5m so as to allow adequate access for fire appliances, to the satisfaction of the Council's appointed officers.
3. Construct a 5m mineral earth firebreak immediately surrounding all buildings and fuel storage areas.
4. Areas cleared and piled for burning require a 20m mineral earth firebreak.
5. An approved fire fighting appliance is required to be present in any paddock being harvested whilst crop harvesting, straw raking and bailing are being carried out during restricted and prohibited periods. The fire fighting unit must be in a state of readiness and have a minimum of 400 litres of water on board.
6. Harvesting is permitted on Sundays and all public holidays, with the exception of Christmas Day, Boxing Day and New Years Day.

ALL OTHER NON URBAN LAND (rural residential, rural development)**Properties 2,023m² (half an acre) to 20 hectares (50 acres)**

This category relates to nearly all lots in all industrial estates and the subdivisions of Jurien Bay Heights, Alta Mare, Marine Fields, Koorngal Vale and Hill River Heights.

1. Clear a 3m wide mineral earth firebreak (clear of all inflammable material) with a vertical clearance of 4m high, clear of any obstructions immediately inside or as close as practical inside all external boundaries of the property to all unobstructed movement of emergency vehicles.
2. On heavily vegetated or grassed blocks, implement supplementary fuel reduction for a further 5m inside the firebreak, to the satisfaction of Council's authorised officers.
3. Clear all inflammable material within 20m of all buildings to construct a 20m circle of safety. This can be maintained through domestic grass, mulch or slashed native grasses.

URBAN LAND (all townsites)**Land 2,023m² (half an acre) or less**

Clear land of all inflammable material ie debris, dry grass, dry bush etc, to the satisfaction of Council's authorised officers.

Land larger than 2,023m² (half an acre)

Clear a 2.5m wide firebreak of all inflammable material, immediately inside the external boundaries of the land, to the satisfaction of Council's authorised officers.

PLANTATIONS**Tree plantations of more than 3 hectares but less than 10 hectares**

Construct a 10m wide mineral earth firebreak with a vertical clearance of 4m high, clear of all inflammable material immediately surrounding the plantation (adjacent areas of the same property are subject to provisions as for rural areas).

Plantations larger than 10 hectares

Comply with the Code of Practice for Timber Plantations in Western Australia Guidelines for Plantation Fire Protection. A copy is available from the Shire of Dandaragan Administration Centre upon request.

ALTERNATIVE ALIGNMENTS and VARIATIONS TO FIREBREAK NOTICES

If it is impractical to have a firebreak immediately inside a boundary, for environmental or any other reason(s), you are required to apply to the Shire of Dandaragan in writing, before 1st October to obtain permission for firebreaks to be installed in an alternative position or for alternative measures to be put in place. Once approval is granted, there is no need to re-apply each year, unless circumstances change or a duly appointed officer feels that the conditions of the Firebreak Variation notice are not being met.

HARVEST / MOVEMENT OF VEHICLES BANS

A ban on harvesting and the movement of vehicles in paddocks (except for the watering or movement of stock) is likely to be imposed when the predicted weather conditions are classified by the Bureau of Meteorology as very high or extreme.

All such bans are at the discretion of the Chief Bush Fire Control Officer or a duly appointed person.

ADDITIONAL RESPONSIBILITIES AND PENALTIES

Persons who fail to comply with the requirements of this Order may be fined up to \$1,000. In addition, Council can arrange for the required work to be carried out at the cost of the owner / occupier.

Gas or electric barbecues ONLY, are permitted during prohibited burning times.

A permit to burn must be obtained during the restricted burning period. Permits are generally subject to a number of conditions but will NOT be issued for burning on Sundays or public holidays, unless approved by the Chief Bush Fire Control Officer.

Prior to any burning you are required to notify your neighbours, Fire Control Officer and the Shire of Dandaragan on 9652 0800. If the burn is to be carried out on any land that is joining or adjacent to land that is managed or controlled by the Department of Environment and Conservation your local Department of Environment and Conservation office is to be notified by telephoning 9652 1911.

Besides being responsible for the safety of your own property, if a fire escapes from your property, you may be liable to pay compensation for any damage caused outside of your property—this could be very costly.

Public infrastructure must not be placed in a manner that results in an aboveground encroachment into the firebreak area.

Trees must not be planted in a manner that results in vegetation encroaching into the firebreak area.

RESTRICTED and PROHIBITED BURNING PERIODS

Prohibited burning period 1st November to 28th February—STRICTLY NO BURNING.

Restricted burning period 19th September to 31st October and 1st March to 1st May—PERMITS ARE REQUIRED.

No burning is permitted over the EASTER holiday period (Good Friday and the three days immediately following Good Friday).

No camp fires are permitted between the 1st November and the 31st March including for the purpose of cooking.

Persons who fail to comply with the requirements stated in this Order may incur penalties, either by way of infringements or prosecutions, as defined in the Bush Fires Act 1954 Regulations and Infringements.

In addition should the property owner / occupier fail to comply with this Order, the Shire of Dandaragan can, at any time after the specified dates enter the property to carry out the required work, where the owner / occupiers will then be liable for all penalties and costs incurred.

If the requirements of this Order are carried out by burning, such burning must be carried out in accordance with the relevant provisions of the *Bush Fires Act 1954*.

The requirements of this Order are considered to be the minimum standards of fire prevention to protect not only individual properties, but also the district generally.

In addition to this Order, the Shire of Dandaragan may issue separate special orders on owners / occupiers if a particular fire hazard removal is deemed necessary.

The Council no longer installs firebreaks for ratepayers, Council recommends that you contact local contractors as soon as possible to ensure the requirements of this notice are carried out.

The firebreak notice previously published in the *Government Gazette* No 157 on the 16 September 2008 is hereby revoked.

Applications are invited for the grant of geothermal exploration permits for available mainland predetermined areas, **within Petroleum 1:1 000 000 map sheets Perth SH50, Kalgoorlie SH51, Nullarbor Plain SH52, Albany SI50, Esperance SI51 and Eyre SI52 under the jurisdiction of the Petroleum and Geothermal Energy Resources Act 1967 as identified on the attached plan.**

Applications will be received up until 4.00 pm on Thursday, 20 August 2009. Applicants need to observe the closing time and date. Any applications received after the closing time and date will not be considered.

APPLICATION DETAILS

This release is limited to blocks and part blocks landward of the mean high water mark (mainland coastline only) and does not include any coastal waters or islands.

For geothermal exploration permits, each application must identify one of the predetermined areas of approximately 80 contiguous 5' x 5' graticular blocks (as outlined on the release map). A single application may not include blocks from outside the predetermined area, however, applications for multiple areas are allowed.

Applicants will need to specify the area number reference identifying the area pertaining to their application (as outlined on the release map). Details of the area reference numbers and graticular block numbers making up each of the areas are available on the Release Area CD and from the Department's website www.dmp.wa.gov.au/6060.aspx.

Geothermal exploration permit applications shall specify a clear and concise work program and rationale (minimum number of wells to be drilled and their depth, line kilometres of seismic, geophysical surveys, etc.) to be carried out and estimated expenditures for **each of the six years** for each application.

This release requires that a minimum of **one shallow well (i.e. approximately 400 metres) will need to be drilled during the first two years of the geothermal exploration permit.**

Critical to any application made is the program of work proposed for each of the years of the six year term. Applications are to be made in accordance with Section 30(1) of the *Petroleum and Geothermal Energy Resources Act 1967*. Consideration of an application for the grant of a geothermal exploration permit shall take into account work programs relative to the whole of the area applied for, the adequacy of the work program, the applicant's technical and financial ability to undertake the work, and will need to specify the depth of any well and provide geological rationale. Permits are awarded on the understanding that the first two years work commitment will be fulfilled without variation.

Where there is more than one applicant to the application, the percentage participating interests of each party to the application is to be supplied including evidence that a satisfactory settlement has been, or can be, reached on a Joint Operating Agreement (a copy of a Heads of Agreement dealing will generally suffice).

Applicants should also make themselves aware of the existence of any areas of which have the potential to restrict exploration activities, e.g., National Parks, Nature Reserves, Petroleum Titles, Mining Titles, World Heritage Areas, and Conservation Reserves.

Applicants will also need to be aware of the requirements of the *Rights in Water and Irrigation Act 1914*.

Insofar as reserved land is concerned, entry for exploration purposes is subject to approval by the Minister.

Any applications over the Release Area may be the subject of the future act, right to negotiate provisions of the Commonwealth *Native Title Act 1993* (NTA). If the NTA applies, then the application will be managed in accordance with the State Negotiation Protocol, and the Negotiation in Good Faith Requirements.

Applicants should also be aware that the area available to application is subject (at least in part) to Registered Native Title claims. Plans showing these claim boundaries are available as part of the release package.

An information package on the release area detailing the criteria for assessment of applications and the conditions to apply following the award of a geothermal exploration permit, and including a plan of the release area and an application proforma, is available on CD. Copies of the CD can be obtained from the Petroleum and Environment Division, Department of Mines and Petroleum by contacting the Titles Officer (Releases) on (08) 9222 3106.

LODGEMENT OF APPLICATIONS

Applications, together with supporting data, should be submitted in the following manner and accompanied by fee of \$3,900.00 per application area (non-refundable) payable to the Department of Mines and Petroleum through an Australian bank or by Australian bank cheque.

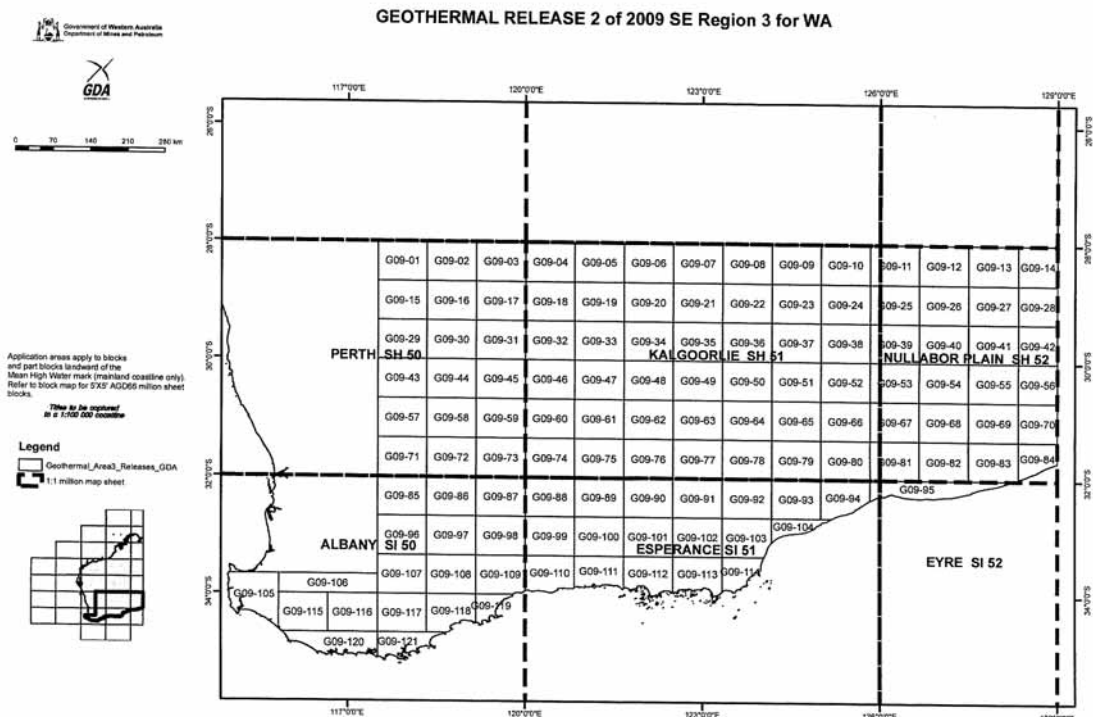

Amendment to the Instrument of Delegation to local governments of certain powers and functions of the Western Australian Planning Commission as gazetted on 19 December 2008

Under section 16 of the *Planning and Development Act 2005* (the Act) the Western Australian Planning Commission (the WAPC) may, by resolution published in the *Government Gazette*, delegate any function to a local government, a committee established under the *Local Government Act 1995* or an employee of a local government.

In accordance with section 16(4) of the Act, a reference in this instrument to a function or a power of the WAPC includes and extends to, without limitation or restriction, any of the powers, privileges, authorities, discretions, duties and responsibilities vested in or conferred upon the WAPC by the Act or any other written law as the case requires.
