**Gas Standards (Gas Supply and System Safety)  
Amendment Regulations 2009**

Made by the Governor in Executive Council.

**1. Citation**These regulations are the *Gas Standards (Gas Supply and System Safety) Amendment Regulations 2009*.**2. Commencement**

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day after that day.

**3. Regulations amended**

These regulations amend the *Gas Standards (Gas Supply and System Safety) Regulations 2000*.

**4. Regulation 25 amended**

(1) Before regulation 25(1) insert:

(1A) In this regulation —

**contractor**, in relation to a network operator, means a contractor or subcontractor to the operator;

**employee** —

- (a) in relation to a contractor, means a person employed or engaged by the contractor;
- (b) in relation to a network operator, means a person employed or engaged by the operator.

(2) In regulation 25(1) after “employee” insert:

or contractor

(3) After regulation 25(1) insert:

(2A) A contractor to a network operator must ensure, so far as is reasonable and practicable, that any employee engaged in carrying out a prescribed activity —

(a) is provided with —

- (i) copies of any documents provided to the contractor by the network operator under subregulation (1)(a); or
- (ii) other documents approved by the network operator that set out appropriate work standards, procedures and practices;

and

- (b) is given instruction and training, and tested for competency, in a manner approved by the network operator, in how to safely apply and use the standards, procedures and practices set out in those documents.

Fish Resources Management Act 1994

**Fish Resources Management Amendment  
Regulations (No. 4) 2009**

Made by the Governor in Executive Council.

**1. Citation**

These regulations are the *Fish Resources Management Amendment Regulations (No. 4) 2009*.

**2. Commencement**

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day after that day.

**3. Regulations amended**

**4. Regulation 3 amended**

***complying drop net*** means a drop net that —

- (a) is not more than 1.5 metres at its widest point; and
- (b) is so constructed that when set —
  - (i) its side or sides collapse so that its netting lies flat on the ground; and
  - (ii) its netting is not capable of ensnaring or entangling a fish;

(b) in the definition of *fishing net* delete paragraph (c) and insert:

(c) a complying drop net;

**5. Regulation 40 amended**

In regulation 40:

(a) in paragraph (a) before “drop” insert:

**6. Regulation 64L amended**

### **1. Citation**

These rules are the *Supreme Court (Corporations) (WA) Amendment Rules (No. 2) 2009*.

### **2. Commencement**

These rules come into operation as follows —

- (a) rules 1 and 2 — on the day on which these rules are published in the *Gazette*;
- (b) the rest of the rules — on the day after that day.

### **3. Rules amended**

These rules amend the *Supreme Court (Corporations) (WA) Rules 2004*.

### **4. Rule 15A.5 replaced**

Delete rule 15A.5 and insert:

#### **15A.5. Official liquidator's consent to act**

If an application is made for an order —

- (a) under article 19 or 21 of the Model Law to entrust the administration or realisation of all or part of the debtor's assets to a person designated by the Court (other than the foreign representative); or
- (b) under article 21 to entrust the distribution of all or part of the debtor's assets to a person designated by the Court (other than the foreign representative),



then, unless the Court otherwise orders, the person must —

- (c) be an official liquidator; and
- (d) have filed a Consent to Act, in accordance with Form 19, that specifies an address for service for the person within the State.

### HEALTH ACT 1911

### LOCAL GOVERNMENT ACT 1995

*Shire of Kalamunda*

### HEALTH AMENDMENT LOCAL LAW 2009

Under the powers conferred by section 342 of the *Health Act 1911*, Subdivision 2 of Division 2 of Part 3 of the *Local Government Act 1995* and all other powers enabling it, the Council of the Shire of Kalamunda resolved on 15 June 2009 to make the following local law.

#### 1 Citation

This local law may be cited as the *Shire of Kalamunda Health Amendment Local Law 2009*.

#### 2 Application

This local law shall apply throughout the district of the Shire of Kalamunda.

#### 3 Commencement

This local law will come into operation on the fourteenth day after the day on which it is published in the *Government Gazette*.

#### 4 Principal local law

In this local law, the *Shire of Kalamunda Health Local Laws 2001* published in the *Government Gazette* on 11 January 2002 are referred to as the principal local law.

The principal local law is amended by inserting in clause 66a new subclause (3) as follows—

“(3) An owner or occupier of premises shall not keep a rooster, peafowl, goose or turkey on a lot of land zoned residential, unless otherwise approved by the Local Government, and in accordance with any conditions imposed by the Local Government.”

### LOCAL GOVERNMENT ACT 1995

#### SOUTHERN METROPOLITAN REGIONAL COUNCIL STANDING ORDERS AMENDMENT LOCAL LAW 2009

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it the Council of the Southern Metropolitan Regional Council resolved on the 29 October 2009 to adopt the following local law.

#### 1. Citation

This local law is the *Southern Metropolitan Regional Council Standing Orders Amendment Local Law 2009*.

#### 2. Commencement

This Local Law comes into operation 14 days after the date of publication in the *Government Gazette*.

#### 3. Principal local law amended

The *Southern Metropolitan Regional Council Standing Orders Local Law 2008* is referred to as the principal local law. The principal local law is amended.

#### 4. Clause 3.1(1) amended

(1) After paragraph (e), insert—

(ea) announcements by the Chairman or the presiding person;

(2) Delete paragraph (k), re-designate paragraph “(l)” to “(k)” and insert—

(l) questions by members’ of which due notice has been given;

#### 5. Clause 3.11 amended

Delete clause 3.11 and its heading.

#### 6. New clause 3.5 inserted

After clause 3.4, insert new clause—

##### 3.5 Announcements by a presiding person

(1) At any meeting of the Council the presiding person may announce or raise any matter of interest or relevance to the business of the Council, or propose a change to the order of business.

(2) Any member may move that a change in order of business proposed by the presiding person not be accepted and, if carried by a majority of the members present, the proposed change in order is not to take place.

And clause numbers “3.5” through to “3.6” are re-designated “3.6” through to “3.11”.

#### 7. New clause 3.13 inserted

Before clause 3.14, insert—

##### 3.13 Questions by members of which due notice has been given

(1) A question on notice is to be given by a member in writing to the CEO at least 4 working days before the meeting at which it is raised.

- (2) If the question referred to in subclause (1) is in order, the answer is, so far as is practicable, to be included in written form in the agenda of the meeting, or otherwise tabled at the meeting.
- (3) Every question and answer is to be submitted as briefly and concisely as possible and no discussion is to be allowed thereon, unless with the consent of the presiding person.

**8. Clause 4.9 and 4.11 amended**

Delete clauses 4.9 and 4.11 and their headings.

**9. Clause 4.14 amended**

In subclause (3), delete “and must be accepted by the meeting without argument of comment”.

**10. Clause 4.15 amended**

In subclause (3), delete “that meeting” and substitute with “the item under discussion”.

**11. Clause 5.9 amended**

Delete subclause (3).

**12. Clause re-numbering**

Clause numbers are re-designated as follows—

- (1) “4.10” is re-designated “4.9”
- (2) “4.12” is re-designated “4.10”
- (3) “4.13” through to “4.17” are re-designated “4.11” through to “4.15”.

**13. Content page amended**

Clause numbers and their headings are amended accordingly.

**BUSH FIRE NOTICE AND REQUIREMENTS**

Pursuant to the powers contained in Section 33 of the Bush Fires Act, 1954, it is hereby notified that owner/occupiers of land with the District of the City of Bunbury are required to carry out fire prevention work in accordance with the provisions of this notice. This work must be carried out no later than 30 November 2009 and kept maintained throughout the summer months until 10 May 2010. The penalty of non-compliance with this notice is a modified penalty of \$250 and a maximum penalty of \$1000, and notwithstanding prosecution, Council may enter upon the land and carry out required works at the land owners/occupiers expense.

**REQUIREMENTS****1. Rural and Townsite Land (includes residential, commercial and industrial)**

(a) Where the area of land is 2024m<sup>2</sup> (approximately 1/2 acre) or less, **remove** all flammable material on the land except living standing trees, from the whole of the land; and

(b) Where the area of land exceeds 2024m<sup>2</sup> provide firebreaks free of all flammable material and at least 3 metres wide, immediately inside all external boundaries of the land and also immediately surrounding all buildings and haystacks situated on the land. Where several adjoining lots are held or used by the owner/occupier, the firebreaks may be provided inside and along the external boundaries of the group or lots.

**2. Rural Land**

The owners of all rural holdings zoned as Rural under Town Planning Schemes must maintain clear of all flammable materials, a firebreak not less than three (3) metres wide immediately inside all external boundaries of the land.

**3. Fuel and Gas Depots**

In respect of land owned and/or occupied by you on which is situated any container normally used to contain liquid or gas fuel, including the land on which any ramp or supports are constructed, you shall have the land clear of all flammable material.

**4. Plantations**

Boundary Firebreaks—

On the horizontal plane a firebreak shall be provided 15 metres wide and immediately adjoining all external boundaries of the planted area. The outer 10 metres will be cleared of all flammable material while the inner 5 metres, i.e. that portion closest to trees may be kept in a reduced fuel state, i.e. by slashing or grazing grass provided that the height of the grass does not exceed 8cm.

On the vertical plane a clear space 4 metres high will be maintained above the outer 10 metres of the firebreak.

Internal Firebreaks—

Plantations shall be subdivided into areas not exceeding 30 hectares by firebreaks 6 metres wide, which shall be cleared of all flammable material. In the vertical plane a clearance of a minimum height of 4 metres from the ground level will be maintained above the firebreak.

**5. Burning Permits, Burning of Bush, Grass and Garden Refuse**

Burning of anything including bush, grass and garden refuse is totally prohibited from 30th December 2009 to 28th March 2010 (inclusive).

Permits to burn are required for any burning including garden refuse at any time between 15 November 2009 and 29 December 2009 (inclusive) and between 29 March 2010 and 10 May 2010 (inclusive).

Permits to burn will only be issued to land owners/occupiers for hazard reduction burning until 30 November 2009 (inclusive). From 1 December 2009 to 29 December 2009 (inclusive), permits to burn will not be issued to land owner/occupiers for hazard reduction burning. From 1 December 2009 to 29 December 2009 (inclusive) permits to burn will only be issued to fire brigades established in accordance with the Fire Brigades Act 1942 or the Bushfires Act 1954 and for any other burning as approved by the Councils Chief Bush Fire Control Officer.

#### **6. Campfires**

Campfires are totally banned within the whole of the District of the City of Bunbury from 15 November 2009 until 10 May 2010 (inclusive).

#### **7. Prohibited and Restricted Burning periods**

Prohibited Burning Period: The 'prohibited burning' period that applies within the District of the City of Bunbury is 30 December 2009 to 28 March 2010 (inclusive).

Restricted Burning Period: The 'restricted burning' periods that apply within the District of the City of Bunbury are 15 November 2009 to 29 December 2009 (inclusive) and 29 March 2010 to 10 May 2010 (inclusive). These dates may be subject to variation according to seasonal conditions, but any changes will be advertised in a newspaper circulating the Bunbury District.

If it is considered for any reason to be impractical to clear firebreaks as required by this notice or if natural features render fire-breaks unnecessary, you may apply to the Council or its duly authorised officer not later than 15 November 2009 for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land. If permission is not granted by the Council or its duly authorised officer, the requirements of this notice shall be complied with. If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bushfires Act.
