Electricity Act 1945

### Electricity Amendment Regulations (No. 5) 2009

Made by the Governor in Executive Council.

**1. Citation**

These regulations are the *Electricity Amendment Regulations (No. 5) 2009*.

**2. Commencement**

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day after that day.

**3. Regulations amended**

These regulations amend the *Electricity Regulations 1947*.

**4. Regulation 2 amended**

In regulation 2(1) in the definition of *Australian/New Zealand Wiring Rules*:

- (a) delete “AS/NZS 3000:2000 Electrical Installations” and insert:

AS/NZS 3000:2007 Electrical installations

- (b) delete “New Zealand.” and insert:

New Zealand, as amended from time to time.

**5. Regulation 12 amended**

In regulation 12 delete the definition of *residential premises* and insert:

*residential premises* means premises that constitute or are intended to constitute a place of residence but does not include any common property relating to the residential premises;

**6. Regulation 15 amended**

In regulation 15 delete “the property” and insert:

the common property

**7. Regulation 18 inserted**

After regulation 17 insert:

**18. Director may grant temporary exemptions**

- (1) The Director may, by notice in writing, exempt an owner of residential premises from the requirements of regulation 13, 14 or 15, for such period, and on such conditions, as the Director considers appropriate and are set out in that notice.
- (2) The Director must not grant an exemption under subregulation (1) unless the Director is satisfied that —
  - (a) there are special circumstances which justify exempting the owner from the requirements of regulation 13, 14 or 15, as the case requires; and
  - (b) those circumstances are temporary; and
  - (c) the exemption will not cause or allow to continue any undue risk of —
    - (i) injury to a person; or
    - (ii) damage to property.

**Dental Board Amendment Rules 2010**

Made by the Dental Board of Western Australia with the approval of the Governor in Executive Council.

**1. Citation**

These rules are the *Dental Board Amendment Rules 2010*.

**2. Commencement**

These rules come into operation as follows —

- (a) rules 1 and 2 — on the day on which these rules are published in the *Gazette*;
- (b) the rest of the rules — on the day after that day.

**3. Rules amended**

These rules amend the *Dental Board Rules 1973*.

**4. Rule 17A inserted**

After rule 16 insert:

**17A. Fees for registration under the *Mutual Recognition (Western Australia) Act 2001* or *Trans-Tasman Mutual Recognition (Western Australia) Act 2007***

The fees in Schedule 3 are prescribed as the fees payable in respect of the registration of a person entitled under —

- (a) the *Mutual Recognition Act 1992* (Commonwealth), as adopted by the *Mutual Recognition (Western Australia) Act 2001*; or
- (b) the *Trans-Tasman Mutual Recognition Act 1997* (Commonwealth), as adopted by the *Trans-Tasman Mutual Recognition (Western Australia) Act 2007*,

to be registered in this State as a registered person.

## Poisons Amendment Regulations (No. 2) 2010

Made by the Governor in Executive Council.

### 1. Citation

These regulations are the *Poisons Amendment Regulations (No. 2) 2010*.

### 2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day after that day.

### 3. Regulations amended

These regulations amend the *Poisons Regulations 1965*.

### 4. Regulation 38A inserted

After regulation 37 insert:

#### **38A. Prescriptions for poisons included in Schedule 4 for patient discharged from public hospital**

- (1) In this regulation —  
*NIMC* means the National Inpatient Medication Chart developed by the Australian Council for Safety and Quality in Health Care.
- (2) An NIMC for a patient who is discharged from a public hospital is to be taken to be a prescription for a Schedule 4 poison that complies with regulation 37 for the purposes of dispensing the Schedule 4 poison at the public hospital on the discharge of the patient if —
  - (a) all the details in respect of the patient required by the NIMC have been completed; and
  - (b) a medical practitioner or nurse practitioner has completed, in ink in his or her own hand writing, all the details in respect of the Schedule 4 poison required by the NIMC; and
  - (c) a medical practitioner or nurse practitioner has written, in ink, an authorisation on the NIMC for the Schedule 4 poison to be dispensed for

discharge, and dated and signed the authorisation.

**5. Regulation 41D amended**

In regulation 41D(2) delete “(a) by” and insert:

(c) by

**6. Regulation 51 amended**

(1) Delete regulation 51(1B)(b) and insert:

(b) processed on an approved computer program and have the information referred to in subregulation (1)(a)(iii), (iv) and (vi) written in ink in the prescriber’s own handwriting.

(2) After regulation 51(1B) insert:

(1C) In subregulation (1B) —

*approved computer program* means a computer program that —

- (a) complies with the criteria specified in Appendix L; or
- (b) is recommended by the Poisons Advisory Committee and approved in writing by the CEO.

**7. Regulation 51AAA inserted**

After regulation 51 in Subdivision 1 insert:

**51AAA. Prescriptions for poisons included in Schedule 8 for patient discharged from public hospital**

(1) In this regulation —

*NIMC* means the National Inpatient Medication Chart developed by the Australian Council for Safety and Quality in Health Care.

- (2) An NIMC for a patient who is discharged from a public hospital is to be taken to be a prescription for a Schedule 8 poison that complies with regulation 51 for the purposes of dispensing the Schedule 8 poison at the public hospital on the discharge of the patient if —
  - (a) all the details in respect of the patient required by the NIMC have been completed; and



- (b) a medical practitioner has completed, in ink in his or her own hand writing, all the details in respect of the Schedule 8 poison required by the NIMC; and
- (c) a medical practitioner has written, in ink, an authorisation on the NIMC for the Schedule 8 poison to be dispensed for discharge, and dated and signed the authorisation.

**8. Regulation 53A amended**

Delete regulation 53A(1) and insert:

- (1) A person shall not dispense a prescription for or supply upon a prescription any poison included in Schedule 8 unless —
  - (a) the prescription is issued electronically via an approved electronic prescribing system; or
  - (b) if the prescription is not issued electronically —
    - (i) he or she is familiar with the prescriber's handwriting; or
    - (ii) he or she has verified with the purported prescriber that the prescription was issued by him or her.

**5. Clause 15(1) amended**

Delete the word ‘occupier’.

**6. Clause 15(3) amended**

Delete this paragraph and substitute with the following—

‘Should the owner fail to comply with a notice of breach, the Shire of Goomalling may by its employees, agents or contractors enter upon the lot to which the notice relates and remedy the breach, only if the fence abuts a public thoroughfare, public place or property of the Council, and may recover the shared expenses of so doing from the owner of the lot, in a court of competent jurisdiction.’

(a) Residential Development—

(i) Residential development shall be undertaken having due regard to the provisions of Planning Policy 5 and in accordance with the requirements of the Residential Design Codes with respect to the "R80" provisions.

(ii) Residential Density

The precinct is to be considered as a single development site for the purpose of calculating the total permissible number of dwellings (residential density).

## (b) Non-residential development—

## (i) Coventry's Square Tourism development—

- The net leasable area (NLA) of the markets, shop(s), restaurant(s), tavern and other uses associated with the Coventry's Square Tourism development shall not exceed 11,300m<sup>2</sup> unless approved by the Council and the Western Australian Planning Commission.
- Subject to the above, the Coventry's Square Tourism development uses shall not exceed the following NLA limits—
  - o Markets/shop—9300m<sup>2</sup>
  - o Restaurant/Fast food outlet (including al fresco area)—1700m<sup>2</sup>
  - o Tavern (including alfresco area)—800m<sup>2</sup>
 unless approved by the Council.
- The building containing the Coventry's Square Tourism development and associated uses shall not be subdivided or strata-titled and is to remain in the ownership of one ownership grouping.
- The net leasable area (NLA) of the market stalls and shops shall comprise of separate leaseholders up to a maximum individual leasehold size of 350m<sup>2</sup> NLA, with the exception of no more than six (6) separate leaseholds with maximum size of up to 500m<sup>2</sup> NLA.

## (ii) Public space interaction

The ground floor wall (up to 2.4 metres above pavement level) of the existing building facing Walter Road shall have a minimum of 75% of the wall area devoted to visually permeable, full height glazing to provide for visual interaction with exterior public spaces. At least 50% of the total wall area noted above shall be openable to encourage interaction with the exterior of the building.

## (c) Plot Ratio

The precinct is to be considered as a single development site for the purpose of calculating the permissible plot ratio—

## (i) Residential

The plot ratio for residential development shall be in accordance with the Residential Planning Codes with respect to the "R80" density code.

## (ii) Non-Residential

The plot ratio of non-residential development shall not exceed 1.0:1 across the precinct, calculated independently of plot ratio for any residential development.

## (iii) Total

The total plot ratio shall not exceed 2.0:1 across the precinct, inclusive of residential and non-residential uses.

## (d) Setbacks

New development shall be setback in accordance with the Residential Design Codes in accordance with the "R80" density code.

## (e) Car Parking

Car parking shall generally be provided in accordance with the requirement stipulated by Table 1 of the Scheme with respect to the proposed use(s), unless it is in compliance with an approved Outline Development Plan.

## (f) Building Height—

- (i) Buildings shall not exceed a height of three storeys unless in compliance with an approved Outline Development Plan or Detailed Site Plan, in which case buildings up to six storeys may be permitted.
- (ii) For the purposes of this calculating building height, a storey shall not include—
  - a full basement or a semi-basement that does not protrude any further than 1.4 metres above ground level;
  - lift overruns, water tanks, or other roof plant.

## (g) Landscaping

A minimum of 10% of the precinct shall be designed, developed and maintained as a landscaped area to the satisfaction of Council.

A reduction in the required landscaping may be considered by the Council if an applicant can demonstrate that the proposed landscaping will be of a high quality and will incorporate mature trees and significant vegetation or other landscape features.

- (h) Façades and Materials—
- (i) Building façades are to be articulated and detailed (broken into distinct visual elements). Projections such as verandahs, awnings, canopies and bay windows are encouraged.
  - (ii) The creation of expansive blank walls is not permitted.
