HEALTH ACT 1911

Shire of Goomalling

HEALTH AMENDMENT LOCAL LAW 2010

Under the provisions conferred by Clause 342 of the *Health Act 1911* and in accordance with subdivision 2 of Division 2 of Part 3 of the *Local Government Act 1995* and all other powers the Council of the Shire of Goomalling resolved on 21 April 2010 to make the following local law.

1. Citation

This local law may be cited as the *Shire of Goomalling Health Amendment Local Law 2010*.

2. Principal local law

In this local law, the *Shire of Goomalling Health Local Laws 2007*, published in the *Government Gazette* on 16 July 2007 is referred to as the principal local law. The principal local law is amended as follows.

3. Clause 1.3 amended

Replace both instances of the reference 'AS/NZS ISO 7171.1: 2004' with 'AS/NZ ISO 717.1.2004'.

Delete '1996' in the definition of "water" and replacing it with '2004'.

4. Clause 2.1.4(1)(c) amended

Replace "wash hand basin" with "hand wash basin".

5. Clause 2.2.1(c) amended

Replace "wash hand basin" with "hand wash basin".

6. Clause 2.2.1(2) amended

Replace "hand basin" with "hand wash basin".

7. Clause 6.3.3 (b) amended

Delete and replaced with—

- (b) any stored food intended for birds or other animals, unless it is contained in a rodent proof receptacle or a compartment, which is kept effectively protected against access by rodents'.

The Western Australian Planning Commission (WAPC) has considered all the submissions received in respect of the amendment proposals for Capel East, Amendment 0004/41 and Areas Identified in the Capel Townsite Strategy, Amendment 0006/41. These proposals were first published in the *Government Gazette* on 16 October 2009. The amendments are shown on WAPC plan numbers 3.2330 and 3.2333/1.

The amendments, as advertised (0004/41) and as modified (0006/41) have been presented to and approved by the Governor in accordance with the requirements of the *Planning and Development Act 2005*. They will now be tabled in both Houses of Parliament, where they must remain for 12 sitting days. During this time either House may, by resolution, disallow either of the amendments. As soon as the amendments are no longer subject to disallowance they become legally effective in the Greater Bunbury Region Scheme.
