1. Citation

These regulations are the *Hospitals (Services Charges) Amendment Regulations 2010*.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) regulations 3 and 4(1) — on the day after that day;
- (c) regulation 4(2) — on 1 July 2010.
