Shipping and Pilotage Act 1967

## Shipping and Pilotage (Ports and Harbours) Amendment Regulations (No. 3) 2010

Made by the Governor in Executive Council.

### 1. Citation

These regulations are the *Shipping and Pilotage (Ports and Harbours) Amendment Regulations (No. 3) 2010*.

### 2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette* (**gazettal day**);
- (b) the rest of the regulations —
  - (i) if gazettal day is before 1 July 2010 — on 1 July 2010; or
  - (ii) if gazettal day is, or is after, 1 July 2010 — on the day after gazettal day.
