BUSH FIRES ACT 1954

City of Bayswater

FIREBREAK NOTICE

Notice to all landowners and occupiers of land in the City of Bayswater

All landowners and occupiers of land within the City of Bayswater are advised that, on or before the 30 November 2010 or within fourteen days of the date of becoming an owner or occupier up to and including 30 April 2011, must ensure compliance with the following firebreak conditions—

All land which is 2000 or less in area—

Remove all inflammable matter from the whole of the land, except living trees and shrubs; plants under cultivation and lawn, by means of ploughing, cultivating or slashing to a height of no more than 50mm

All other land within the City of Bayswater—

- i. Firebreaks of a minimum width and height of 3 metres are to be cleared immediately inside all external boundaries of the land;
- ii. Firebreaks of a minimum width of 3 metres and height of 3 metres are to be cleared immediately surrounding all buildings situated on the land; and any place where inflammable liquids and gas products are kept.

If for any reason an owner and/or occupier consider it impractical to clear firebreaks or comply with other fire protection measures in accordance with this Notice, the owner and/or occupier may apply in writing to Council not later than 29 November 2010.

Where an owner and/or occupier of land fails or neglects to comply with any requirement of this Notice, Council may undertake the work and recover the costs and expenses from the owner and/or occupier pursuant to the Act, in addition to any penalty which might be imposed. A Penalty of not more than \$5,000 applies.

Burning off within the City of Bayswater is prohibited. All clearing and disposal of waste should be carried out by methods other than burning.

Shire of Busselton

FIREBREAK AND FUEL HAZARD REDUCTION NOTICE

All owners and/or occupiers of land within the District of the Shire of Busselton are hereby given notice that in accordance with Section 33 of the *Bush Fires Act 1954*, you are required to carry out and maintain fire protection measures in accordance with the provisions of this Notice.

'Compliance Period' is from 1 December 2010 to 12 May 2011 on all Rural Residential Land, Vacant Urban and Industrial Land. Rural land must be prepared by 15 December 2010 and maintained until 12 May 2011 or such later date as stated by the Shire via notices placed in the local newspaper.

- Garden Refuse Urban Areas: No garden refuse is permitted to be burnt on the ground, in the open air or in an outdoor incinerator within the urban areas of Busselton and Dunsborough town sites at any time of the year.
- Garden Refuse Rural—Residential Areas: The burning of garden refuse is prohibited from 14 December to 29 February. During the restricted burning period, 2 November to 14 December and 1 March to 12 May each year, permits are required to be obtained from the fire control officer for your area for the burning of any garden refuse.
- Burning of toxic materials and rubbish is prohibited at all times.

Variations to the annual Firebreak and Fuel Hazard Reduction Notice: Applications for alternative fire protection measures must be lodged in writing to the Shire prior to 8 November each year.

Restricted Burning Period: 7 October 2010 to 12 May 2011.

BURNING PERMITS ARE REQUIRED FROM—

- 7 October to 14 December each year inclusive; and
- 1 March to 12 May each year inclusive.

BURNING ON SUNDAYS AND PUBLIC HOLIDAYS DURING THE RESTRICTED FIRE SEASON IS PROHIBITED

BURNING PROHIBITED FROM 15 DECEMBER TO 29 FEBRUARY EACH YEAR INCLUSIVE

'Building Protection Zones (BPZ)' are a legal requirement and must be a minimum of 20 metres in depth in accordance with the Fire Management Plan specifications and are designed to reduce the fire's intensity close to buildings to minimise the likelihood of flame contact with the buildings.

Isolated trees and shrubs may be retained, however, the first 5 metres around all buildings must be cleared of all hazardous/flammable Materials. Reticulated gardens must be no greater than 500 millimetres in height and may be located in this zone. For the next 15/25 metres, i.e. from 5 metres onwards to 20/30 metres surrounding any buildings.

Hazardous/flammable materials must be maintained below a height of 10 centimetres. The spacing of individual or groups of trees shall be 15 metres apart to provide for a 5 metre separation between crowns.

Trees and branches must be removed and at least 3 metres back from the eaves of all buildings and 5 metres above the top of roof height. Branches that may fall on the house must also be removed.

Wood heaps and fuel must be a minimum of 10 metres away from buildings. All leaves and dry grass must be removed from the building protection zone.

'Windbreak' means an area of planted trees not exceeding 10 metres in depth with an unrestricted length that has been planted to provide wind protection to crop or pasture land.

'Parkland clearing' means that all dead vegetation and dry grasses (excluding approved crops, pasture areas and living trees/bushes) must be maintained to a height of no greater than 10 centimetres, including piles of timber, branches and other vegetation.

Camp Fires are totally banned within the whole Shire during the Restricted Burning Period.

Failure to comply with this fire break notice is an offence under Section 33 of the Bush Fires Act. Penalty is a minimum of \$250.00 with the maximum penalty being \$5,000.00 plus costs associated with meeting the Shire's expenditure in ensuring that you comply with the Firebreak and Fuel Hazard Reduction Notice.

3 REQUIREMENTS FOR PARTICULAR CATEGORIES OF LAND

Under each heading, the requirements of this Notice for each category of land are listed.

3.1 Rural Land (Category 1)

Mineral Earth Firebreak

Firebreaks shall be constructed and maintained adjacent to all external boundaries of a Land. The firebreak shall be 3 metres wide except in pasture or crop areas where it shall be 2 metres wide. Where the land area exceeds 120 hectares, an additional firebreak must divide the land into areas of not more than 120 hectares completely surrounded by a firebreak.

3.2 Urban Residential and Industrial—Commercial (Category 2)

Mineral Earth Firebreak

Where the area of land exceeds 2024m², firebreaks shall be constructed and maintained which are at least 3 metres wide and within 6 metres of the inside of all external boundaries of the Land.

FUEL REDUCTIONS

Where the area of land is $\frac{1}{2}$ acre (2,024m²) or less, all hazardous material must be removed from the whole of the land except living trees and in the area remaining, vegetation is to be maintained at a height of no greater than 10 centimetres, including piles of timber, branches and other vegetation.

3.3 Plantations (Category 3) (if established before 26 July 2000)**Mineral Earth Firebreak**

A firebreak shall be not less than 5 metres in width on all plantations.

FUEL REDUCTIONS

A 5 metres low fuel area is to be maintained between the 5 metre firebreak and the first row of trees. In this area, vegetation is to be maintained at a height of no greater than 10 centimetres.

BUILDING PROTECTION AND HAZARD SEPARATION ZONES

A 5 metre firebreak within 20 metres of all buildings.

FUEL STORAGE AND HAYSTACK PROTECTION ZONES

A 3 metre mineral earth firebreak must be located within 6 metres from the fuel storage, tanks, gas cylinders and haystacks is required on areas of the land.

3.4 Eucalypt and Pine Plantations (Category 4) (if established after 26 July 2000)**Mineral Earth Firebreak**

A firebreak shall be not less than 10 metres in width on all plantations.

FUEL REDUCTIONS

A 5 metre low fuel area is to be maintained between the 10 metre firebreak and the first row of trees. In this area, vegetation is to be maintained at a height of no greater than 10 centimetres, including piles of timber, branches and other vegetation.

BUILDING PROTECTION AND HAZARD SEPARATION ZONES

A 5 metre firebreak within 20 metres of all buildings.

FUEL STORAGE AND HAYSTACK PROTECTION ZONES

A 3 metre mineral earth firebreak within 6 metres from the fuel storage, tanks, gas cylinders and haystacks is required on areas of the land.

3.5 Protea Plantations and Vineyards (Category 5) (if established after 26th July 2000) (including vineyard tourist chalets)**Mineral Earth Firebreak**

A firebreak shall be not less than 3 metres in width on all plantations and vineyards.

FUEL REDUCTIONS

A 5 metre low fuel area is to be maintained between the 3 metre firebreak and the plantation/vineyard area. In this area, vegetation is to be maintained at a height of no greater than 10 centimetres, including piles of timber, branches and other vegetation.

BUILDING PROTECTION

A 3 metre firebreak within 20 metres of all farm buildings;

All tourist chalets shall have a building protection zone of a minimum depth of 20 metres around the building if no fire management plan applies; or

Compliance with Fire Management Plan.

FUEL STORAGE AND HAYSTACK PROTECTION ZONES

A 3 metre mineral earth firebreak within 6 metres from the fuel storage, tanks, gas cylinders and haystacks is required on areas of the land.

3.6 Rural Residential Land—Individual Firebreaks (Category 6)

(Refer to Estate Fire Management Plan or Individual Fire Management Plan)

Mineral Earth Firebreak

A firebreak shall be 3 metres wide except in pasture and crop areas where the firebreak shall be 2 metres wide and within 6 metres of all external boundaries of the land.

FUEL REDUCTIONS

Parkland clearing must be carried out in all open paddocks and along the boundary of the property.

BUILDING PROTECTION AND HAZARD SEPARATION ZONES

A building protection zone (BPZ) of a minimum depth of 20 metres is required, as per the interpretations guide; or

Compliance with the estate or individual Fire Management Plan.

A hazard separation zone is also recommended in the absence of a Fire Management Plan.

FUEL STORAGE AND HAYSTACK PROTECTION ZONES

A 3 metre mineral earth firebreak within 6 metres from the fuel storage, tanks, gas cylinders and haystacks is required on areas of the land.

3.7 Rural Residential—Strategic Firebreaks on One or More Boundaries (Category 7)

(Refer to Estate Fire Management Plan or Individual Fire Management Plan)

Mineral Earth Firebreak

Firebreaks shall be 3 metres wide. Free access along the strategic firebreak across the boundary of the lots is required to be provided for by means of a 3.5 metres field gate in a boundary fence.

FUEL REDUCTIONS

Parkland clearing must be carried out in all open paddocks and along the boundary of the property.

BUILDING PROTECTION AND HAZARD SEPARATION ZONES

A building protection zone (BPZ) of a minimum depth of 20 metres is required, as per the interpretations guide; or

Compliance with the estate or individual Fire Management Plan.

A hazard separation zone is also recommended in the absence of a Fire Management Plan.

FUEL STORAGE AND HAYSTACK PROTECTION ZONES

A 3 metre mineral earth firebreak within 6 metres from the fuel storage, tanks, gas cylinders and haystacks is required on areas of the land.

3.8 Rural Residential—Lots within a Strategic Firebreak Area with no Strategic Firebreaks on the Lot Boundaries (Category 8)

Parkland clearing must be carried out in all open paddocks and along the boundary of the property.

Compliance with the estate or individual Fire Management Plan.

A hazard separation zone is also recommended in the absence of a Fire Management Plan.

FIRE BREAK ORDER

Notice to all Owners and or Occupiers of land in the Shire of Corrigin

Pursuant to the powers contained in section 33 of the *Bush Fires Act 1954*, you are hereby required on or before 31 October 2010, to plough, scarify, cultivate, spray or otherwise clear and thereafter maintain free of all inflammable material until 15 April 2011 firebreaks in the following dimensions, on the land owned or occupied by you.

1. RURAL LAND

1.1 Firebreaks of not less than 2.44 metres (8 feet) in width must be constructed along and within 20 metres of all external boundaries of the property owned or occupied by you. If any portion of the land adjoins a public road or railway line, a firebreak must also be constructed along that boundary.

1.2 Property in excess of 250 hectares shall have fire breaks positioned as necessary to divide land into areas not exceeding 250 hectares each completely surrounded by a firebreak.

1.3 Clear and maintain firebreaks at least 2.44 metres (8 feet) wide within 20 metres of the perimeter of any building or group of buildings, fuel tanks or haystack, in such a manner as to fully encircle the structure/s.

1.4 During any period when harvesting operations are being conducted, there shall be provided an operational mobile firefighting unit with a minimum capacity of 500 litres of water located in or immediately adjacent to the paddock being harvested. The responsibility to supply the unit is that of the landowner/occupier.

2. TOWN SITES

2.1 Where the area of the land is 0.2 hectares (one half of one acre) or less, you shall clear all inflammable material on the land from the whole of the land.

2.2 Where the area of the land exceeds 0.2 hectares (one half of one acre), you shall clear of all inflammable material, firebreaks not less than 2.44 metres (8 feet) wide immediately inside all external boundaries of the land, and also immediately surrounding all buildings, haystacks and fuel ramps situated on the land, and also immediately surrounding any drums or drums situated on the land which are normally used for the storage of fuel, whether they contain fuel or not.

3. GENERAL PROVISIONS

The term "*Inflammable Material*" for the purpose of this notice includes bush (as defined in the Bush Fires Act 1954), timber, boxes, cartons, paper, and the like inflammable materials, rubbish and any combustible matter, but does not include buildings, green standing trees and bushes or growing bushes or plants in gardens or lawns.

If it is considered to be impractical for any reason to provide firebreaks in the position or adhere to the provisions required by this notice, the written approval of Council or a duly authorised officer must be obtained to prepare such firebreaks in an alternative position. If permission is not granted by Council or a duly authorised officer you shall comply with the requirements of this order.

A "Harvesting/Total Movement Ban" includes harvesting and the movement of vehicles in paddocks, except vehicles carrying water to stock. Contractors carting lime, gypsum or fertilizer are allowed to enter into paddocks to unload at any time that there is a "Harvest/Total Movement Ban" in place on the condition that a manned fire unit with at least 500 litres of water is in attendance. **Harvesting is not permitted on Christmas Day and New Years Day.**

The penalty for failing to comply with this order is a fine of not more than one thousand dollars (\$1000) and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed by this notice, if it is not carried out by the owner or occupier by the date required by this notice.
