Hospitals (Services Charges) Amendment Regulations 2012

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Hospitals (Services Charges) Amendment Regulations 2012.*

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day after that day.

3. Regulations amended

These regulations amend the *Hospitals (Services Charges) Regulations 1984*.

4. Regulation 4 amended

- (1) In regulation 4(1) delete the definition of *participating hospital*.
- (2) In regulation 4(1) insert in alphabetical order:

participating hospital means a public hospital in the State, if either or both of the following applies in relation to the hospital —

- (a) an approval under the National Health Act section 94 is in force in relation to the hospital authority for the hospital;
- (b) the hospital authority for the hospital is authorised to supply pharmaceutical benefits pursuant to a special arrangement in force under the National Health Act section 100;

pensioner concession card means a currently valid card, known by that name, issued on behalf of the Commonwealth;

private pathology out-patient has the meaning given by regulation 9(3);

(3) In regulation 4(1) in the definition of *compensable out-patient* delete "9(a);" and insert:

9(1)(a);

(4) In regulation 4(1) in the definition of *concessional beneficiary* delete "9(d);" and insert:

 - (a) the person is classified as a private pathology out-patient for the purpose of the payment of any charge for that pathology service determined under regulation 5(2)(f); and

(b) despite subregulation (1)(b), (d) and (e), the person is not classified as an eligible out-patient, concessional beneficiary or pensioner (as the case may be) for that purpose.

Hospitals and Health Services (Pathology) Approval 2012

Given by the Minister for Health under the *Hospitals and Health Services Act 1927* section 18.

1. Citation

This is the *Hospitals and Health Services (Pathology) Approval 2012.*

2. Commencement

This approval comes into operation as follows —

- (a) clauses 1 and 2 on the day on which this approval is published in the *Gazette*;
- (b) the rest of the approval on the day after that day.

3. Term used: MHS

In this approval —

MHS (which stands for Metropolitan Health Services) means the Minister in his or her incorporated capacity under section 7 of the Act as the board of the hospitals that were managed and controlled by the Metropolitan Health Service Board immediately before its abolition on 9 March 2001 by the *Hospitals and Health Services (Metropolitan Health Service Board) Abolition Notice 2001.*

4. Functions of hospital boards

For the purposes of section 18(1)(a)(iii) of the Act, the following services are approved to the extent that they constitute health services —

- (a) pathology services and related medical scientific services for the purpose of diagnosing and managing disease or protecting public health;
- (b) forensic biology services and forensic pathology services, including obtaining DNA profiles for forensic and other purposes.

5. Approval to provide services on terms and conditions

For the purposes of section 18(2a) of the Act, approval is given for the MHS to provide services of a kind that the MHS is empowered to provide under the *Hospitals and Health Services* (*Pathology*) Regulations 2005 regulation 4 on such terms and conditions, including payment for those services, as the MHS thinks fit.

6. Hospitals and Health Services (Pathology) Approval 2005 revoked

The Hospitals and Health Services (Pathology) Approval 2005 is revoked.

City of Vincent

DOGS AMENDMENT LOCAL LAW 2012

Under the powers conferred by the *Local Government Act 1995*, the *Dog Act 1976* and by all other powers enabling it, the Council of the City of Vincent resolved on 14 February 2012 to make the following local law.

1. Citation

This local law may be cited as the City of Vincent Dogs Amendment Local Law 2012.

2. Commencement

This local law comes into operation 14 days after the date of its publication in the $Government\ Gazette$.

3. Principal local law

In this local law the *Town of Vincent Dogs Local Law 2007* published in the *Government Gazette* on 21 November 2007, is referred to as the principal local law. The principal local law is amended.

4. Clause 1.6 amended

Clause 1.6 be amended to add the following definitions in alphabetical order—

""food premises" means any premises or vehicle in which a food business, as defined in section 10 of the Food Act 2008, is being carried on";

""food transport vehicle" has the meaning given to it in the Food Act 2008";

5. Clause 4.9 amended

Clause 4.9 be deleted and substituted with the follows—

"4.9 Compliance with conditions of approval

A licensee who does not comply with the conditions of a licence commits an offence."

6. Clause 5.1 amended

Subclause (1) be deleted and substituted with the follows—

"(1) Subject to Section 8 of the Act and Section 66J of the *Equal Opportunity Act 1984*, dogs are prohibited absolutely from entering or being in any of the following places—"

Subclause (1)(c) be deleted and substituted with the follows—

"(c) all food premises and food transport vehicles;"






