Made by the Governor in Executive Council.

### **Part 1 — Preliminary**

**1. Citation**

These regulations are the *Road Traffic (Charges and Fees) Amendment Regulations (No. 3) 2012*.

**2. Commencement**

These regulations come into operation as follows —

- (a) Part 1 — on the day on which these regulations are published in the *Gazette* (**gazettal day**);
- (b) Part 3 — on 1 July 2012;
- (c) the rest of the regulations — on the day after gazettal day.
