Made by the Governor in Executive Council.

**1. Citation**

These regulations are the *Child Care Services Amendment Regulations 2012*.

**2. Commencement**

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day after that day.

**3. Regulations amended**

These regulations amend the *Child Care Services Regulations 2007*.

**4. Regulation 6AA inserted**

At the end of Part 2 insert:

**6AA. Form of entry warrant**

Schedule 1 Form 1 is prescribed for the purposes of section 43K(3) of the Act.

## 5. Schedule 1 inserted

After regulation 11 insert:

Land Administration Act 1997

### **Land Administration Amendment Regulations 2012**

Made by the Governor in Executive Council.

**1. Citation**

These regulations are the *Land Administration Amendment Regulations 2012*.

**2. Commencement**

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day after that day.

**3. Regulations amended**

These regulations amend the *Land Administration Regulations 1998*.

**4. Regulation 3 replaced**

Delete regulation 3 and insert:

**3. Services prescribed as public utility services**

(1) In this regulation —

*marine navigational aid* means a lighthouse or other structure intended to aid the navigation of vessels at sea and includes a helicopter landing pad if necessary to access the lighthouse or other structure by helicopter;

*survey mark* has the same meaning as in the Act section 268(3);

*telecommunications network* has the same meaning as in the *Telecommunications Act 1997* (Commonwealth) section 7.

(2) For the purposes of the definition of *public utility services* in section 3(1) of the Act, the following services are prescribed —

- (a) services provided by a telecommunications network;
- (b) services provided by a marine navigational aid;
- (c) geocentric datum services provided by a survey mark.

**5. Regulation 17F inserted**

At the end of Part 2 insert:

**17F. Commonwealth agencies: section 275A**

For the purposes of the definition of *public authority* in section 275A(1) of the Act, the following Commonwealth agencies are prescribed —

- (a) the Australian Electoral Commission established by the *Commonwealth Electoral Act 1918* (Commonwealth);
- (b) the Australian Air Force established by the *Defence Act 1903* (Commonwealth);
- (c) the Australian Regular Army established by the *Defence Act 1903* (Commonwealth);
- (d) the Australian Bureau of Statistics established by the *Australian Bureau of Statistics Act 1975* (Commonwealth);

- (e) the Commonwealth agency known as Centrelink at the time the *Land Administration Amendment Regulations 2012* came into operation;
- (f) the department of the Commonwealth public service principally assisting the Commonwealth Minister in the administration of any of the following Acts —
  - (i) the *Primary Industries Levies and Charges Collection Act 1991*;
  - (ii) the *Quarantine Act 1908*;
  - (iii) the *Export Control Act 1982*;
  - (iv) the *Imported Food Control Act 1992*.

### LOCAL GOVERNMENT ACT 1995

#### *Shire of Broomehill-Tambellup*

#### REMOVAL OF REFUSE, RUBBISH AND DISUSED MATERIALS LOCAL LAW 2012

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the local government of the Shire of Broomehill-Tambellup resolved on the 21st June 2012 to make the following local law.

#### 1. Citation

This local law may be cited as the *Shire of Broomehill-Tambellup Removal of Refuse, Rubbish and Disused Materials Local Law 2012*.

#### 2. Commencement

This local law comes into operation 14 days after the date of its publication in the *Government Gazette*.

#### 3. Interpretation

(1) In this local law, unless the context otherwise requires—

**Act** means the *Local Government Act 1995*;

**district** means the district of the Shire of Broomehill-Tambellup;

**local government** means the Shire of Broomehill-Tambellup;

**refuse, rubbish or disused material** includes—

- (i) any material which is abandoned or unwanted by its owner or the person in possession of it;
- (ii) any material which is not being used for its original intended purpose and which has been deposited or stored upon any property for no current purpose other than the deposit storage;
- (iii) any motor vehicle, motor vehicle part or machinery which has been deposited or stored upon any property for the purpose of dismantling or breaking up;
- (iv) any wood, timber, lumber; or cuttings, logs or remnants of trees; or chopped, split or chipped wood, deposited, stored, located or placed on property;

and any material may be refuse, rubbish or disused material notwithstanding that it may have a commercial value to its owner or the person in possession of it or the owner or occupier of any property upon which it is deposited or stored;

*served* has the same meaning as defined in section 75 and 76 of the *Interpretation Act 1984*.

(2) Where in this local law a duty of liability is imposed on an owner or occupier of land, the duty or liability is imposed jointly and severally on each of the owner or occupier.

#### 4. Clearing of refuse, rubbish or disused material

(1) If there is—

- (a) on any vacant property within the district, any refuse, rubbish or disused material or any overgrown vegetation, trees, scrub or undergrowth; or
- (b) on any property within the district other than vacant property any refuse, rubbish or disused material or any overgrown vegetation, trees, scrub or undergrowth which, in the opinion of the local government—
  - (i) is likely to adversely affect the health, comfort or convenience of the inhabitants of that property or any adjoining property; or
  - (ii) results in that property having an appearance which does not conform with the general appearance of other property in the locality,

the local government may cause a notice under the hand of the Chief Executive Officer to be served on the owner or occupier of that property requiring that owner or occupier as the case may be to clear the property of the overgrown vegetation, trees, scrub or undergrowth or refuse, rubbish or disused material specified in the notice within the time specified in the notice.

(2) Any owner or occupier who is served with a notice under clause 3 of this local law and who fails to comply with the terms of the notice commits an offence.

Penalty—

- (a) five thousand dollars (\$5,000); and
- (b) a daily penalty of five hundred dollars (\$500).

(3) Where an owner or occupier who is served with a notice under clause 3 of this local law fails to comply with the terms of the notice, the local government is authorised—

- (a) to clear or remove from the property the overgrown vegetation, trees, scrub or undergrowth or refuse, rubbish or disused material specified in the Notice, and dispose of the same, without payment of any compensation; and
- (b) to recover in a court of competent jurisdiction the amount of the local government's expenses in doing so from the owner or occupier who was served the notice.

#### DOGS AMENDMENT LOCAL LAW 2012

Under the powers conferred by the *Local Government Act 1995*, the *Dog Act 1976* and all other powers conferred upon it, the Council of the Town of Cottesloe resolved on 25 June 2012 to make the following local law.

#### 1. Citation

This local law may be cited as the *Town of Cottesloe Dogs Amendment Local Law 2012*.

#### 2. Commencement

This local law comes into operation 14 days after the date of its publication in the *Government Gazette*.

**3. Principal Local Law**

In this local law, the *Town of Cottesloe Dogs Local Law 2011* published in the *Government Gazette* on 26 July 2011 is referred to as the Principal Local Law. The Principal Local Law is amended.

**4. Clause 1.4 amended**

In Clause 1.4 insert the following in alphabetical order—

**Children’s playground** means an area set aside for use by children and noted by the presence of dedicated children’s playground equipment and the presence of either white sand or other form of soft fall surface;

**5. Clause 4.1 amended**

Clause 4.1 (1) is amended as follows—

- (a) In paragraph (c) delete “2008,” and insert “2008;”;
- (b) In paragraph (d) delete “pool,” and insert “pool;”;
- (c) In paragraph (f) delete “designated by sand/soft fall area or fence”.

**6. Clause 4.2 amended**

In clause 4.2—

- (a) delete subclause (3);
- (b) delete subclause (4); and
- (c) delete subclause (5).

**HEALTH AMENDMENT LOCAL LAW 2012**

Under the powers conferred by the *Health Act 1911* and all other powers enabling it, the City of Cockburn resolved on 14 June 2012 to adopt the following local law amendments made by the Local Government of the City of Cockburn under section 342 of the *Health Act 1911* in accordance with subdivision 2 of Part 3 of the *Local Government Act 1995*.

**1. Citation**

This local law may be cited as the *City of Cockburn Health Amendment Local Law 2012*.

## 2. Commencement

This local law comes into operation on the day of its publication in the *Government Gazette*.

## 3. Principal Local Laws

The *City of Cockburn Health Local Laws 2000* published in the *Government Gazette* on 9 October 2000 is referred to as the principal local law. The principal local law is amended.

- (b) The owners of Lot 3, House Number 7, Gay Street and Lot 9, House Number 15, Osborne Road, Dianella shall undertake the following, to the satisfaction of the City—

- (i) The preparation of a Kangaroo Management Strategy specific to the subject Lots 3 and 9, at the owner’s cost prior to the commencement of any subdivision site works on the Lots, to the satisfaction of the City of Stirling, on the advice of the Department of Environment and Conservation; and

The provision of suitable reticulated turfed kangaroo grazing areas within the subject Lots in accordance with the Kangaroo Management Strategy, at the owner’s cost prior to the sale of any portion of the Lots; and

A suitable staging plan detailing how a continuous supply of grazing areas and the capture and release of kangaroos will be provided through the construction phase of the development, prior to the commencement of any subdivision site works on the Lots; and

The maintenance of the reticulated turfed kangaroo grazing areas within the subject Lots for a minimum of two years in accordance with the Kangaroo Management Strategy, at the owner’s cost.

- (ii) Provision of a minimum of 100 dwellings over the subject Lots.

**6.10.4 Redevelopment Procedure Statement and Precinct Plan**

For the purposes of promoting the highest standard of development within the Dianella Media District Special Control Area, the Council and applicants are to have due regard to the Media Zones Redevelopment Procedures Statement and the Media Zones Precinct Plan (as amended from time to time).

The Council may require the preparation of a Detailed Area Plan for a particular lot or lots within the Dianella Media District Special Control Area, in accordance with Part 6A of the Scheme.
