Notice to all Owners and/or Occupiers of Land within the Town of Victoria Park and City of Vincent.

Pursuant to the powers conferred in Section 33 of the *Bush Fires Act 1954*, you are required on or before the 31st day of October 2012, or within fourteen days of the date you become the owner or occupier should this be after the 31st day of October 2012 and thereafter up to and including the 30th day of April 2013, to clear inflammable matter, on land owned and/or occupied by you in accordance with the following requirements—

1. All land which is 2000 m² or less in area—
