Prisons Act 1981

Prisons (Hakea Prison) Order 2013

Made by the Minister under the *Prisons Act 1981* section 5.

1. Citation

This order is the *Prisons (Hakea Prison) Order 2013*.

2. Commencement

This order comes into operation on the day on which it is published in the *Gazette*.

3. Prison declared

The buildings and enclosures on Reserve 50756, being Lot 501 on Deposited Plan 69593 (held by the Western Australian Land Information Authority established by the *Land Information Authority Act 2006*), other than the parts of them known as Units 5 and 12, are declared to be a prison, called the Hakea Prison, within the meaning and for the purposes of the Act.

4. Proclamation declaring Hakea Prison revoked

The proclamation made under section 5 of the Act, published in the *Gazette* of 28 March 2000 on page 1687 and amended by a proclamation published in the *Gazette* of 25 August 2000 on page 4903 is revoked.

Young Offenders Act 1994

Young Offenders (Banksia Hill Detention Centre) Order 2013

Made by the Minister under section 13 of the Act.

1. Citation

This order is the *Young Offenders (Banksia Hill Detention Centre) Order 2013*.

2. Commencement

This order comes into operation as follows —

- (a) clauses 1 and 2 — on the day on which this order is published in the *Gazette*;
- (b) the rest of the order — on the day after that day.

3. Declaration of Banksia Hill Detention Centre

Reserve 35153, being Lot 500 on Deposited Plan 69593, and the buildings and enclosures on it are declared to be a detention centre called the Banksia Hill Detention Centre.

4. Order revoked

The *Young Offenders (Detention Centre) Order 1997*, published in the *Gazette* of 5 September 1997 pages 5038-9 is revoked.

Made by the Minister under the *Young Offenders Act 1994* section 13.

1. Citation

This order is the *Young Offenders (Detention Centre) Order 2013*.

2. Commencement

Subject to it being published in the *Gazette*, this order comes into operation immediately after the *Prisons (Hakea Prison) Order 2013* comes into operation.

3. Detention centre declared

Those parts of the buildings and enclosures on Reserve 50756, being Lot 501 on Deposited Plan 69593 (held by the Western Australian Land Information Authority established by the *Land Information Authority Act 2006*) known as Units 5 and 12 of the Hakea Prison, but not being parts of a prison under the *Prisons Act 1981*, are declared to be a detention centre.
