LOCAL GOVERNMENT ACT 1995

Shire of Broomehill-Tambellup

REMOVAL OF REFUSE, RUBBISH AND DISUSED MATERIALS LOCAL LAW 2012

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the local government of the Shire of Broomehill-Tambellup resolved on the 21st February 2013 to make the following local law.

1. Citation

This local law may be cited as the *Shire of Broomehill-Tambellup Removal of Refuse, Rubbish and Disused Materials Local Law 2012*.

2. Commencement

This local law comes into operation 14 days after the date of its publication in the *Government Gazette*.

3. Interpretation

(1) In this local law, unless the context otherwise requires—

Act means the *Local Government Act 1995*;

district means the district of the Shire of Broomehill-Tambellup;

local government means the Shire of Broomehill-Tambellup;

refuse, rubbish or disused material includes—

- (i) any material which is abandoned or unwanted by its owner or the person in possession of it;
- (ii) any material which is not being used for its original intended purpose and which has been deposited or stored upon any property for no current purpose other than the deposit storage;
- (iii) any motor vehicle, motor vehicle part or machinery which has been deposited or stored upon any property for the purpose of dismantling or breaking up;
- (iv) any wood, timber, lumber; or cuttings, logs or remnants of trees; or chopped, split or chipped wood, deposited, stored, located or placed on property;

and any material may be refuse, rubbish or disused material notwithstanding that it may have a commercial value to its owner or the person in possession of it or the owner or occupier of any property upon which it is deposited or stored;

served has the same meaning as defined in section 75 and 76 of the *Interpretation Act 1984*.

(2) Where in this local law a duty of liability is imposed on an owner or occupier of land, the duty or liability is imposed jointly and severally on each of the owner or occupier.

4. Clearing of refuse, rubbish or disused material

(1) If there is—

- (a) on any vacant property within the district, any refuse, rubbish or disused material or any overgrown vegetation, trees, scrub or undergrowth; or
- (b) on any property within the district other than vacant property any refuse, rubbish or disused material or any overgrown vegetation, trees, scrub or undergrowth which, in the opinion of the local government—
 - (i) is likely to adversely affect the health, comfort or convenience of the inhabitants of that property or any adjoining property; or
 - (ii) results in that property having an appearance which does not conform with the general appearance of other property in the locality,

the local government may cause a notice under the hand of the Chief Executive Officer to be served on the owner or occupier of that property requiring that owner or occupier as the case may be to clear the property of the overgrown vegetation, trees, scrub or undergrowth or refuse, rubbish or disused material specified in the notice within the time specified in the notice.

(2) Any owner or occupier who is served with a notice under clause 4(1) of this local law and who fails to comply with the terms of the notice commits an offence.

Penalty—

- (a) five thousand dollars (\$5,000); and
- (b) a daily penalty of five hundred dollars (\$500).

(3) Where an owner or occupier who is served with a notice under clause 4(1) of this local law fails to comply with the terms of the notice, the local government is authorised—

- (a) to clear or remove from the property the overgrown vegetation, trees, scrub or undergrowth or refuse, rubbish or disused material specified in the Notice, and dispose of the same, without payment of any compensation; and
- (b) to recover in a court of competent jurisdiction the amount of the local government's expenses in doing so from the owner or occupier who was served the notice.

DOGS AMENDMENT LOCAL LAW 2012

Under the powers conferred by the *Dog Act 1976*, the *Local Government Act 1995* and under all other powers enabling it, the Council of the City of Mandurah resolved on 29 January 2013 to make the following local law.

1. Citation

This local law may be cited as the *City of Mandurah Dogs Amendment Local Law 2012*.

2. Commencement

This local law comes into operation 14 days after the date of its publication in the *Government Gazette*.

3. Principal Local Law

In this local law, the *City of Mandurah Dogs Local Law 2010* as published in the *Government Gazette* of 22 March 2011, and as published and amended in the *Government Gazette* on 21 October 2011, is referred to as the Principal Local Law. The Principal Local Law is amended.

4. Schedule 2 amended

Schedule 2 is amended as follows—

- (a) In paragraph (e) delete “the eastern end of Town Beach car park west” and insert “Stewart Street in a westerly direction”; and
- (b) In paragraph (k) delete “66” and insert “166”.

5. Schedule 3 amended

In Schedule 3, delete clause (3) and insert—

- (3) The area commonly known as the Bird Sanctuary situated within Reserve no. 32836 located at the south-east end of John Street, Coodanup, then in a north-west direction along Reserve no. 32836 to the south-west prolongation of William Street.

6. Schedule 4 amended

In Schedule 4 clause (o) delete “66” and insert “166”.

7. Schedule 5 amended

In Schedule 5 delete clause (21) and insert—

(21) Hall Park Reserve no.27581 bounded by Leighton Place and Mary Street, Halls Head, excluding—

- (a) War Memorial site Reserve no. 42921; and
- (b) the portion of Reserve no. 27581 bounded by Mary Street, the southern entry into Reserve no. 27581 off Mary Street, north following the driveway and fire brigade running track to the south-east corner of Reserve no. 42921 east to the estuary.

In this precinct in the area coded Residential R40 between Leonard Street and McMillan Street, and the area coded Residential R40 bounded by Kent Street, Berwick Street, Basinghall Street, Moorgate Street and Gloucester Street, multiple dwellings are not permitted.”
