Local Government (Belmont - New Wards and Councillor Numbers) Order 2013

Made by the Lieutenant-Governor and deputy of the Governor in Executive Council on the recommendation of the Minister for Local Government.

1. Citation

This order is the *Local Government (Belmont - New Wards and Councillor Numbers) Order 2013*.

2. Commencement

This order comes into operation as follows —

- (a) clauses 1 and 2 — on the day on which this order is published in the *Gazette*;
- (b) the rest of the order — on the day after that day.

3. Terms used

commencement day means the day on which the rest of the order comes into operation under clause 2(b);

continuing councillor means a councillor on the council of the City of Belmont whose term of office as councillor continues beyond next election day;

district means the district of Belmont;

next election means the first ordinary election for the City of Belmont held after commencement day;

next election day means the day fixed for the holding of the poll for the next election.

4. Abolition of existing wards (s. 2.2(1)(d) of the Act)

All of the wards in the district are abolished immediately before next election day.

5. Division into new wards (s. 2.2(1)(a) of the Act)

- (1) On and from next election day, the district is divided into the following wards —
 - (a) the East Ward;
 - (b) the South Ward;
 - (c) the West Ward.
- (2) The East Ward consists of the land described in Schedule 1.
- (3) The South Ward consists of the land described in Schedule 2.
- (4) The West Ward consists of the land described in Schedule 3.

6. Number of councillors (s. 2.18(3)(a) and (b) of the Act)

- (1) On and from next election day, the number of offices of councillor on the council of the City of Belmont is 9.
- (2) On and from next election day, the number of offices of councillor for the East Ward is 3.
- (3) On and from next election day, the number of offices of councillor for the South Ward is 3.
- (4) On and from next election day, the number of offices of councillor for the West Ward is 3.

7. Continuing councillors allocated to new wards (s. 9.62 of the Act)

- (1) A continuing councillor who was a councillor for the East Ward immediately before its abolition under clause 4 is, on and from next election day, to be taken to have been elected as a councillor for the East Ward established under clause 5(2).
- (2) A continuing councillor who was a councillor for the South Ward immediately before its abolition under clause 4 is, on and from next election day, to be taken to have been elected as a councillor for the South Ward established under clause 5(3).
- (3) A continuing councillor who was a councillor for the West Ward immediately before its abolition under clause 4 is, on and from next election day, to be taken to have been elected as a councillor for the West Ward established under clause 5(4).

8. Consequential directions (s. 2.35 and 9.62 of the Act)

In order to give effect to clauses 4, 5, 6 and 7 —

- (a) Part 4 of the Act applies to preparing for and conducting the next election as if the changes effected by clauses 4, 5 and 6 take effect on commencement day; and
- (b) the operation of Part 4 of the Act is modified to the extent necessary for the purposes of paragraph (a).

Schedule 1 — Description of East Ward

[cl. 5(2)]

All that portion of land bounded by lines starting from the intersection of the left bank of the Swan River with the centreline of Grandstand Road, a point on a present northwestern boundary of the district of Belmont and extending generally southeasterly along that centreline and generally southwesterly along the centreline of Grandstand Road (undedicated) as shown on Deposited Plan 185797, to the prolongation westerly of the centreline of Resolution Drive; thence easterly to and generally southeasterly, generally northeasterly and again generally southeasterly along that centreline and onwards to the centreline of Hardey Road; thence southeasterly along that centreline and onwards to the centreline of Tonkin Highway (undedicated) as shown on Plan 14114; thence generally southwesterly and generally southeasterly along that centreline and generally southeasterly along the centreline of Tonkin Highway (dedicated); again generally southeasterly along the centreline of Tonkin Highway (undedicated) as shown on Plan 7067 and again generally southeasterly along Tonkin Highway (dedicated) to the prolongation southwesterly of the northernmost northwestern boundary of Lot 500 (Reserve 46524) as shown on Deposited Plan 62709, a point on a present southeastern boundary of the district of Belmont and thence generally northeasterly, northwesterly and generally southwesterly along boundaries of that district to the starting point.

Schedule 2 — Description of South Ward

All that portion of land bounded by lines starting from the intersection of a northern side of Orrong Road and the centreline of Sydenham Street, a point on a present southwestern boundary of the district of Belmont and extending northeasterly along that centreline to the and onwards to the centreline of Belmont Avenue thence southeasterly along that centreline to the centreline of Elizabeth Street; thence northeasterly along that centreline and onwards to the centreline of Robinson Avenue; thence northwesterly along that centreline to the prolongation southwesterly of the northernmost northwestern boundary of Lot 53 as shown on Plan 7804; thence northeasterly to and along that boundary and onwards to the western corner of Lot 12576 as shown on Deposited Plan 192704; thence northeasterly along the northwestern boundary of that lot and onwards to the centreline of Fisher Street; thence northwesterly along that centreline to the prolongation southwesterly of the centreline of Sydenham Street; thence northeasterly along that centreline to the centreline of Hardey Road; thence southeasterly along that centreline and onwards to the centreline of Tonkin Highway (undedicated) as shown on Plan 14114; thence generally southwesterly and generally southeasterly along that centreline and generally southeasterly along the centreline of Tonkin Highway (dedicated); again generally southeasterly along the centreline of Tonkin Highway (undedicated) as shown on Plan 7067 and again generally southeasterly along Tonkin Highway (dedicated) to the prolongation southwesterly of the northernmost northwestern boundary of Lot 500 (Reserve 46524) as shown on Deposited Plan 62709, a point on a present southeastern boundary of the district of Belmont and thence generally southwesterly, generally northwesterly, again generally southwesterly and generally northwesterly along boundaries of that district to the starting point.

Schedule 3 — Description of West Ward

[cl. 5]

All that portion of land bounded by lines starting from the intersection of the left bank of the Swan River with the centreline of Grandstand Road, a point on a present northwestern boundary of the district of Belmont and extending generally southeasterly along that centreline, and generally southwesterly along the centreline of Grandstand Road (undedicated) as shown on Deposited Plan 185797 to the prolongation westerly of the centreline of Resolution Drive; thence easterly to and generally southeasterly, generally northeasterly and again generally southeasterly along that centreline and onwards to the centreline of Hardey Road; thence southeasterly along that centreline to the centreline of the northeastern section of Sydenham Street; thence southwesterly along that centreline and onwards to the centreline of Fisher Street; thence southeasterly along that centreline to the prolongation northeasterly of the northwestern boundary of Lot 12576 as shown on Deposited Plan 192704; thence southwesterly to and along that boundary to its western corner; thence southwesterly to the northern corner of Lot 53 as shown on Plan 7804; thence southwesterly along the northernmost northwestern boundary of that lot and onwards to the centreline of Robinson Avenue; thence southeasterly along that centreline to the prolongation northeasterly of the centreline of Elizabeth Street; thence southwesterly to and along that centreline to the centreline of Belmont Avenue; thence northwesterly along that centreline to the prolongation northeasterly of the centreline of the southwestern section of Sydenham Street; thence southwesterly to and along that centreline and onwards to a northeastern side of Orrong Road, a point on a present southwestern boundary of the district of Belmont and thence generally northwesterly, generally southeasterly, generally northeasterly, again generally northwesterly and again generally northeasterly along boundaries of that district to the starting point.

2. Commencement

3. Terms used

commencement day means the day on which the rest of the order comes into operation under clause 2(b);

continuing councillor means a councillor on the council of the City of Swan whose term of office as councillor continues beyond next election day;

district means the district of Swan;

next election means the first ordinary election for the City of Swan held after commencement day;

next election day means the day fixed for the holding of the poll for the next election.

4. Abolition of existing wards (s. 2.2(1)(d) of the Act)

All of the wards in the district are abolished immediately before next election day.

5. Division into new wards (s. 2.2(1)(a) of the Act)

- (1) On and from next election day, the district is divided into the following wards —
 - (a) the Altone Ward;
 - (b) the Ballajura Ward;

 - (d) the Midland/Guildford Ward;
 - (e) the North Ward;
 - (f) the Swan Valley/Gidgegannup Ward.

- (7) The Swan Valley/Gidgegannup Ward consists of the land described in Schedule 6.

along western and southwestern boundaries of Lot 127 to the northern boundary of Lot 27 as shown on Diagram 46680; thence westerly and southerly along the northern and western boundaries of that lot to the northwestern corner of Lot 6 as shown on Plan 2235; thence southerly along the western boundary of that lot and onwards to the northwestern corner of Lot 10821 (Reserve 39580) as shown on Deposited Plan 29559; thence southerly and easterly along the western and southern boundaries of that lot to the northwestern corner of the northern severance of Lot 5 as shown on Diagram 48370; thence southerly along the western boundary of that severance and onwards to the northwestern corner of the southern severance of that lot; thence southerly along the western boundary of that severance and onwards to the northeastern corner of Lot 56 as shown on Plan 2746; thence southerly along the eastern boundary of that lot and onwards to the centreline of Reid Highway (dedicated and undedicated); thence generally westerly and generally northwesterly along that centreline to the prolongation northeasterly of an eastern side of the proposed Lord Street Extension as shown on Department of Planning Plan 1.1227/1; thence southwesterly to and generally southwesterly along sides of that proposed extension and generally southwesterly along eastern sides of Lord Street to the southwestern corner of Lot 11966 (Part Reserve 43131) as shown on Deposited Plan 218524, a point on a present southern boundary of the City of Swan and thence generally westerly, generally northerly and westerly along boundaries of that City to the starting point.

Plan 7216 sheets 1 and 2 to the southeastern corner of Lot 5199 as shown on Deposited Plan 161576, a point on a present western boundary of the City of Swan and thence westerly, southerly, again westerly, generally southerly and easterly along boundaries of that City to the starting point.

Areas Closed to Fishing for Prawns

Notice No. 2 of 2013

I, Stuart Smith, Chief Executive Officer of the Department of Fisheries, in accordance with clause 17 of the *Kimberley Prawn Managed Fishery Management Plan 1993* (the Plan) and being of the opinion that the prohibition is required in the better interests of the Kimberley Prawn Managed Fishery (the Fishery), do hereby—

1. Cancel *Notice No. 1 of 2013*, dated 21 March 2013;
2. Prohibit fishing for prawns in those parts of the Fishery between the times and dates provided for in items (a) to (c) below—
 - (a) Fishing for prawns is prohibited in all of the waters of the Fishery from the date of the gazettal of *Notice No. 2 of 2013*, until 0600 hours WST on 1 August 2013;

To prevent bush fires and to minimise the spread of a bush fire, all owners and occupiers of land within the City's district are required to comply with the requirements of this Annual Fire Hazard Reduction Notice.

1. OWNERS AND OCCUPIERS OF LAND ZONED 'GENERAL RURAL' OR 'SPECIAL RURAL'
