The Western Australian Planning Commission (WAPC) proposes to amend the Greater Bunbury Region Scheme (GBRS) by introducing a new zone—Industrial Deferred and is seeking public comment.

The purpose of this amendment is to give statutory effect in the GBRS to the resolution of the Western Australian Planning Commission to introduce a new “Industrial Deferred” zone in order to facilitate future industrial development in the Greater Bunbury area. At the same time the WAPC has resolved to amend the zoning of lots in the City of Bunbury and the Shire of Dardanup. The land affected directly by this amendment are lots 2,9,10,11,12,43 and part lots 3 and 43 Boyanup-Picton Road and lots 8,102,103,4208 Harris Road, lots 11 and 38 South Western Highway and lots 1, 110 and 603 Martin-Pelusey Road, portion of Taverner Road and public road, Picton East.
