**FISH RESOURCES MANAGEMENT ACT 1994**  
**PROHIBITION ON FISHING FOR ROCK LOBSTER ORDER 2013**  
Order No. 5 of 2013

FD 1830/13 [1164]

Made by the Minister under section 43.

**1. Citation**This order may be cited as the *Prohibition on Fishing for Rock Lobster Order 2013*.**2. Orders revoked**The *Prohibition on Recreational Fishing for Rock Lobster (West Coast) Order 2006* and the *Prohibition on Fishing for Rock Lobster Order 2010* are hereby revoked.**3. Interpretation**

In this order—

**rock lobster** means the fish of that common name described by the scientific classification opposite that name in Column 2 of Schedule 7 to the *Fish Resources Management Regulations 1995*.

**4. Application of order**

This order does not apply to a person fishing for rock lobster in accordance with a managed fishery licence granted under—

- (a) the *Esperance Rock Lobster Management Plan 1987*;
- (b) the *West Coast Rock Lobster Managed Fishery Management Plan 2012*; or
- (c) the *Windy Harbour-Augusta Rock Lobster Management Plan 1987*.

**5. Prohibition on fishing for rock lobster at certain times**

(1) Subject to subclause (2), a person must not fish for rock lobster by any means—

- (a) in the waters specified in Schedule 1 during the period commencing on 1 July and ending on 14 October in any year;
- (b) in the waters specified in Schedule 2 during the period commencing on 1 July in any year and ending on 14 March in any year; or
- (c) in the waters specified in Schedule 3 during the period commencing on 1 July in any year and ending on 14 November in any year.

(2) Despite subclause (1), the holder of a recreational fishing licence that authorises fishing for rock lobster may—

- (a) set a baited rock lobster pot in the waters specified in Schedule 1 on 14 October in any year; or
- (b) set a baited rock lobster pot in the waters specified in Schedule 3 on 14 November in any year.

(3) A person must not pull a rock lobster pot or fish for rock lobster by diving—

- (a) at any time before 4.30 a.m. or after 7.30 p.m. on any day during the period 15 October of any year to 31 March of the following year; or
- (b) at any time before 6.00 a.m. or after 6.00 p.m. on any day during the period 1 April in any year to 30 June of the same year,

in the waters described in Schedule 4.

**Schedule 1**

All WA waters south of 21° 44' south latitude but excluding all waters off the southern coast of WA east of 115° 30' east longitude.

**Schedule 2**

The waters of the Abrolhos Islands area bounded by a line commencing at the intersection of 27° 30' south latitude and 112° 50' east longitude and extending in an easterly direction to the intersection of 27° 30' south latitude and 113° 37' east longitude; thence south easterly to the intersection of 28° 45' south latitude and 114° 9' 52.18" east longitude; thence south easterly to the intersection of 29° 30' south latitude and 114° 30' east longitude; thence west to 112° 50' east longitude; thence north to the starting point.

**Schedule 3**

All WA waters off the southern coast of WA east of 115° 30' east longitude.

**Schedule 4**

All waters of the Indian Ocean between 21° 44' south latitude and 34° 24' south latitude but excluding all waters off the southern coast of WA east of 115° 08.091' east longitude.

**BUSH FIRES ACT 1954***City of Kwinana***FIRE BREAK NOTICE 2013-2014**

To all owners and/or occupiers of land in the City of Kwinana.

Pursuant to the powers contained in Section 33 of the *Bush Fires Act 1954* you are hereby required to comply with the requirements set out in this notice.

The works outlined in the following as applicable must be completed before the 1st December 2013 and works maintained up to and including the 31st March 2014.

**1. Area—3001m<sup>2</sup> or greater**

You are required to—

- Construct bare earth fire breaks 3 metres wide inside and along all boundaries of land in a continuous form, including on boundaries adjacent to roads, rail and drain reserves and all public open space reserves, with all overhanging branches, trees, limbs etc to be trimmed back from over the fire break area, to a minimum height of 4 metres.
- Remove all flammable matter except living trees, shrubs, plants under cultivation and lawns, 3 metres wide and minimum height of 4 metres immediately surrounding all buildings situated on the land;
- Fire breaks 3 metres in width and minimum height of 4 metres are to be cleared immediately surrounding any place where wood or timber piles, hay stacks, tyres, vehicles, flammable liquids, chemicals and gas products are kept on the land.

Maintained and living lawns are acceptable in conjunction with or in lieu of mineral earth fire breaks, provided that the same minimum width and height requirements for a fire break are maintained.

**2. Area—3000m<sup>2</sup> or less**

You are required to—

- Have all flammable material such as long dry grass, weeds, etc slashed, mown or trimmed down by other means to a height no greater than 50mm across the entire property.

Bare earth fire breaks are not necessary on property that are 3000m<sup>2</sup> or less in areas where slashing, mowing or living and maintained garden beds or lawn is established.

**3. Additional Works**

In addition to the requirements regardless of land size and location, Council or its duly authorised officer may require additional works on your property in order to improve access or to improve overall fire prevention measures across the City. Where the land area is 10ha or greater in size, additional fire breaks as determined appropriate for suitable fire control may be required.

It is recommended that where possible, a 20 metre low ground fuel zone is established around your home. Advice on how to achieve this correctly is available from the City of Kwinana during office hours.

**4. Fire Break Variations**

All previously approved fire break variations will be automatically cancelled from 1st July 2013. The City of Kwinana will make contact with previously approved applicants in the 2012-13 season to assess individual needs for the 2013-14 fire season.

All Fire break variation applications must be approved by 1st November 2013 to avoid your property being deemed non-compliant during the fire break inspection period.

Fire break variations are considered only where owners or occupiers of land believe they cannot physically construct a fire break due to environmental and physical restrictions. If you think you may need a fire break variation then please contact the City of Kwinana on 9439 0200 for further information.

**5. Fire Management Plans**

All subdivisions and/ or developments within the City of Kwinana must comply with the Fire Management Plans for their estates to the satisfaction of Council or its duly authorised officer.

**BUSH FIRES ACT 1954***City of Stirling***FIRE BREAK NOTICE**

All land owners and occupiers are required to install fire breaks by 30 November 2013 or within 14 days of becoming the owner or occupier of the land.

This is necessary to—

- help prevent the spread of fire
- allow easy access for emergency
- provide a break from which back burning can take place

The fire break must be maintained up to and including 31 March 2014 and must be—

- clear of all combustible materials
- minimum width of three metres immediately inside all external boundaries of the land
- minimum width of three metres surrounding all buildings on the land

Rangers will conduct fire break inspections from 1 December 2013. Where a fire break is not installed by this date, an on-the-spot fine of \$250.00 will be issued to the owner, and the City will organise for a contractor to install the fire break and recover the costs from the owner.

Backyard burning and the use of incinerators are prohibited within the City of Stirling at all times.

If the owner or occupier believes it is impractical to clear a fire break they must apply in writing to the City of Stirling before Friday 8 November 2013.

## BUSH FIRES ACT 1954

*City of Bunbury*

### FIRE BREAK NOTICE

Pursuant to the powers contained in Section 33 of the *Bush Fires Act 1954*, it is hereby notified that owner/occupiers of land within the District of the City of Bunbury are required to carry out fire prevention work in accordance with the provisions of this notice. This work must be carried out no later than 30 November 2013 and kept maintained throughout the summer months until 10 May 2014. The penalty for non-compliance with this notice is a modified penalty of \$250 and a maximum penalty of \$5000, and notwithstanding prosecution, Council may enter upon the land and carry out the required works at the land owners/occupiers expense.

#### REQUIREMENTS

##### 1. Rural and Townsite Land (includes residential, commercial and industrial)

- (a) Where the area of land is 2024m<sup>2</sup> (approximately 1/2 acre) or less, remove all flammable material on the land except living standing trees, from the whole of the land; or
- (b) Where the area of land exceeds 2024m<sup>2</sup> provide fire breaks (free of all flammable material) at least 3 metres wide, immediately inside all external boundaries of the land and also immediately surrounding all buildings and haystacks situated on the land. Where several adjoining lots are held or used by the owner/occupier, the fire breaks may be provided inside and along the external boundaries of the group of lots.

##### 2. Rural Land

The owners of all rural holdings zoned as Rural under Town Planning Schemes must maintain clear of all flammable materials, a fire break not less than three (3) metres wide immediately inside all external boundaries of the land.

##### 3. Fuel and Gas Depots

In respect of land owned and/or occupied by you on which is situated any container normally used to contain liquid or gas fuel, including the land on which any ramp or supports are constructed, you shall have the land clear of all flammable material.

##### 4. Plantations

Boundary Fire breaks—

On the horizontal plane a fire break shall be provided 15 metres wide and immediately adjoining all external boundaries of the planted area. The outer 10 metres will be cleared of all flammable material while the inner 5 metres, i.e. that portion closest to trees may be kept in a reduced fuel state, i.e. by slashing or grazing grass provided that the height of the grass does not exceed 8cm.

On the vertical plane a clear space 4 metres high will be maintained above the outer 10 metres of the fire break.

Internal Fire breaks—

Plantations shall be subdivided into areas not exceeding 30 hectares by fire breaks 6 metres wide, which shall be cleared of all flammable material. In the vertical plane a clearance of a minimum height of 4 metres from the ground level will be maintained above the fire break.

##### 5. Burning Permits, Burning of Bush, Grass and Garden Refuse

Burning of anything including bush, grass and garden refuse is totally prohibited from 30th December 2013 to 28th March 2014 (inclusive).

Permits to burn are required for any burning including garden refuse at any time between 15 November 2013 and 29 December 2013 (inclusive) and between 29 March 2014 and 10 May 2014 (inclusive).

Permits to burn will only be issued to land owners/occupiers for hazard reduction burning until 30 November 2013 (inclusive). From 1 December 2013 to 29 December 2013 (inclusive), permits to

burn will not be issued to land owner/occupiers for hazard reduction burning. From 1 December 2013 to 29 December 2013 (inclusive) permits to burn will only be issued to fire brigades established in accordance with the *Fire Brigades Act 1942* or the *Bush Fires Act 1954* and for any other burning as approved by the Councils Chief Bush Fire Control Officer.

#### 6. Campfires

Campfires are totally banned within the whole of the District of the City of Bunbury from 15 November 2013 until 10 May 2014 (inclusive).

#### 7. Prohibited and Restricted Burning periods

Prohibited Burning Period: The 'prohibited burning' period that applies within the District of the City of Bunbury is 30 December 2013 to 28 March 2014 (inclusive).

Restricted Burning Period: The 'restricted burning' periods that apply within the District of the City of Bunbury are 15 November 2013 to 29 December 2013 (inclusive) and 29 March 2014 to 10 May 2014 (inclusive). These dates may be subject to variation according to seasonal conditions, but any changes will be advertised in a newspaper circulating the Bunbury District.

If it is considered for any reason to be impractical to clear fire breaks as required by this notice or if natural features render fire-breaks unnecessary, you may apply to the Council or its duly authorised officer not later than 15 November 2013 for permission to provide fire breaks in alternative positions or to take alternative action to abate fire hazards on the land. If permission is not granted by the Council or its duly authorised officer, the requirements of this notice shall be complied with. If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the *Bush Fires Act*.

### BUSH FIRES ACT 1954

*Town of Victoria Park*

#### FIRE BREAK NOTICE 2013/2014

Notice to all Owners and/or Occupiers of Land within the Town of Victoria Park.

Pursuant to the powers conferred in Section 33 of the *Bush Fires Act 1954*, you are required on or before the 31st October 2013, or within fourteen days of the date you become the owner or occupier should this be after the 31st day of October 2013 and thereafter up to and including the 30th day of April 2014, to clear inflammable matter, on land owned and/or occupied by you in accordance with the following requirements—

1. All land which is 2000 m<sup>2</sup> or less in area;
  - Remove inflammable matter from the whole of the land, except living trees and shrubs; plants under cultivation and lawn, by means of ploughing, cultivating or slashing to a height of no more than 50mm.
2. All other land within the Town of Victoria Park—
  - (i) Fire breaks of a minimum width and height of 3 metres are to be cleared immediately inside all external boundaries of the land;
  - (ii) Fire breaks to a minimum width of 3 metres and height of 3 metres are to be cleared immediately surrounding all buildings situated on the land; and any place where inflammable liquids and gas products are kept;

In addition to the requirements in this notice Council may, by notice in writing require an owner and/or occupier to act as and when specified in the notice with respect to anything which is upon land and which in the opinion of Council is or is likely to be conducive to the outbreak of a bush fire or the spread or extension of a bush fire.

The term "Inflammable Matter" for the purpose of this notice includes bush (as defined in the *Bush Fires Act 1954*), timber, boxes, cartons, paper, rubbish and any other combustible or inflammable matter, but does not include buildings, green standing trees and bushes or growing bushes or plants in gardens or lawns.

All fire breaks must be cleared on or before 31 October in any year and thereafter maintained clear of inflammable matter up to and including 30 April in the following year.

If for any reason an owner and/or occupier considers it impractical to clear fire breaks or comply with other fire protection measures in accordance with the notice, the owner and/or occupier may apply in writing to Council no later than 31 October in any year for a variation. If permission is not granted in writing by Council or its authorised officer, the owner and/or occupier must comply with the requirements of this notice. Any variation granted by Council will apply only for a single Fire break period. A variation granted by Council shall only remain in force until 30 April in the following year.

The penalty for failing to comply with this notice is a fine of not more than \$5,000.00 and a person in default is also liable whether prosecuted or not, to pay the cost of performing the work directed in this notice if it is not carried out by the owner or occupier by the date required by this notice.
