FISH RESOURCES MANAGEMENT ACT 1994

NORTHERN DEMERSAL SCALEFISH FISHERY MANAGEMENT PLAN AMENDMENT 2013 FD 1394/13 [1154]

Made by the Minister under section 54.

1. Citation

This instrument is the Northern Demersal Scalefish Fishery Management Plan Amendment 2013.

2. Management plan amended

The amendments in this instrument are to the Northern Demersal Scalefish Fishery Management Plan 2000.

Delete "Executive Director" in each instance where it appears in this Plan and insert— CEO

4. Clause 3 amended

- (a) Delete the definition of "Committee".
- (b) Delete the definition of "day" and insert-
 - "day", for the purposes of a calculation made in accordance with Schedule 7, means a period of 24 hours, or part thereof if the final day is not a complete period of 24 hours, commencing from—
 - (a) for the purposes of a calculation made in accordance with item 1, 2 or 3 of Schedule 7, when the boat enters Area 2 of the Fishery and ending when the boat leaves Area 2 of the Fishery; or
 - (b) for the purposes of a calculation made in accordance with item 4, 5, 6, 7, 8 or 9 of Schedule 7, when a nomination of intention to commence fishing is made under clause 25B and ending when a nomination to cease fishing is made under clause 25C;
- (c) Delete the definition of "KGBMF licence".
- (d) Delete the definition of "nomination to fish" and insert—
 - "nomination" means a nomination sent to the Department, by means of an approved ALC, in accordance with this Plan;
- (e) After the definition of "nomination" insert—
 "port area" means an area described in Schedule 12;

4. For the purposes of section 65 of the Act, the licence holders are the persons that are to be consulted before this Plan is amended or revoked.

6A. Area 2 of the Fishery is divided into the 3 zones described in Schedule 2A.

14. (1) A person must not sell, purchase, or deal in, or attempt to sell, purchase or deal in, any demersal scalefish taken from the Fishery in contravention of this Plan.

(2) A person must not sell, purchase, or deal in, or attempt to sell, purchase or deal in, any demersal scalefish taken from the Fishery unless the demersal scalefish were taken by the holder of a commercial fishing licence operating under the authority of a licence issued in accordance with this Plan.

13. Clause 15 amended

 - (1) For the purposes of this clause, a fish trap—
 - (a) is a "dumped trap" when it has been left in the waters of the Fishery and the holder of the relevant licence or a person acting on that person's behalf has—

 - (b) ceases to be a "dumped trap" when the holder of the relevant licence or a person acting on that person's behalf has made a nomination to commence fishing by fish traps under clause 25B.

- (c) In subclause (10)(a), after "used in", insert a zone of
- (d) Delete subclauses (11) and (12) and insert-
 - (11) Subclause (10) does not apply where the master of an authorised boat has reported lost fish traps to the Compliance Manager at the Broome office of the Department.
 - (12) The master of an authorised boat must not allow a person fishing from that boat to use, set or pull, or carry on board that boat any fish traps or droplines unless those fish traps or droplines have attached a surface float which—
 - (a) has a diameter of not less than 150 millimetres; and
 - (b) is branded or stamped with the initial letter and the licensed fishing boat number for the boat that is being used to fish in the Fishery, and each character of the brand or stamp is legible and measures not less than 60 millimetres high and 10 millimetres wide.
 - (13) The master of an authorised boat must not allow a person fishing from that boat to use, set or pull, or carry on board that boat two or more fish traps attached together in a line unless a surface float that complies with subclause (12)(a) and (b) is attached to each end of the line of fish traps.
 - (14) The master of an authorised boat must not permit fishing by means of a fish trap from that boat unless that fish trap conforms with the specifications set out in Schedule 9.

14. Clause 15A inserted

After clause 15 insert—

Use of gear in zone C of Area 2

- 15A. (1) The CEO may, if the CEO considers it appropriate to do so, permit the use of fishing gear in zone C of Area 2 that would otherwise be prohibited under this Plan, by notice published in the Gazette.
 - (2) A notice made under subclause (1) must-
 - (a) identify the type of fishing gear that is permitted to be used; and
 - (b) specify the period in which the fishing gear is permitted to be used.
 - (3) The CEO may impose conditions on a notice made under subclause (1).

(4) A person fishing in zone C of Area 2 by means of fishing gear permitted under a notice made under subclause (1) must comply with the terms of that notice.
