Liquor Control Act 1988

### **Liquor Control Amendment Regulations (No. 8) 2013**

Made by the Governor in Executive Council.

**1. Citation**

These regulations are the *Liquor Control Amendment Regulations (No. 8) 2013*.

**2. Commencement**

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on the day after that day.

**3. Regulations amended**

These regulations amend the *Liquor Control Regulations 1989*.

**4. Regulation 8 amended**

Delete regulation 8(1)(c) and insert:

- (c) the sale or supply of liquor together with flowers, a food parcel or a gift hamper, to be delivered by the vendor or supplier as a gift, where —
  - (i) the gift is delivered no earlier than 7 a.m. and no later than 7 p.m.; and
  - (ii) the person to whom the gift is delivered has reached 18 years of age and is not the vendor, supplier or purchaser; and
  - (iii) the quantity of liquor sold or supplied does not exceed 2 L; and
  - (iv) the liquor was purchased by the vendor or supplier from the holder of a hotel licence or a liquor store licence; and
  - (v) the value of the liquor and its container is not more than half of the purchase price of the gift; and
  - (vi) the business of the vendor or supplier is genuinely marketed as a service for the sale and delivery of gifts; and
  - (vii) the gift is packaged so that a person to whom it is delivered would be likely to know that it was intended to be a gift;

#### CONSERVATION AND LAND MANAGEMENT ACT 1984

#### APPROVAL OF THE FOREST MANAGEMENT PLAN 2014-2023

1. Notice is hereby given that the Hon Albert Jacob MLA, Minister for Environment, has approved the Forest Management Plan 2014-2023.

2. The Forest Management Plan 2014-2023 was prepared in accordance with Part V of the *Conservation and Land Management Act 1984* (the Act). The plan is a management plan for land vested in the Conservation Commission of Western Australia that is located in the Swan, South West and Warren Regions of the Department of Parks and Wildlife, and the lands collectively known as 'Redmond forest block' in the Department's South Coast Region.

3. The Forest Management Plan 2014-2023 specifies the following combination of purposes for which all areas of indigenous State forest and timber reserves in those regions, other than any areas identified in Appendix 1 of the plan and shown on Map 2, which are proposed to be reclassified as national park, conservation park, nature reserve or forest conservation area, are reserved—

- (a) conservation;
- (b) recreation;
- (c) timber production on a sustained yield basis;
- (d) water catchment protection; and
- (e) other purposes being prescribed by the regulations.

4. The Forest Management Plan 2014-2023 specifies the following combinations of purposes for which any areas of indigenous State forest and timber reserves identified in Appendix 1 of the plan and shown on Map 2 of the plan, and which are proposed to be reclassified under section 62 of the Act as a forest conservation area, are reserved—

- (a) conservation;
- (b) recreation;
- (c) public firewood collection on a case by case basis;
- (d) water catchment protection; and
- (e) other purposes being prescribed by the regulations.

5. The Minister made no modifications, under section 60(2) of the Act, to the Proposed Forest Management Plan 2014-2023 as submitted to him by the Conservation Commission of Western Australia.

- (d) on each public holiday or public half-holiday from and after 10.00am until 6.00pm.

(3) Despite subclause (1) and subclause (2), this order does not authorise general retail shops referred to in those subclauses to be open on—

- (a) Good Friday; or
- (b) ANZAC Day; or
- (c) Christmas Day.
