#### STANDING ORDERS AMENDMENT LOCAL LAW 2014

Under the powers of the *Local Government Act 1995* and by all other powers, the Council of the City of Nedlands resolved on 25 March 2014 to make the following local law.

#### 1. Citation

This local law may be cited as the City of Nedlands Standing Orders Amendment Local Law 2014.





# ELECTRICITY ACT 1945 ELECTRICITY REGULATIONS 1947

CODE OF PRACTICE FOR PERSONNEL ELECTRICAL SAFETY FOR VEGETATION CONTROL WORK NEAR LIVE POWERLINES

It is hereby notified for public information that for the purposes of subparagraph (i) of regulation 316A(4)(b) of the *Electricity Regulations 1947* the following amendments have been made to the *Code of Practice for Personnel Electrical Safety for Vegetation Control Work Near Live Powerlines* published in July 2012.

#### **AMENDMENTS**

- 1. Clause 3.1: insert at the appropriate location in the list of definitions—
  - **'Running Earth'** means a conductor at earth, or close to earth, potential running with and operating as, an integral part of the HV system.
- 2. Clause 6.1: last sentence of first paragraph replace "the same as applied to phase conductors" with "300mm. Work practices, equipment and operator competence will be consistent with requirements for the HV system."
- 3. Clause 6.5.3: table 4, column 5, line 3 replace "Physical clearance" with "No clearance".
- 4. Clause 6.5.4: table 5, columns 4 and 5 replace "Physical clearance" with "No clearance".
- 5. Clause 8.3.2: 2nd paragraph, 2nd dot point replace "HLTCPR201A" with "HLTAID002" and delete "(1 year refresher)".
- 6. Clause 8.3.2: 3rd paragraph, 8th dot point replace "HLTFA301B—Senior First Aid (3 year refresher)" with "HLTFA311A—Apply First Aid".
- 7. Clause 8.3.2: 3rd paragraph, 9th dot point replace "RIIOSH302A" with "RIIOSH302D"
- 8. Clause 8.3.2: 3rd paragraph, 10th dot point replace "RIIOSH205A" with "RIIOSH205D".
- 9. Clause 8.3.3: 1st paragraph, 3rd dot point replace "HLTFA301B—Senior First Aid (3 year refresher)" with "HLTFA311A—Apply First Aid".

The Authority gives notice, consistent with the *Botanic Gardens and Parks Authority Act 1998*, of the release of the Kings Park and Botanic Garden Draft Management Plan 2014-2019 for the statutory two month public submission period.

Kings Park and Botanic Garden is an inner-metropolitan park overlooking the city of Perth, covering just over 400 hectares and comprised of the Western Australian Botanic Garden, landscaped parkland, and remnant banksia woodland. It was officially created as an A-class reserve in 1900, and today is the most visited destination in Western Australia, welcoming nearly six million people each year. The park provides a haven for biodiversity and is a popular place for picnics, recreation, cultural and ceremonial events. The park is also a significant scientific institution and a renowned centre for research, education and conservation.
