CITY OF GOSNELLS AMENDMENT LOCAL LAW 2014

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the Council of the City of Gosnells resolved on 8 April 2014 to make the following local law.

2009**PART 1—PRELIMINARY****1.1 Title**

This local law may be cited as the *City of Gosnells Amendment Local Law 2014*.

1.2 Commencement

This local law comes into operation 14 days after the date of its publication in the *Government Gazette*.

1.3 Purpose and effect

(1) The purpose of this local law is to amend the *City of Gosnells Parking Local Law 2012*, the *City of Gosnells Thoroughfares and Public Places Local Law 2012*, the *City of Gosnells Property Local Law 2009* and the *City of Gosnells Animals, Environment and Nuisance Local Law 2009*.

(2) The effect of this local law is to clarify clauses within the City's existing local laws.

PART 2—CITY OF GOSNELLS PARKING LOCAL LAW 2012**2.1 *City of Gosnells Parking Local Law 2012* amended**

This part of the local law amends the *City of Gosnells Parking Local Law 2012*.

2.2 Clause 1.4 amended

Clause 1.4 is amended as follows—

- (1) After the definition of "bicycle", insert "**built-up area** has the meaning given to it by the Code;"

- (2) Delete

length of carriageway means the same side of the road between intersections on that side of the road;"

and replace with

length of carriageway means the section of carriageway between two intersections or the section of carriageway between a cul-de-sac and an intersection;"

- (3) After the definition of "trailer", insert "**truck** has the meaning given to it by the Code;"

2.3 Clause 3.3 amended

Clause 3.3(1)(a) is amended as follows—

After the words "on a" insert "length of"; and

After the words "2 hours" insert "in any 24 hour period".

2.4 Clause 3.4 inserted

At the end of Part 3—Stopping and Parking Generally insert a new clause 3.4 as follows—

3.4 Parking on a Thoroughfare

- (1) A person shall not stop or park a vehicle on a thoroughfare for a period exceeding 24 hours.

- (2) Clause (1) does not apply where the vehicle is stopped or parked on a verge by a person who is the owner or occupier of the premises abutting the section of the verge on which the vehicle is parked, or is a person authorised by the occupier of those premises to stop or park the vehicle on that part of the verge.

2.5 Sub-clause 5.1(1)(b) amended

Sub-clause 5.1(1)(b) is amended as follows—

After the words “commercial vehicle” insert “, truck”.

2.6 Clause 5.8 amended

Clause 5.8 is amended as follows—

After the words “trailer or caravan is on” insert the words “or over”.

2.7 Sub-clause 6.1(2) amended

Sub-clause 6.1(2) is amended as follows—

- (1) At the end of sub-clause 6.1(2)(h), delete “.” and replace it with “;”.
- (2) Insert a new sub-clause (i) which reads—
 - (i) in front of a path, in a position that obstructs access by vehicles or pedestrians to or from that path unless—
 - (ii) the driver is dropping off, or picking up, passengers; or
 - (iii) the driver stops in a parking stall and the driver is permitted to stop in the parking stall under this local law.

2.8 Schedule 1—Prescribed Offences amended

Schedule 1 is amended as follows—

Insert a row into the table immediately under the row commencing with “3.3” in the column headed “Clause” with that row to include the following text—

3.4	Stopping or parking on a thoroughfare for a period exceeding 24 hours	100

PART 3—CITY OF GOSNELLS THOROUGHFARES AND PUBLIC PLACES LOCAL LAW 2012

3.1 *City of Gosnells Thoroughfares and Public Places Local Law 2012* amended

This part of the local law amends the *City of Gosnells Thoroughfares and Public Places Local Law 2012*.

3.2 Clause 2.6 amended

Clause 2.6 is amended as follows—

- (a) After the word “woodchips;” delete “and”.
- (b) After the word “lawn;” insert new parts (c) and (d) which read—
 - “(c) brick paving; and
 - (d) compacted limestone.”

3.3 Clause 4.2 amended

Clause 4.2 is amended as follows—

- (1) In sub-clause (2), after the word “shall”, delete the word “not”.
- (2) In sub-clause (2)(a), delete the words “allow the animal to enter or remain” and replace with the words—

“prevent the animal from entering or remaining”
- (3) In sub-clause (2)(b)—
 - (i) delete the word “allow” and replace it with the word “prevent”; and
 - (ii) delete the words “to be” and replace them with the words “from being”.
- (4) In subclause (2)(c), prior to the word “train” insert the word “not”.

PART 4—CITY OF GOSNELLS ANIMALS, ENVIRONMENT AND NUISANCE LOCAL LAW 2009

4.1 *City of Gosnells Animals, Environment and Nuisance Local Law 2009* amended

This part of the local law amends the *City of Gosnells Animals, Environment and Nuisance Local Law 2009*.

4.2 Clause 17(1) amended

Clause 17(1) is amended as follows—

- (1) In sub-clause 17(1)(e) delete “.” and replace with “;”.

(2) After subclause 17(1)(e) insert—

- (f) ensure that the portion of the premises on which the animal is kept is fenced or walled in a manner capable of confining the animal and, having regard to the species, age, size and condition of the animal, capable of preventing the animal at all times from passing over, under or through it.

4.3 Schedule 3 amended

Schedule 3 is amended as follows—

In the column headed “Clause” of the table of prescribed offences in Schedule 3, after the text “17(1)(a), (b), (c), (d), (e)” insert “, (f)”.

PART 5—CITY OF GOSNELLS LOCAL GOVERNMENT PROPERTY LOCAL LAW 2009

5.1 *City of Gosnells Local Government Property Local Law 2009* amended

This part of the local law amends the *City of Gosnells Property Local Law 2009*.

5.2 Schedule 2 amended

Schedule 2 is amended as follows—

In clause 1.10 after the words “A person shall not play at or practice golf on any local government property except”, delete the words “where a permit specifies a particular local government property” and replace with—

“on local government property specifically set aside for that purpose.”

Criminal Investigation (Identifying People) Act 2002

Criminal Investigation (Identifying People) Amendment Regulations 2014

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Criminal Investigation (Identifying People) Amendment Regulations 2014*.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette* (*gazettal day*);

- (b) regulation 4 — when the *Criminal Investigation (Identifying People) Amendment Act 2013* section 28 comes into operation;
- (c) the rest of the regulations — on the day after gazettal day.

3. Regulations amended

These regulations amend the *Criminal Investigation (Identifying People) Regulations 2002*.

4. Regulation 5B inserted

After regulation 5A insert:

5B. DNA database indexes (s. 76)

- (1) In this regulation —

commencement day means the day on which the *Criminal Investigation (Identifying People) Amendment Act 2013* section 28 comes into operation;

crime scene index means an index of DNA profiles derived from material obtained from —

- (a) a place (whether within or outside Australia) where an offence was, or is reasonably suspected to have been, committed; or
- (b) a place (whether within or outside Australia) where evidence associated with, relevant to, or of assistance in investigating, an offence was situated; or
- (c) on or in the body of a person who was involved when an offence was committed, whether as a suspect for, or as a victim of, or as a witness to, the offence; or
- (d) on or in anything worn or carried by a person referred to in paragraph (c) at the time of the offence; or
- (e) anything in respect of which an offence was committed or that was used in committing, or in connection with committing, an offence,

together with information about when and where the material was obtained, but does not include the DNA profile of a person reasonably suspected to have committed the offence, if the profile was obtained from that person;

former section 76 means section 76 of the Act as in effect immediately before commencement day;

missing persons index means an index of DNA profiles derived from material that relates to, or that may relate to, a missing person, together with

information about when and where the material was obtained;

offence means —

- (a) an offence under the law of this State, another State, a Territory or the Commonwealth; or
- (b) an offence under the law of a jurisdiction outside Australia the elements of which, if they had occurred in Australia, would have constituted an offence referred to in paragraph (a);

offenders index means an index of the DNA profiles obtained —

- (a) under Part 6 or 7 of the Act from suspects, if the profiles were, immediately before commencement day, lawfully in the offenders index (as defined in former section 76); or
- (b) under Part 8A of the Act, or the former Schedule 1 clause 6 (as defined in section 68A(1) of the Act), from serious offenders; or
- (c) under the corresponding law of a participating jurisdiction from people who have been convicted of an offence under the law of that jurisdiction,

together with the personal details of the people whose profiles they are;

suspects index means an index of the DNA profiles obtained —

- (a) under Part 6 or 7 of the Act from suspects; or
- (b) under the former Schedule 1 clause 6 (as defined in section 68A(1) of the Act) from remand prisoners; or
- (c) under the corresponding law of a participating jurisdiction from people who are suspected of having committed an offence under the law of that jurisdiction,

together with the personal details of the people whose profiles they are;

unknown deceased persons index means an index of the DNA profiles derived —

- (a) from material obtained from deceased people whose personal details are unknown; or
- (b) from material that relates, or may relate, to deceased people whose personal details are unknown,

together with information about when and where the material was obtained;

volunteers (limited purposes) index means an index of the DNA profiles obtained —

- (a) under Part 4 Division 2 of the Act from volunteers; or
- (b) under Part 5 of the Act from victims and witnesses; or
- (c) under the corresponding law of a participating jurisdiction from people similar to those referred to in paragraphs (a) and (b); or
- (d) under Part 4 Division 3 of the Act, or under the corresponding law of a participating jurisdiction, from deceased people,

in respect of which there are limits as to the forensic purposes for which they may be used, together with the personal details of the people whose DNA profiles they are;

volunteers (unlimited purposes) index means an index of the DNA profiles obtained —

- (a) under Part 4 Division 2 of the Act from volunteers; or
- (b) under Part 5 of the Act from victims and witnesses; or
- (c) under the corresponding law of a participating jurisdiction from people similar to those referred to in paragraphs (a) and (b); or
- (d) under Part 4 Division 3 of the Act, or under the corresponding law of a participating jurisdiction, from deceased people,

in respect of which there are no limits as to the forensic purposes for which they may be used, together with the personal details of the people whose DNA profiles they are.

- (2) For the purposes of paragraph (c) of the definition of ***DNA database*** in section 76 of the Act, the following indexes are prescribed —
 - (a) a crime scene index;
 - (b) a missing persons index;
 - (c) an offenders index;
 - (d) a suspects index;
 - (e) an unknown deceased persons index;
 - (f) a volunteers (limited purposes) index;
 - (g) a volunteers (unlimited purposes) index.
